At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

The Commission reorganized for 2011. Ova made a motion seconded by Marks to nominate Klose for Chairman. Motion carried.

Schwartz made a motion seconded by Marks to nominate Ova for Vice-Chairman. Marks made a motion to cast a unanimous ballot for Ova. Motion carried.

Ova made a motion seconded by Neys to approve the minutes of the December 2010 meetings. Motion carried.

No action was taken on the bids for the ADA restroom remodeling project. The bids needed further clarification.

Chad Kaiser, County Sheriff, requested that he be placed on the pay plan at grade 17 step 6. By policy, the Commission had given up to two extra steps on the pay plan for experience. Ova made a motion seconded by Schwartz to place Kaiser on the salary schedule at grade 17, step 3. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye.

Kaiser requested lighting and cage equipment for the new Sheriff's vehicle at a cost of \$6,769.59. This equipment would make the vehicle road ready to travel to emergencies. Kaiser stated that he would be using his current vehicle and that the new deputy would be assigned to the new GMC pickup. He considers it a safety issue and that it was essential equipment. Kaiser said that he was waiting for a \$2,500 grant from the City of Jamestown that would be used to purchase lighting for the 2010 Expedition. Ova made a motion seconded by Schwartz to authorize the purchase of the equipment. Roll call vote – Marks, Schwartz, Neys, Klose and Ova voted aye.

Mike Zimmerman, County Highway Superintendent, gave his monthly report. They were busy plowing snow. There were areas where the snow banks needed to be pushed back away from the road to prevent constant blocking. The consensus was to hire Guthmiller Construction – they had an excavator that could reach out from the road.

Zimmerman requested permission to get gravel crushing and motor grader bids and to purchase a used trailer. These items were all in his 2011 budget. Marks made a motion seconded by Neys to solicit motor grader bids. Motion carried.

Ova made a motion seconded by Schwartz to solicit gravel crushing bids. Motion carried.

Schwartz made a motion seconded by Marks to authorize the purchase of a used trailer for \$27,000. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye.

Zimmerman indicated that the road department manual would be updated. Equipment costs and graveling costs would have to be increased. Commissioner Klose commented that the fees should reflect all costs including depreciation. The County should at least break even on rates compared to all costs.

Fritz Fremgen, State's Attorney, gave his monthly report. The Assistant State's Attorney vacancy in his office had been filled. Ashley Heitkamp had accepted the position. Ova made a motion seconded by

Schwartz to place Heitkamp on the pay scale at grade 15, step 3. Roll call vote – Neys, Klose, Ova, Marks and Schwartz voted aye.

Fremgen reported that his office was using a case management system that was outdated and the software was no longer supported by the State. He was reviewing similar software to replace the outdated system. ND DOT required Title VI compliance or the County could not do work on any projects involving Federal funds. He would assist with developing county policies for Title VI compliance.

Mark Dooley, General Manager, Gavilon Fertilizer, LLC, requested that the Commission make a decision on whether or not they would close the railroad crossing adjacent to their facility in Midway Township. Future expansion plans would be affected by closing or not closing the crossing. Troy Schrader, Area Manager for Gavilon Fertilizer, LLC, commented that the crossing was a safety concern and the decision on whether or not to close the crossing could affect Gavilon's decision to expand at this location. Commissioner Ova commented that there was a township road with a railroad crossing on the section line one mile west of the facility so farmers and local traffic would still have a way around the plant. A public input meeting would be advertised and scheduled. Letters would be sent to the township officers and area residents about the public meeting. The railroad and ND DOT would be contacted about their publication requirements for closing the crossing and closing the road at the crossing.

Noel Johnson, County COO, presented an agreement to provide computer hardware support to LaMoure County for \$1,400 per month. The one year contract could be canceled by either party with 30 day notice. The contract would allow for additional compensation for the County's IT support technician, and it would provide revenue to pursue additional help for the County's IT Department. Johnson recommended a two step raise for IT tech Josh Smagge and an additional \$450 per month. The additional monthly pay would cease if there was no longer a support contract with LaMoure County. Marks made a motion seconded by Neys to approve the contract and extra compensation. Roll call vote – Klose, Ova, Marks, Schwartz and Neys voted aye.

A motion was made by Neys seconded by Schwartz to approve the following 2010 fund transfers: Transfer from Fund 10 - \$107,504.46 to Fund 23 - \$105,000.00, to Fund 40 - \$2,000.00 and to Fund 35 - \$504.46; from Fund 11 to Fund 53 - \$60,000.00; from Fund 14 - \$124,600.00 to Fund 23 - \$114,600.00 and to Fund 10 - \$10,000.00; from Fund 15 to Fund 10 - \$7,500.00; from Fund 10 - \$100,000.00; from Fund 10 - \$175,000.00; from Fund 10

Schwartz made a motion seconded by Marks to authorize the following 2011 automatic transfers and bills to be paid upon demand. Motion carried.
