January 6, 2009

At 4:00 p.m., Chairman Klose called the regular monthly meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call.

A motion to approve the minutes of the December, 2008 meetings was made by Neys and seconded by Kaiser. Motion carried.

The Commission reorganized for 2009. Noel Johnson, County COO, requested nominations for Chairman. Kaiser made a motion that was seconded by Ova to nominate Mark Klose for Chairman. Motion carried.

Klose chaired the remainder of the meeting.

Klose asked for nominations for Vice-Chairman. A motion was made by Kaiser and seconded by Marks to nominate Dennis Ova for Vice-Chairman. Motion carried.

All Commissioners consented to the same committee appointments as 2008.

The hearing was held pursuant to NDCC 24-07-03 on a request to close the Section line between Sections 22 and 27 in Spiritwood Township (T140N-R62W) with the exception of the portion of the section line lying adjacent to the south side of the Spiritwood Cemetery. Clarence Daniel, President of the Spiritwood Township Board of Supervisors indicated that the Township Board had a meeting and went on record not opposing the closing. Paul Solomonson, Great River Energy, indicated that his company had requested the closing because a proposed railroad spur would cross the section line. Nels Albin, Secretary of the Spiritwood Cemetery Association, and the other members of their board that were present indicated their association was not opposed provided the road adjacent to the cemetery was not closed so they continued to have access to their property. The Commission received no opposition to the closing and all parties were in agreement. A motion was made by Ova and seconded by Neys to close the section line except that portion lying south of and adjacent to the Spiritwood Cemetery. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Fritz Fremgen, State's Attorney, gave his monthly report. A meeting was scheduled for a committee to work on the agreement for joint library services between Stutsman County and the City of Jamestown. Work continued on the wind turbine zoning ordinance.

Mike Zimmerman, County Highway Superintendent, and Commissioners Kaiser and Marks had reviewed the bids for the front-end loader and the backhoe that were taken under advisement at the last commission meeting. Their recommendation was to accept the low bid of Titan Machinery for the new equipment and to accept the high bid of RDO Equipment for the sale of the County's used equipment. Zimmerman recommended reducing the low bid by the amount of the performance bond. The bond would not be necessary as there were buy back guarantees and the County planned on owning the equipment for more than five years. A motion was made by Kaiser and seconded by Marks to accept the low bid less the performance bond of Titan Equipment for a net cost of \$249,605 for a 2009 Case 821E front end loader and for a 2009 Case 580SM backhoe and to accept the high bid of \$39,375 for the County's 1986 Cat 980C wheel loader. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

Zimmerman requested out-of-state travel for three department employees for Case Equipment tour in Tomahawk, Wisconsin. The travel would be at no expense to the County. A motion was made by Kaiser and seconded by Marks to allow the out-of-state travel. Motion carried.

Zimmerman reported that ND DOT had notified the County of potential federal stimulus funds that could amount to \$452,000. Plans were to use the funds for chip sealing. A meeting would be held January 28th with ND DOT and the cities and townships along old Highway #10 to address right of way issues.

Ova made a motion that was seconded by Kaiser to advertise for bids for electrical parts and labor and for plumbing parts and labor. Motion carried.

A motion was made by Kaiser and seconded by Neys to approve the following 2009 automatic transfers and 2009 payments on demand.

Ova made a motion that was seconded by Neys to approve the beer license application of Jamestown Country Club. Motion carried.
