Official Proceedings of the Stutsman County Commission

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Craig Neys, and Mark T. Klose answered roll call. Doug Kaiser was absent.

Neys made a motion seconded by Ova to approve the raffle/poker permit gaming application of the El Zagal Shrine Clowns at the Jamestown Masonic Lodge. Motion carried.

A motion was made by Ova seconded by Marks to approve \$157.50 in taxable meals. Roll call vote – Ova, Marks, Neys and Klose voted aye.

Jim Boyd, President of JSDC Board of Directors, requested funds for a Flex PACE Interest Buy down for Custom Contracting Solutions, LLC. The JSDC Board had recommended approval of \$16,000 on an 80/20 City/County split. The funds would be repaid once the underlying loan with the Bank of North Dakota was repaid. Tom Schultz, Partner/Owner of Custom Contracting Solutions, LLC, indicated that his company concentrated on bidding fencing for state highway projects. There were no local competing fencing companies. They also had plans to get into general contracting. Marks made a motion seconded by Neys to approve \$3,200 in County funds. Roll call vote – Marks, Neys, Klose and Ova voted aye.

Jan Thompson, County Treasurer, presented the list of depository banks and pledge of securities. Ova made a motion seconded by Marks to approve the following depository banks. Motion carried. Depository Banks for 2010 and 2011: Bank of North Dakota, Bismarck; Bank Forward, Jamestown; Dakota Heritage Bank, Streeter; First Community Credit Union, Jamestown; Gate City Bank, Jamestown; Northland Financial Bank, Medina; Northland Financial Bank, Steele; Unison Bank, Jamestown; U S Bank, Jamestown; and Wells Fargo Bank NA, Jamestown.

A motion was made by Neys seconded by Marks to approve the following pledge of securities. The institutions, total deposits, and securities pledged are as follows: Bank Forward, \$2,100,000.00, \$2,570,000.00; First Community Credit Union, \$2,250,000.00, \$2,529,000.00; Gate City, \$225,500.00, \$250,000.00; Northland Financial, \$140,000.00, \$250,000.00; Unison Bank, \$2,608,268.57, \$3,044,765.65; U S Bank, \$207,869.61, \$2,008,015.88; Wells Fargo Bank NA, \$5,206,491.73, \$13,000,861.30. Motion carried.

Steve Thompson, Interstate Engineering, reviewed the status of the bridge on the valley road south of Ypsilanti. Because of the condition of the bridge, it qualified for 80/20 replacement funds. A project concept report was necessary to analyze possible rehabilitation, replacement and/or other alternatives. Tentative plans were to budget the project in 2011. Klose questioned the status on the bridge that is out near Sydney. Zimmerman reported that there is an improved project letter ready to forward to FEMA to look at placing culverts and rip rap versus replacing the bridge. Marks made a motion seconded by Ova to enter into a \$32,000 contract with Interstate Engineering to develop a project concept report for the bridge. Roll call vote – Neys, Klose, Ova and Marks voted aye.

Mike Zimmerman, County Highway Superintendent, presented a map that identified 119 miles of the County's paved roads that would be a priority to maintain as pavement. The identified roads were a starting point. Plans could change depending on future developments. Federal funds were decreasing while costs were increasing. Decisions on recycling roads would depend on conditions and costs for maintenance. The main priority was providing safe roads.

Zimmerman requested permission to request front wheel assist in the bid specs for a new motor grader.

Chris Wingire expressed concerns about the roads north of Woodworth that were used as access to the local elevator and used to go to Carrington for health care. Wingire requested that problems areas be signed better. Additional money was needed and an effort should be made to inform the public of the need for additional funds. Laurie Carlson stated that the public would be willing to provide additional funding if the County had the right plan for spending the funds. Commissioner Klose pointed out that rebuilding the County's road system was a \$50 million problem.

Darrell Roorda stated the County needed to identify its priorities, where do you want the funds spent. If the road system was the main priority, then the County's focus should be directed towards that priority. JSDC funds should be used for road projects. Recycled roads would require additional maintenance and there was already a lack of maintenance on area roads. Laurie Carlson questioned the plan to not prioritize old Highway 10 from Cavendish to Spiritwood as it had some of the heaviest traffic. She suggested trying to get something on the ballot again to get additional funding.

Commissioner Marks indicated that he had approached the City with a proposal for a 1% sales tax issue on the ballot to share for infrastructure, but the City would not endorse the idea.

Commissioner Ova suggested that a small portion of any sales tax issue could be shared with the townships. The townships had no money and they were having difficulty paying for their road damages. Roorda voiced his concerns over the County serving as a bank for the townships. The townships should raise their taxes and not rely on the County. Klose indicated that the county had several recent proposals on the ballot to raise road revenue and all had failed. An initiated measure by County residents for additional tax money was an option. Carlson stated that there were plans for a citizens' group meeting.

Zimmerman recommended using the next round of federal stimulus funds (\$400,000) for chip sealing 11.5 miles south of Cleveland. Marks made a motion seconded by Ova to approve chip sealing County Highway 67PB. Motion carried.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, reported that the \$1.00 telephone surcharge for funding 9-1-1 emergency services would have to be on one of the 2010 election ballots. Every twelve years the issue had to be on the ballot. Ova made a motion seconded by Neys to place the issue on the 2010 primary election ballot. Motion carried.

Bergquist indicated that there would be no Presidential Disaster Declaration for the County's \$102,000 snow removal costs for the Christmas 2009 blizzard. Statewide snow removal costs failed to meet the \$1 million threshold for a statewide disaster declaration.

Noel Johnson, County COO, gave a preliminary 2009 year-end financial report. Most of the County's major funds had a break-even year with revenues equaling expenditures. Social Services and County Highway Aid were revenue positive. The additional highway funds were reserves for the 2011 road repair projects. All funds fell within reasonable deviations from budget expectations.

Marks made a motion seconded by Neys to approve the mid-month bills. Roll call vote – Klose, Ova, Marks and Neys voted aye.
