Official Proceedings of the Stutsman County Commission - January 22nd, 2013

At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Jim Fettig, Courthouse Maintenance Supervisor, requested permission to advertise for courthouse roof replacement bids. The project is estimated to cost approximately \$80,000.00. The roof is in the budget. Neys made a motion, seconded by Schwartz to approve advertising for courthouse roof replacement bids as presented. Motion Carried.

Dustin Bakken, Interim Tax Director, updated the commissioners on the agricultural land values. The ag land values are certified to the county by the State Tax Department. The formula has not changed. In 2012 the value per acre was \$472.75. In 2013, the value per acre will be \$551.01, which is an increase of 16.5 percent across the board on all ag land. The agricultural land values will approximately increase 155% over the next five years.

Dustin presented information to the commissioners and to Ron Cumber on the mobile home tax increase. Actual sales of four double wide and four single wide mobile homes were used to arrive at the value of the mobile home, as well as the square footage and the depreciation. There was a clerical error in the calculations. New tax statements will be sent out to the owners of 1993 and older double wide mobile homes.

Ron Cumber spoke regarding the value of his property in Plainview Township. He pays taxes on the buildings on the farmstead as well as the property. His concern is why he should have to pay taxes on the buildings when other property owners don't. This is determined by the amount of off the farm income that is generated.

Bids were opened for providing plumbing labor and plumbing parts. Bids were as follows: Bob's Plumbing and Heating, Inc. - \$65.00/hour with materials at cost plus ten percent. Bids were opened for providing electrical labor and electrical parts. Bids were as follows: Jamestown Electric - \$39.00/hour with material at cost plus five percent, and Curtis Electric, LTD - \$40.00/hour with material at cost plus ten percent. Ova made a motion, seconded by Schwartz to accept the bids of Bob's Plumbing and Heating, Inc., Curtis Electric, LTD, and Jamestown Electric, with Jamestown Electric as a primary and Curtis Electric as a secondary. Roll Call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Chad Kaiser, Stutsman County Sheriff, informed the board regarding the increase in the civil process fees, base rate mileage fees, the concealed weapons permit fees, and copy fees. The increase in fees will be effective February 1st, 2013. The Sheriff's Department will not charge for the fingerprinting service.

Casey Bradley, Auditor/COO, presented the 2012 year-end report to the commissioners. The fund balance at December 31, 2012 is as follows: General Fund \$2,466,807.00; County Social Security \$507,100.00; Restorative Justice Fund \$6,377.00; Emergency Phone System \$230,556.00; Road & Bridge \$594,645.00; Unorganized Township Roads \$55,250.00; Social Services \$1,346,154.00; City County Health \$1,719.00; Airport Authority \$195.00; County Park \$209,720.00; Emergency Fund \$72,661.00; County Correctional Center \$ -357,082.00; Weed

Bradley, Auditor/COO, requested approval to increase the cell phone per diem from \$20.00 to \$50.00 per month for Josh Smaage, IT Director. Josh uses a considerable amount of cell phone minutes on his personal cell phone for county purposes. Schwartz made a motion, seconded by Ova to approve the request as presented. Motion Carried.

Renee Valenta, Interim Treasurer, presented the Designation of Depositories and Pledge of Securities as follows: (institution, total deposits, and securities pledged) Bank Forward, \$746,507.26, \$873,997.84; First Community Credit Union, \$2,425,500.00, \$2,801,378.00; Gate City Bank, \$0.00, \$0.00; Northland Financial, \$546,049.57, \$240,000.00; Unison Bank, \$2,129,276.25, \$2,738,231.84; US Bank, \$550,000.00, \$600,884.39; Wells Fargo Bank, N.A. \$16,571,847.88, \$27,739,929.83. Neys made a motion, seconded by Marks to accept the Pledge of Securities and the Designation of Depositories. Roll Call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Renee requested approval to purchase a folder and inserter mail machine. The machine is reconditioned and would cost \$3,845.00 and a \$595 yearly service agreement. Ova made a motion, seconded by Marks to approve the request as presented. Motion Carried.

Wendy Thompson, County Wellness Committee, presented information on the Stutsman County Wellness Program with a request to approve the on-going comprehensive wellness program and wellness hours. Stutsman County receives a one percent premium reduction with Blue Cross Blue Shield for having this program in place and we have requirements to meet for the 1% premium reduction. Marks made a motion, seconded by Schwartz to approve the comprehensive wellness hours for the Stutsman County Wellness Program. Motion Carried.

Tracey Trapp, Jail Administrator, informed the commissioners that Becky Pretzer, Administrative Assistant, resigned from her position. Tracey requested to fill the vacancy internally first. Ova made a motion, seconded by Neys to approve to fill the administrative Assistant position internally as requested. Motion Carried.

Neys made a motion, seconded by Ova to approve the one year extension request for carryover of 124 vacation leave hours above the year cap of 240 hours for Jerry Bergquist. Motion Carried.

Fritz Fremgen, State's Attorney, updated the board that Kate Naumann has been hired for the Assistant State's Attorney position. She will start February 4, 2013.

Marks made a motion, seconded by Ova to approve the project concept report for the grade raise, widening, mill and overlay project SC-4745(060) which is east of Spiritwood. It is the

connecting road between Highway 62 north and Highway 62 South. It is not an ER project and will approximately cost \$442,103.10. Motion Carried.

The South Central Dakota Regional Council requested the county to reconsider its vote to provide support for three months. They requested the county to fully fund the Regional Council for all of the 2013 fiscal year and sign the joint powers agreement with the quarterly reviews for progress. It is the consensus of the county commissioners to table this request until the February 5th, 2013 commission meeting.

Ova made a motion, seconded by Marks to approve the taxable meals and mid-month bills. Roll Call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.
