

Official Proceedings of the Stutsman County Commission – February 3rd, 2015

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order with all members present.

Neys made a motion, seconded by Schwartz to approve the January 2015 minutes. Motion carried.

Marks made a motion, seconded by Ova to award the plumbing bid to Bob's Plumbing & Heating at \$75/hour with 10% profit and the electrical bid to Jamestown Electric at \$39/hour with 10% profit. Motion Carried.

James Fettig, Maintenance Supervisor, received a bid for a contract with Trane Company to take care of issues that Bob's Plumbing & Heating cannot perform specialty work on. The quote is for \$950/year to go through the Courthouse, \$950/year for the LEC and \$750/year at Social Services. The service contract would lower labor to \$100/hour and they would not charge mileage but charge a \$50 service charge for every call. They would check components for efficiency, check the cooling towers, and roof top units as well. Currently the Vet's club roof top unit is having issues that Trane could fix under the service contract. Motion made by Ova, seconded by Schwartz to enter into a contract with Trane Co. Roll call vote: Ova, Marks, Schwartz, Neys and Klose. Motion Carried.

Wendy Thompson, Wellness Program representative, requesting approval to continue in participating in the Wellness committee to save on health insurance premiums. Program encourages employees to participate in healthy lifestyle choices which other incentives. Currently out of 180 employees 80 participated in the flu clinic. Schwartz made a motion, seconded by Neys to continue participating in the Wellness Committee. Motion Carried.

Casey Bradley, Auditor/COO, presented the commission with the Open Budget Software which is now live on the Stutsman County Website. Currently there are a few issues that are in the process of being fixed. The website gives transparency to the different departments' budgets, breaks each budget down to different categories. There will be reports available to show how many people are viewing and/or using the new available information online.

Connie Ova, Executive Director of the Jamestown Stutsman Development Corp, stated that Holly Miller, Chris Rathjen, and Ramone Gumke here to represent the committee. The land is being sold at a lower rate but the committee receives negative feedback with the process of the transaction being a public decision. The committee believes it would be easier to allow them to sell the land and get development moving faster. The county's share would be 3%. Gumke states that the conveniences and restrictions would stay with the lots no matter who would purchase the lots. Concerns about who will be responsible to uphold the ordinances and enforce/address any issues once the JSDC deeds over the land to the City of Jamestown. Bradley questions if the executive committee could hold an executive session and let the committee decide if the sale meets all of the requirements. Marks made a motion, seconded by Schwartz to deny a Quit Claim deed from the JSDC to the City of Jamestown. Motion Carried.

Mark Klose stated the JSDC discussed to pursue and leave an option needed as necessary. The request is for a ten year loan for \$500,000 at a rate of 10% per year, around .65% rates, and with assurance of profits with the option to use economic development funds if there aren't other available funds. Holly Miller, the motion to request the loan passed through the JSDC board unanimously. Schwartz states that the rail loop cost has gone down \$200,000 with the question if the county contributes shouldn't the county be able to reduce the amount with the total cost going down. Schwartz made a motion to approve the loan request to assist with the rail switch at \$400,000 with subject to meeting all of the terms, seconded by Marks. Roll call vote: Marks, Schwartz, Klose, Ova all vote aye and Neys voted nay. Motion Carried.

Mickey Nenow, County Highway Superintendent, presented his monthly report. The road department did send out advertisements for the Woodworth and Montpelier shops for bid.

Nenow presented the commission with a map of roads they are looking at raising the speed limit to 55mph. Marks made a motion, seconded by Schwartz to approve raising the speed limit on the paved roads marked on the map, after load restrictions are lifted in the spring. Motion Carried.

Nenow, found a 2009 side dump truck for a price of \$32,500 with new paint and tires with plenty

of tread left on them. Commission decided to wait until spring to explore more options. Nenow requested to buy gravel from Lindbergh's pit that is right next to the county's pit on the Trautman land with royalties going to Harold Trautman. Schwartz made a motion, seconded by Ova to approve the purchase of gravel pending Interstate Engineering's measurements. Roll call vote: Marks, Schwartz, Neys Klose, and Ova, voted aye.

Fritz Fremgen, State's Attorney, presented his monthly report. Fremgen presented the commission with figures from the State Court system showing an increase in felony cases. Mental Health cases are on the rise costing more time for the lawyers involved and also the law enforcement as well.

Chad Kaiser, Stutsman County Sheriff, presented his monthly report stating he received vehicle bids; Wilhelm's submitted an unsealed bid at \$30,924 for a 2015 ½ ton GMC with a trade in of \$22,000 leaving a difference of \$8,924. Kaiser will be getting rid of a ¾ ton truck to the County Road Department but he does not want to replace it with a ¾ ton. Bid for a 2015 Ford F150 at \$32,352 with trade-in at \$21,500 for the GMC for a difference of \$10,852. The truck purchase is in the budget and the trade-in needs to happen as soon as possible. Ova made a motion, seconded by Schwartz to accept the GMC bid from Wilhelm's. Roll call vote: Neys, Klose, Ova, Marks, and Schwartz vote aye. Motion Carried.

Casey Bradley, Auditor/COO, presented the commission with a letter of retirement from Warren Tobin, Veteran Service Officer who has set a date of July 31st, 2015. Bradley would like to start the hiring process around April to allow some transition time with Tobin still in the office. There will be a two week training for Veteran Service Officers and also become certified by an organization.

David Schwartz, Commissioner, and Howard Peuser, LEC Maintenance Supervisor, raised concerns for the need of more staff or contract out the cleaning. Bradley stated there will be a meeting this coming Thursday with Extension to decide the maintenance and cleaning issues. Peuser states the lack of help has caused a back-log on jobs needing to be finished. Peuser foresees more jobs will be contracted out in order to catch up on the projects waiting to be finished.

At 5:45 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

Jeff Douty, Pelican Point Concessionaire, is continuing to research internet bookings for the campground through an online camping registration program. Sandy Eckelberg, Accounts/Property Coordinator, states further information sent to Bureau of Reclamation to determine if the campground would qualify to use the internet services. Bradley questions what the benefit would be to using an online website other than taking the credit card transactions. Douty states it would save them time from having to chase around phone calls and it will help save time with all of the information available online including availability and pictures of each camping site. It takes 4-6 weeks to get a new campground online depending on how fast they get the information for the entire site. Recreation.gov does have a fee for the user for around \$9-\$10 fee at the end of the reservation transaction. Douty also questions the construction that is supposed to be finished by June 1st, 2015 or not to interfere with the business at Pelican Point Landing. Bradley suggests reaching out to Border States to touch base on where the project is headed and get an idea of a time frame.

Dennis Lorenz, Park Superintendent, gave his monthly report. Lorenz got the backhoe and came under budget. The 1986 Ford truck has a weakened motor and has been checking with Dakota

Engine builders for a replacement motor. Klose questions why keep sticking money into an older truck or getting quotes from other businesses.

At 6:29p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Houge, seconded by Schwartz. Motion Carried.

At 6:30p.m., the Stutsman County Commission Meeting reconvened.

Marks made a motion, seconded by Ova, to approve the monthly bills for payment but remove the payment for the side dump. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye. Motion carried.
