

Official Proceedings of the Stutsman County Commission

February 5, 2008

At 4:00 p.m. the regular monthly meeting of the Stutsman County Commission was called to order by Chairman Klose. Roll call was answered by Douglas Kaiser, Craig Neys, Dennis Ova, Dale Marks, and Mark T. Klose.

A motion to approve the minutes of the January meetings was made by Neys and seconded by Kaiser. Motion carried.

Jim Fettig, Courthouse/Memorial Building Maintenance Supervisor, requested approval of a \$1,750 change order for the Vet's Club restroom project at the Memorial Building to enlarge the urinal in the men's bathroom. Kaiser made a motion that was seconded by Marks to approve the change order. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Fritz Fremgen, State's Attorney, gave his monthly report. He reviewed the annual statistics for his office. Misdemeanors were at record highs; felonies were down from prior years; mental health cases were about the same as last year; NSF checks have not been the problem they were years ago.

Ova made a motion that was seconded by Marks to nominate David Smette to the Buffalo City Tourism Foundation Board. Motion carried.

Chairman Klose kept the Commission committee appointments the same as last year.

Commissioner Marks reviewed the revised long range road plan. \$21 million in road projects the next five years would be paid for with a 1% County-wide sales tax and a 35 mill levy increase on agricultural land. Old Highway #10 east of Jamestown would be paved after recycling. 72,000 pound load limits would be considered for that road. State Representative Craig Headland complimented the plan, but questioned the County's authority to raise the levy on only one class of property. He proposed a 13 mill increase on all classes of property. He stated that ag dynamics have improved so the farmers may be willing to pay more for roads.

Laurie Carlson agreed with Mr. Headland that the tax should not be on ag land only. The Commission should rescind property tax exemptions that have been granted; the tax levy should include commercial property. It is not only farmers using the roads - there are as many or more commercial truckers using the roads.

Judy Graves commended the Commission for driving the roads. She indicated that it was important to examine history and to clarify the vision. Money should be sought from the Legislature. The County should not be separated into city and rural. Weight limits were needed. The Commission should look at industrial and commercial property not just ag land. Commercial haulers were part of the problem, and there should be no tax exemptions.

When questioned about federal aid money, the Commission responded that they were trying not to use federal aid money for most projects. Costs for engineering, mitigation, cultural resources and other federal regulations substantially increased project costs. Public input meetings would be scheduled.

Nellie and Bill Degen presented a written request that they be notified of the time, date and place of any meetings regarding Bureau of Reclamation land where their home is located. In addition, they were requesting receipt of any e-mails or faxes pertaining to this issue as well.

At 5:08 p.m. the Commission meeting was recessed for the Park Board meeting.

Stutsman County Park Board Meeting

February 5, 2008

At 5:12 p.m. the Stutsman County Park Board meeting was called to order by Chairman Klose. Roll call was answered by Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys, Mark Klose, and Mark Schlecht. Bob Woodward was absent.

Schlecht made a motion that was seconded by Ova to approve the minutes of the December 4, 2007 meeting.

Jack Uehran requested the Board's assistance in a disagreement he was having with Spiritwood Lake City regarding location of campers adjacent to the lake. The City Attorney had sent him an eviction

notice as this use was a violation of the City Zoning Ordinance. Mr. Uehran indicated that the campers were there prior to the zoning ordinance so he was appealing the eviction. Shirley Krapp, City Auditor, commented that the City was trying to clean things up and the campers were located in a commercially zoned area. The Park Board had no jurisdiction over City zoning so they advised Mr. Uehran to take the matter up with Spiritwood Lake City.

Dennis Lorenz, County Park Superintendent, reported that the ND Game & Fish Department would fund a floating fishing pier at Parkhurst, north of the boat ramp, provided the Park Board would fund disability access to the pier. The estimated cost of \$25,000 plus, for the access, exceeded the cost of the pier. An application has been made to ND Game & Fish for a fishing pier at Spiritwood Lake City. The Dakota Anglers have committed funds to assist with the cost of both of these projects.

Neys made a motion that was seconded by Schlecht to approve the transfer of Lot 14, West Side at the Jamestown Reservoir from Dan Wilhelm to Deb Wilhelm. Motion carried.

Mr. Lorenz reported that the grant funding application for a new concessionaire building at Pelican Point Landing had been denied. A motion was made by Ova and seconded by Kaiser to accept the gift of a used Ford backhoe from the Bureau of Reclamation. Motion carried.

The campground committee was recommending approval of changes to policies for the Marina and Pelican Point Campgrounds. Ova made a motion that was seconded by Neys to approve the policy changes. Motion carried. Changes include Interagency Senior Pass & Interagency Access Pass acceptance, sleeping cabins rental guidelines, camping rates, and operation of vehicles.

A motion to adjourn the Park Board meeting was made by Neys and seconded by Schlecht. At 5:44 p.m. the February 5, 2008 Park Board meeting was adjourned.

At 5:45 p.m. the Stutsman County Commission meeting was called back to order with all members present.

Kaiser made a motion that was seconded by Marks to pay the monthly bills. Roll call vote – Marks, Kaiser, Neys, Klose, and Ova voted aye.
