Official Proceedings of the Stutsman County Commission - February 5th, 2013

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Schwartz made a motion, seconded by Ova to approve the minutes of the January 2013 meetings. Motion carried.

Jim Fettig, Courthouse Maintenance Supervisor, updated the commissioners about the maintenance work that was completed. A hot water heater went out in the courthouse building. A commercial hot water heater would approximately cost \$5,000-\$6,000. The only things that use hot water in the courthouse building are the bathrooms, the coffee pot, and just a few other things. The county purchased a bigger hot water heater with a circulating pump in the amount of \$2,263.00. At the Memorial Building, the unit is already five-six years old and has been having little leaks. Jim has tried getting companies to come in to do chemical work to keep the water lines free from corrosion inhibitors. Jim was unable to get a company to do the work because they wanted to use the same type of chemical that was already in the lines. Jim called Agassiz Chemical to do the work. They charged approximately \$125.00/hour. The total bill was about \$700.00. Neither project was in the budget.

Dustin Bakken, Interim Tax Director, presented omitted assessments for parcel numbers 09-3033033, 23-0941010, 30-1311010, 62-0134040, 62-3333030, and 51-0620000. Dustin informed the commissioners that all property owners have been notified that there was an error in generating the tax statements and have been given the opportunity for an appeal of the added values. There have been no objections to these omitted assessments. Neys made a motion, seconded by Schwartz to approve the omitted assessments as presented. Roll call vote: Marks, Ova, Schwartz, Neys, Klose voted aye.

Alden Kollman, Buffalo City Tourism, requested the commissioners write a letter of support on Senate Bill No. 2203. The bill was introduced with its first reading on January 16, 2013. After the first reading, the bill was referred to the Finance and Taxation Committee which met on January 22, 2013. The bill passed out of the Finance and Taxation Committee with a 7-0 in favor of Senate Bill 2203. The bill has moved to the Appropriation Committee which is having a hearing at 9:30 tomorrow. This bill will allow museums more opportunity to access funding by being able to increase the mill levy. Marks made a motion, seconded by Ova to approve writing a letter of support for Senate Bill 2203. Motion Carried.

Lisa Barnick, Jamestown Sun, presented information to the commission board for advertising in the Source Book and the Progress Edition. The Source Book is a list of information of what is happening in Jamestown as well a list of campgrounds, restaurants, and motels. Approximately 20,000 copies will be distributed through the Jamestown Sun, area hotels and motels, gas stations, the airport, the Chamber of Commerce, the Buffalo Museum, and to all North Dakota rest areas. The advertising deadline is Friday, February 8th, 2013. The Source Book advertising failed for a lack of a motion. The Progress Edition advertising deadline is February 22nd, 2013 in order to get the discount. It is the consensus of the board to table the Progress Edition advertising until the next commissioner meeting. It was suggested to contact the concessionaires to see if they would like to advertise in the Progress Edition.

Mickey Nenow, County Highway Superintendent presented his monthly report. Mickey handed out his 2012 year-end report to the commissioners. The road department is continuing doing winter maintenance on the equipment getting it ready for Spring. Mickey requested to advertise for gravel crushing. He is working at getting quotes for oil for chip sealing. Mickey is still working on FEMA paperwork trying to get a few more projects out to bid. Ova made a motion, seconded by Neys to approve the request to advertise for gravel crushing. Motion Carried.

Lutheran Social Services and James River Senior Center is applying for a Community Development Block grant (CDBG) through the South Central Regional Council for the purpose of financial assistance in support of the Legacy Place (Senior Center area). The grant is in the amount of \$40,000.00 for kitchen equipment and \$8,000.00 for dining furnishings for a total of \$48,000.00. Ova made a motion, seconded by Marks to approve a resolution and application for the CDBG grant for Lutheran Social Services and James River Senior Center as requested. Motion Carried.

Fritz Fremgen, State's Attorney presented his monthly report. He introduced Kate Naumann to the commissioners. Fritz stated that not much has happened in the civil environment for him. He has not given any opinions this month otherwise the rest is long-term. Fritz has been working on a few federal lawsuits. Fritz will be contacting Dalsted & Ryan to inform them that the county will be resuming the Mental Health cases effective March 1st, 2013.

Tracey Trapp, LEC Administrator, informed the board about four new part-time hires. They are Gabriel Brown, Janelle Spear, Logan Hord, and Tammy Wampler. Jamie Miller took the Administrative Assistant position and Ariel Kilgore has moved from part-time to full-time status.

Ova made a motion, seconded by Neys to nominate and appoint Charlotte Freeberg to the Joint Library Board. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

The South Central Dakota Regional Council requested Stutsman County to reconsider its vote to provide support for one-quarter of SCDRC's fiscal year 2013 with consideration for additional funding in March. Deb Kantrud was unable to attend the commission meeting due to a training conflict. In her place, Becky Meidinger, Small Business Development Center, spoke to the board. Becky reported that the SCDRC has been meeting with on a regular basis with JSDC. The SCDRC has been attending the city council meetings and county commissioner meetings to have more of a presence and understanding of what the needs are. A growth committee has been established. The SCDRC's Board of Directors and the Growth Committee sent out a survey to leaders in the region to help identify needed resources, needs, or priorities to assist jurisdictions. The SCDRC has been working with JSDC about the workforce meetings and what the issues are and also the regional housing study. Phase one has been completed. What has been found is the state housing assessment is way off even without the anticipation of projected businesses that are coming in. The SCDRC will be co-hosting a Regional Housing Summit February 15th, 2013. The Hazard Mitigation Grants were approved at the state level. Stutsman County is eligible to apply for grant funding for hazard mitigation planning. The County Commissioners spoke of their concerns with the SCDRC such as is this organization being run as efficiently as possible. Schwartz made a motion, seconded by Marks to continue to provide support for the balance of the fiscal year, with that the county would want justification on executive director's salary and who sets that, a review of the executive board and accountability for what is going on, see a listing of the projects that are going on and what is being done, to see if and when a salary review has been completed, and to see some documentation that supports the salaries being paid prior to budgeting time next year. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

At 5:00 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

Houge made a motion, seconded by Neys to approve the minutes of the January 2013 meeting. Motion Carried.

A question was raised regarding the Northern Plains bill. There were two entries made for the same dollar amount. Neys made a motion, seconded by Woodward to approve the monthly bills with checking into the Northern Plains billing. Roll call vote: Marks, Ova, Schwartz, Neys, Klose, Woodward, Houge voted aye.

Blake Bond submitted a proposal requesting permission to break the land and grow crops within the area of the former CRP lands South of Spiritwood Lake in Section 31, T142N-R62W and return the profit back into the Spiritwood Campground. It is the consensus of the board to table the request. A question was raised if they haved the CRP could they use that money as a cost share and put part of that profit back into the campground. That was okay by the park board commissioners.

Schwartz made a motion, seconded by Woodward to approve the 2013 Operation and Maintenance Service Contract as presented. Roll call vote: Houge, Woodward, Klose, Neys, Schwartz, Marks, Ova voted aye.

Dennis Lorenz, Park Superintendent, spoke with the Bureau of Reclamation's engineers regarding Pelican Point Campground. The proposal may be completed by April. Dennis informed the engineer that they will not have enough time to get the project completed. The proposal is broke out into phases. According to the proposal, Pelican Point campground will gain approximately 15 campground spaces. The Bureau of Reclamation provided \$45,000.00 last year in a 50/50 matching grant. The Bureau does have an additional \$40,000.00 in reserve and a possible \$65,000.00 that may be possible for a 50/50 matching grant. It is the consensus of the board to have the park campground committee meet on this item.

At 5:41 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Ova, seconded by Houge. Motion Carried.

At 5:41 p.m., the Stutsman County Commission Meeting reconvened.
