Official Proceedings of the Stutsman County Commission – February 20, 2018

At 4:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Denny Ova, Mark Klose and Craig Neys answered the roll call.

Mickey Nenow, Road Superintendent, presented his monthly report. Some rocking is still being done as well as cutting a few trees and winter maintenance.

There are some leaks on the main shop roof. This was budgeted for in 2018. Nenow would like to go with the 18-year warranty for \$28,072.00. Klose questioned whether the warranty was through the manufacturer or the contractor. Neys made a motion, seconded by Schwartz to approve fixing the roof of the main shop with the stipulation of talking to the contractor about the warranty. Roll call vote: Schwartz, Neys, Klose, Ova and Marks voted aye. Motion carried.

Daniel Schwartz, Mid-America Planning & Consulting, LLC, presented a Professional Services Agreement. This agreement is for the generator grant projects that they have submitted through Stutsman County for FEMA. The contract is based on the grant being awarded to the County. Schwartz made a motion to approve the presented agreement, seconded by Ova. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye. Motion carried.

Jim Fettig, Courthouse Maintenance Supervisor, applied for three courthouse facility grants, one was approved. The grant approved is for security upgrades and was in the amount of \$47,361.60, but \$67,329.89 was Fettig's request. Fettig will verify the dollar amount and requested approval to move forward on the project contingent on the grant award. Schwartz made a motion, seconded by Neys to approve the request contingent on the actual dollar amount awarded for the grant. Roll call vote: Klose, Ova, Marks, Schwartz and Neys voted aye. Motion carried.

The Center of Economic Development building ended up with a loss of \$18,876.12. JSDC budgets for 50%. They were not fully leased in 2017. Connie Ova, JSDC, is requesting \$5,436.32 for the building loss. Schwartz made a motion to approve the request, seconded by Ova. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye. Motion carried.

Corry Shevlin, JSDC, was approached a few months ago by Buffalo City Diesel in regards to purchasing the I-94 lot. It was approved by JSDC and they meet the requirements. Ova made a motion to approve the request, seconded by Neys. Motion carried.

Shevlin requested de-obligation of D & B Portable funds. In 2016 D & B Portable was approved for the flex PACE interest buy-down, but have decided to go in another direction. Neys made a motion, seconded by Ova to de-obligate those funds. Motion carried.

Nicole Meland, Interim Auditor/COO, presented a library appointment for Ilana Xinos. Joe Rector, Library Director, thought she would be a good fit for the board. This is the only application Stutsman County received. Her term will be March 1, 2018, to February 28, 2021. Marks made a motion to appoint Xinos, seconded by Schwartz. Motion carried.

Meland presented an abatement for parcel #11-9991750 (Northern States Power Company). Stutsman County was notified by the North Dakota Office of State Tax Commissioner that they were provided inaccurate tax information regarding Northern States Power Company. This resulted in double taxation of the property. The total tax due for the property was \$81,877.85 and will need to be abated by the County. Meland presented the breakdown for the taxes by district. Schwartz made a motion to approve the presented abatement, seconded by Ova. Motion carried.

An additional budget amendment request was presented. This amendment is due to the close out of Game & Fish Fund. A motion to approve this budget amendment was made by Ova, seconded by Neys. Motion carried.

The Sheriff's Department requested to hire a full-time staff member for courtroom security. Getting a part-time staff will be very difficult to do. Sheriff Kaiser plans to utilize this member in other deputy rolls when not in court. There are some savings right now in the budget, regarding how Stutsman County budgeted for the Auditor position. There is enough to cover an additional staff member. Ova made a motion, seconded by Schwartz to approve the request of hiring a full-time deputy for courtroom security. Motion carried.

Dave Schwartz spoke in regards to the Auditor/COO position. Ova made a motion to offer the position to Nicole Meland, seconded by Neys. Roll call vote: Marks, Schwartz, Neys, Klose and Ova voted aye. Motion carried.

Neys made a motion, seconded by Ova to approve the taxable meals and mid-month bills. Roll call vote: Schwartz, Neys, Klose, Ova and Marks voted aye. Motion carried.
