

Official Proceedings of the Stutsman County Commission – March 1, 2016

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order with all members present.

Schwartz made a motion, seconded by Ova to approve the February 2016 minutes and amend the January 19, 2016 as presented. Motion carried.

David Deutscher, water & drainage issues, final complaints to water resource about tiling, being drained on property that is not the sole owner of the land. The individual, who had the complaint filed against, did not receive any penalty or fines since the Water Resource Board informed Deutscher they cannot levy fines or penalties. State water board determined the complaint is less than 80 acres therefore the complaint was sent back to the Stutsman County Water Resource Board.

Mickey Nenow, County Highway Superintendent presented his monthly report. The crews have been working on maintenance to the equipment, crack sealing on black top, road restrictions will be starting on Monday March 7, 2016 at 7:00 a.m.

Nenow, Medina maintenance building purchase at auction, another coming up on auction March 14th, 2016 that would take additional work to fix up to standards. Schwartz made a motion, seconded by Marks to allow Mickey to bid up to the budgeted amount allowed. Roll call: Ova, Marks, Schwartz, Neys and Klose vote aye. Motion carried.

Nenow received three bids, S & S construction had the low bid of \$64,855.00 for building and floor with the heating and plumbing done separately. Ova made a motion, Neys seconded to award bid to S & S Construction for the Kensal shop. Roll call vote: Marks, Schwartz, Neys, Klose and Ova vote aye. Motion carried.

Fritz Fremgen, State's Attorney, nothing to add to the reports that were submitted to the board but noted that felonies are still on the rise.

Josh Smaage, IT Director, ES&S Poll book purchase request, the e-poll books are used to check in the voters. The current ones are roughly 8 years old; the new system was tested during the School Special election. Trade in allowance at \$25/piece \$27,578 plus \$5,022 for the barcode scanners and cases which is over the budget amount of \$24,000. ES&S would allow the payment split within 2 years at no extra charge or interest. M-100 machines should be replaced after the 2016 election cycle is finished. Software does offer a media package so they can view information on their own rather than relying on staff. Schwartz made a motion to make the purchases split over the two years and buy the additional items at \$5,022.00, seconded by Neys. Roll call vote: Schwartz, Neys, Klose, Ova and Marks vote aye.

Casey Bradley, Auditor/COO, presented the commission with an updated list for the early vote center, importing the data will need more time allowed. Early voting would start Tuesday May 31, 2016 through Friday June 3, 2016 and Monday June 6, 2016 through June 10, 2016 all days running 8am-5pm with no Saturdays. Ova made a motion to approve the times as presented and election workers listed for the early vote center at the Stutsman County Court House, seconded by Marks. Motion carried.

Bradley received a request from Lieutenant Opp, from the Jamestown Police Department, to use the LEC meeting rooms to conduct concealed weapons tests after hours on the weekends. He has access to the

facilities already being a full-time law enforcement officer. Bradley made the recommendation to approve the request. Ova made a motion, seconded by Schwartz to approve the request. Motion carried

Bradley gave the commission the 2015 year end fiscal report, including a summary letter and the end of the year fiscal year report but has not been audited yet.

Bradley informed the commission of an application received for the James River Valley Library Board, Lynn Krueger was the only applicant received, previously served on the Alfred Dickey Library Board 3 years. Marks made a motion, seconded by Ova, all aye, motion carried.

At 4:42 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

Bradley presented the Park Board with a letter from the Bureau of reclamation allowing a three year phase in period for the new cabin rates. Phase in on 2017, 2018 and 2019 but the board needs to decide the amounts they want to phase in each year. Stutsman County will notify the bureau of phase in decision and then send out notification to all cabin owners.

Garrison Diversion Request to release grant funds back in 2012 grant was received for PPL expansion on campground. Last extension has been filed, the county needs to expend the money by April 30, 2016 but cannot spend it on roads. County can refund the money and won't hurt future applications. Schwartz made a motion, seconded by Woodward to return the \$10,000.

Approval of modification #004 for Pelican Point Agreement to extend the period of performance to request to extend the deadline to March 31, 2016 with no cost modification. Neys made a motion, seconded by Schwartz to approve the modification. All aye, motion carried.

Denial of Game & Fish grant for the vault toilet at Parkhurst, grant was denied for funding this year. Game & Fish received numerous applications this year and couldn't approve all of them due to lack of funding. Get a quote to see if a vault toilet could be moved to the Parkhurst location.
