Official Proceedings of the Stutsman County Commission – March 6, 2018

At 4:00 p.m., Chairman Mark Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys and Mark Klose answered the roll call. Dennis Ova was absent.

Neys made a motion to approve the February meeting minutes, seconded by Schwartz. Motion carried.

Jim Fettig, Courthouse Maintenance Supervisor, discussed changes to the courthouse facility grant. We received 50% of the grant this year vs 75% in past years. Fettig was able to reduce the cost of the project so that the County share will be in the 25% range of the project costs. The grant will still reimburse up to 75% if costs are reduced. Fettig also requested \$1,500 in excess funds in case of unplanned expenses. Neys made a motion, seconded by Marks, to approve a total of \$20,709.98 in County funds plus allowing an additional \$1,500 in case of overages. Marks, Schwartz, Neys, and Klose answered aye. Motion carried.

Mickey Nenow, County Highway Superintendent, presented a request to hire a full-time employee since they lost an employee of 34 years. Schwartz made a motion, seconded by Marks, to approve advertising for a full-time employee. Motion carried.

Nicole Meland, Auditor/COO presented the 2017 fiscal report in accordance with North Dakota Century Code 11-11-11(4). These reports are not audited but will be the basis for the 2017 fiscal year audit.

Jerry Bergquist, Emergency Manager/9-1-1 Coordinator, presented the Communications Center Annual Report. In 2017, calls for service from Dispatch increased. The largest users of the dispatch center are Jamestown Police, Stutsman County Sherriff, and Jamestown Ambulance. In total, there were 1,600 more calls in 2017 than 2016. The severe weather warnings were quite a bit lower than 2016. 9-1-1 usage increased by 120 calls from 2016, with 79% being from cell phones.

Josh Smaage, I.T. Director, requested an out of state travel request for a Microsoft conference in Houston, TX. Travel costs will be between \$900-\$1200 with flight and hotel. There is no registration cost. Schwartz made a motion to approve the request, seconded by Neys. Motion carried.

Nicole Meland presented a request from Sam Seafeldt, Director of Jamestown Regional Airport, for a letter of support for Essential Air Service for Jamestown. The contract with Skywest is up and needs to be renewed for another two years. They were the only company to respond, and the airport has been happy with the service and would like to continue. A motion was made by Marks, seconded by Schwartz to sign the letter of support. Motion carried.

At 4:24, the County Commission meeting recessed for the County Park Board meeting.
