At 8:00 a.m., Chairman Klose called the mid month meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

Rena Hoggarth, Jamestown Sun, questioned whether or not the Commission would like to place an ad in the Progress Addition of the Jamestown Sun similar to their ad in prior years. The cost this year would be \$830. Ova made a motion seconded by Neys to purchase the advertisement. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye.

Neys made a motion seconded by Schwartz to approve the raffle permit application of the Jamestown Wrestling Association. Motion carried.

A motion was made by Ova seconded by Schwartz to approve the poker permit application of the James River Humane Society at 281 Stop in Pingree. Motion carried.

Schwartz made a motion seconded by Ova to approve \$215 in taxable meals. Roll call vote – Marks, Schwartz, Neys, Klose and Ova voted aye.

Commissioner Schwartz reviewed the status of the motor grader bids. The bid for one machine was pending. The motor grader in Woodworth also needed to be replaced. The vendor had consented to a \$100,000 buy back on this machine. A decision needed to be made on whether or not to accept a bid for the one machine or to reject the bids and solicit bids for two machines. Marks made a motion seconded by Schwartz to accept the bid from RDO Equipment, Bismarck for a 2011 John Deere 772G motor grader at a net bid of \$174,215 plus \$18,000 for the extended warranty. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye.

A motion was made by Ova seconded by Neys to solicit bids for another motor grader to replace the machine located at Woodworth. Motion carried.

Warren Tobin, Veteran Service Officer, requested Family Medical leave for Rita Morris. A motion was made by Neys seconded by Schwartz to grant the leave request. Motion carried.

Chad Kaiser, County Sheriff, reported on the snow event March 11th and 12th. His department, ND Highway Patrol, ND National Guard, Stutsman County Emergency Services and numerous private citizens assisted over 500 motorists that were stranded on Interstate I-94. About 300 people were taken to Medina and about 200 people were taken to Cleveland. Food and shelter was provided by local residents. Technology played a large part in being able to locate stranded motorists. Dispatch received 123 calls on Friday from midnight to midnight versus an average day being 15. Kaiser stated that the communities of Medina and Cleveland were fantastic. The Commission expressed their appreciation for a job well done.

Sheriff Kaiser expressed concerns over the hiring of a weight enforcement officer without his or other County Sheriffs' involvement. Commissioner Marks indicated that their committee had hired an individual and the program was ready to go. A meeting would be held in Valley City with the County Sheriff's to iron out the details of the overload weight enforcement unit. Public forums would be held to inform the public of plans for the weight enforcement unit.

Jay Hesse, Development Associate for Geronimo Wind, introduced himself and indicated that his company was working in the area and that he would have further contact with Stutsman County Officials.

Mickey Nenow, County Highway Superintendent, stated that spring road restrictions would go into effect on Monday, March 21.

Noel Johnson, County COO, gave the final 2010 financial report. Fund balances for the County's principle funds were projected to be \$8.0 million. Actual ending balances were \$9.4 million. Fund balances for agency and other funds were projected to be \$1.2 million. Actual ending balances were \$1.5 million. The increases over projections were due to under stated revenues and/or 2010 budgeted projects that were not completed and were carried over to 2011.

A motion was made by Ova seconded by Schwartz to approve payment of the mid-month bills. Roll call vote – Neys, Klose, Ova, Marks and Schwartz voted aye.
