Official Proceedings of the Stutsman County Commission – March 15, 2016

At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. All commissioners present.

Jim Boyd, Jamestown Airport Board member, informed the commission that the Jamestown Regional Airport received Airport of the Year recently. Boyd also updated the commission that flight numbers are at a record high and hadn't been since 1978.

Tyler Perleberg, Stutsman County Tax Director, provided the commission with an abatement request he received on behalf of Jock Crane. Parcel number 03-3811012 is a vacant lot located out in Hoggarth's 3<sup>rd</sup> addition. Perleberg made the recommendation to deny the request as the land has 1.6-1.7 usable acres. Ova made a motion, seconded by Schwartz to deny the abatement request. Roll call vote: Ova, Marks, Schwartz, Neys, and Klose all vote aye, motion carried.

Perleberg received an inundated land request on parcel number 03-0710000 from Roy and Mary Werner. The Werner's have filed for the same in the past and it is Perleberg's recommendation to approve the inundated land. Neys made a motion for the approval of inundated land, seconded by Schwartz. All aye, motion carried.

Perleberg stated he has fifty equalization meetings scheduled so far and will be submitting the two week notice to the Jamestown Sun prior to meet the advertising requirements.

losco and Winfield townships have requested to enter into an assessment contract with Stutsman County. Schwartz made a motion to approve of the assessment contracts as presented, seconded by Marks. All aye, motion carried.

Mickey Nenow, Stutsman County Highway Superintendent, requested the commission to award the bid in Medina to S & S Construction as the low bid at \$64,055.00 which is under budget. Schwartz made a motion, seconded by Ova to award the Medina building bid to S & S Construction. Roll call vote: Marks, Schwartz, Neys, Klose, and Ova all vote aye, motion carried.

Nenow stated three bids were received for cold storage and requested the commission award the low bidder. Marks made a motion to award the low bidder S & S Construction, seconded by Neys. Roll call vote: Schwartz, Neys, Klose, Ova, and Marks vote aye, motion carried.

Border States Paving came in as the low bidder for paving projects on county roads 37, 38, 67 and alternates 1 & 2. The estimate was \$1.6 million higher than the bid with the bid at \$3.8 million which includes alternates 1 & 2. Ova made a motion, seconded by Marks to award the bid to Border States Paving. Roll call vote: Neys, Klose, Ova, Marks and Schwartz vote aye, motion carried.

Ten bids were received for gravel crushing but two bids were thrown out because they did not contain a separate envelope which was listed as a requirement. Schwartz made a motion to award the low bid to RTS Shearing at \$3.24, seconded by Marks. Roll call vote: Klose, Ova, Marks, Schwartz and Neys vote aye, motion carried.

Robin Iszler, Central Valley Health Unit Administrator, presented the commission with the annual report. Currently they employ 23 staff members and high for 2015 of receiving Public Health Accreditation

status. Statistics were provided showing the budget and some of the programs that they utilize to benefit county residents.

South Central Dakota Regional Council board and staff brought the membership and dues from Stutsman County to the commission. The Jamestown/Stutsman Development Corporation meeting were given the same information and passed it along to Stutsman County without any recommendations. Commissioners would like to see a meeting between the South Central Dakota Regional Council staff, Casey Bradley, Stutsman County Auditor/COO, and Craig Neys to discuss financial instabilities and try to reach a conclusion between Stutsman County and SCDRC.

Casey Bradley, Auditor/COO, presented the commission with an amended contract with the South Central Human Service Center for safe bed. Schwartz made a motion, seconded by Neys to approve the amendment as presented. All aye, motion carried.

Bradley informed the commission of the Memorandum of Understanding they received from the Truck Regulatory Board. In the agreement each party will receive three scales and money for the dissolution of the board. Motion made by Neys, seconded by Ova to approve the Memorandum of Understanding with the Truck Regulatory Board as presented. Roll call vote: Ova, Marks, Schwartz, Neys and Klose vote aye, motion carried.

Schwartz made a motion to approve the mid-month bills and taxable meals, seconded by Marks. Roll call vote: Marks, Schwartz, Neys, Klose and Ova all vote aye, motion carried.
