

Official Proceedings of the Stutsman County Commission – April 3rd, 2012

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Neys made a motion, seconded by Ova to approve the minutes of the March 2012 meetings. Motion Carried.

Robin Iszler, Central Valley Health District Unit Administrator, Marcia Bollingberg, and Marcie Bata presented her 2011 annual report for the Central Valley Health District. Central Valley Health District continues to provide many programs including but not limited to Immunizations, Title X, MCH Newborn home visits, Public Health State Aid and Tobacco. Central Valley Health was selected by the National Association of County and City Health Officials (NACCHO) to receive grant funding to initiate and complete community health improvement processes; they were one of 12 health departments selected from a total of 127 applications. This funding will help Central Valley Health and the community partners develop a community health assessment and a community health improvement plan which is a prerequisite that every health department must complete prior to applying for accreditation. In our school-based immunizations clinic, we vaccinated over 600 students in Stutsman County. The state will be receiving approximately one million dollars less for the public health emergency preparedness program, however they do plan on keeping the staffing the same for this program. The chronic disease management program is a federal program. It is ending this April and Central Valley Health has applied for another federal grant. They are waiting to hear if they were awarded the grant. The nursing services provide information regarding injury prevention such as education programs, bike rodeo, and health fair and after School programs such as Latch key, lead screening and health assessments as well as a car seat program. In Stutsman County, Central Valley Health has a Title III program which is aging services and it is supported by federal dollars with a local dollar match. In the family planning services, the Central Valley Health has outreach clinics that are located in Valley City and Ellendale. Carrington will be added in 2012.

Steve Thompson, Interstate Engineering, presented resolutions to award Border States Paving Inc. a contract for three paving projects, CER-4717(082), CER 4717(083), and CER-4717(084). The bid opening was held on March 23, 2012 at the Department of Transportation in Bismarck, ND. Two bids were received. Border States Paving's bid is in the amount of \$516,621.35 and Central Specialties' bid is at \$600,000.00. The projects were estimated to cost \$651,442.00. It is Interstate Engineering's recommendation to award the bid to Border States Paving Inc. Marks made a motion, seconded by Schwartz to award Border States Paving Inc. the contract for projects CER-4717(082), CER-4717(083), and CER-4717(084). Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Steve Thompson, Interstate Engineering, informed the board that the Hehn-Schaeffer Lake project and the project south of Cleveland will have a bid opening for building and paving the road in June 2012. The remainder of the projects will have a bid opening in November for 2013 construction.

Renee Valenta, Interim Treasurer, presented the Pledge of Securities as follows: (institution, total deposit, and securities pledged) Bank Forward, \$520,063.94, \$718,707.99; First Community Credit

Union, \$1,625,458.90; \$2,271,000.00; Gate City Bank, \$225,500.00, \$225,500.00; Northland Financial, \$240,000.00, \$240,000.00; Unison Bank, \$3,196,770.11, \$3,901,535.67; US Bank, \$744,923.99, \$844,767.50; Wells Fargo NA, \$17,895,487.84, \$19,548,676.35. Ova made a motion, seconded by Schwartz to approve the pledge of securities. Motion Carried.

Ova made a motion, seconded by Marks to approve the increase in poll worker wage from \$10.00 per hour to \$12.00 per hour. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Schwartz made a motion, seconded by Neys to approve the early voting precinct at the Stutsman County Courthouse as follows: Monday through Friday, May 29, 2012 to June 11, 2012 from 8:00 a.m. to 5:00 p.m., Saturday June 2, 2012 from 9:00 a.m. to 2:00 p.m. and Saturday, June 9, 2012 from 9:00 a.m. to 2:00 p.m. Motion Carried.

Neys made a motion, seconded by Schwartz to approve a local raffle permit for the Jamestown Regional Medical Center Relay for Life Team. Motion Carried.

Ova made a motion, seconded by Neys to approve advertising for bids on grazing leases on Stutsman County gravel pits. Motion Carried.

Casey Bradley, Auditor/COO presented a letter and a list of property owners who have been identified as encroaching upon the county's right-of-way. Upon receipt of the notice, the property owner will have until October 1, 2012 to remedy and reestablish the right-of-way to the condition of the property prior to the encroachment. Failure to do so will result in the county conducting the work and the property owner will be liable for 100% of the cost associated with correcting the damages. The property owners will be billed for the work if they fail to comply. Stutsman County will work with landowners to establish right-of-ways. Schwartz made a motion, seconded by Marks to approve the notification and the list of landowners regarding the encroachment on Stutsman County right-of-ways as presented. Motion Carried.

Casey Bradley presented Article 6 Fund Balance Policy. This policy addresses the implications of Governmental Accounting Standards Board (GASB) Statement No. 54, Fund Balance Reporting and Governmental Fund Definitions; which goes into effect this year. The policy is created in consideration of unanticipated events that could adversely affect the financial condition of Stutsman County and jeopardize the continuation of necessary public services. This policy will ensure that Stutsman County maintains adequate fund balances and reserves in order to provide sufficient cash flow for daily financial needs, secure and maintain investment grade bond ratings, offset significant economic downturns or revenue shortfalls, and provide funds for unforeseen expenditures related to emergencies. Schwartz made a motion, seconded by Ova to adopt Article 6 Fund Balance Policy as recommended. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Bradley, Auditor/COO presented Article 7 Investment Policy to the board. This policy addresses the investment objectives and parameters for the management of public funds of Stutsman County. The intent of this policy is to safeguard funds on behalf of the County, to assure the availability of funds for operational and capital needs, to comply with applicable North Dakota Century Code, and to provide a competitive return on investment. This policy is set forth to reduce the custodial risk and concentration of credit risk. Ova made a motion, seconded by Schwartz to approve Article 7 Investment policy as

presented. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, updated information on the burn bans. Jerry informed the board that Stutsman County did not have a lot of fires since the last commissioner meeting. The burn ban went into effect three times since March 20, 2012. It is the recommendation from the Fire Chiefs in Stutsman County to continue with the burn ban. It is too dry and we have not had a loss of precipitation. It is the consensus to continue with the burn ban and revisit it at the next commissioner meeting.

Neys made a motion, seconded by Schwartz to appoint Robin Iszler, Frank Balak, Casey Bradley, and Ben Maulding to the local emergency planning committee members with the removal of Jim Michael, Noel Johnson, Tom Lindberg, Dave Donegan, and Tom Tracy. Motion Carried.

Mickey Nenow, County Highway Superintendent presented his monthly report. The highway department is requesting to purchase oil at \$3.24/gallon and chip seal 17 miles of road near Ypsilanti, Montpelier, and Millarton. The only place to purchase the chips is from Strata Block. The chips increased in price. It went from \$11.50 per ton in 2004 to \$19.80 per ton in 2012 for the chips. The highway department would need about 3400 ton of chips to do the 17 miles of road which will approximately cost \$25,000 per mile. Schwartz made a motion, seconded by Marks to approve the purchase of oil and to chip seal the 17 miles of road as requested. Roll call vote: Klose, Ova, Marks, Schwartz, Neys vote aye.

Mickey had received some phone calls from people who are interested in purchasing the screening machine that Stutsman County owns. The screen plant is too small and the road department does not use it anymore. Mickey would like to advertise for bids to sell it. The road department crew is starting on crack sealing and rocking some township and county roads that are in danger of getting washed out. After that then the road department will work on culverts and other projects for FEMA. Stutsman County received a state payment for the flooding bill where the townships each received \$10,000.00 and the county was projected to receive \$198,000.00. It looks like the county will be receiving \$720,000.00 with approximately \$290,000.00 will be divided among the townships based on road miles in the townships.

Fritz Fremgen, Stutsman County State's Attorney presented his monthly report. Fritz is currently working on the mobile home case. Fritz stated that he will need to read on some cases that were brought up. The information regarding the right-of-way encroachment was presented at the township meeting. Fritz reported that he did not hear of any gripes or questions. The case of Sissell vs. Stutsman County was turned over to North Dakota Insurance Reserve Fund.

At 5:15 p.m., the Stutsman County recessed for the County Park Board Meeting.

At 5:20 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys, Mark Schlecht, Robert Woodward and Mark T. Klose answered the roll call.

Marks made a motion, seconded by Woodward to approve the minutes of the March meeting. Motion Carried.

Neys made a motion, seconded by Schlecht to approve the monthly bills. Roll call vote: Ova, Marks, Schwartz, Neys, Klose, Woodward, Schlecht voted aye.

Dennis Lorenz, Stutsman County Park Superintendent is requesting to hire one full-time seasonal and one part-time seasonal position. Both positions are replacements and the dollars are in the budget. Ova made a motion, seconded by Schwartz to approve the request to hire one full-time and one part-time position. Motion Carried.

Dennis presented to the board his monthly report. The park department is starting on their spring work. They are working on the areas that were affected by the flood. They are doing some dragging and may possibly have to plant some grass seed in areas. The Park Department will be opening up some of the campgrounds after the Easter weekend. They had major problems at Pelican Point where they will have to rebuild pads that were washed out and hook up the well system. Dennis will be gathering water samples from the wells and sending them in to the North Dakota Health Department. Campfires at the campgrounds may be an issue with the burn ban.

Vern Quam, City of Jamestown Forester presented information regarding a United States Forest Service Grant to plant a living snow fence near 19th Street Northeast which is on Bureau of Reclamation land. The Lions Club approached Vern about a tree planting project near 19th Street Northeast. This area has received a considerable amount of snow over the past years. It is a \$10,000.00 50/50 matching grant from the forest service with a local match of \$10,000.00 for a total of \$20,000.00 plus in-kind; with the in-kind there could be a possibility of adding additional trees. Vern will write the grant, but Stutsman County will be the applicant. The Soil Conservation would use a weed barrier and plant many types of trees including but not limited to junipers, pines, spruces, lilacs, elms, etc. The Bureau of Reclamation, Larry Kuntz gave cultural clearance to go ahead with this project. Neys made a motion, seconded by Woodward for approval to apply for a US Forest Service Grant Application living snow fence. Motion Carried.

Fritz Fremgen updated the board on the assignment of leases at Spiritwood Lake. He reported that he has not worked on a new lease for the Spiritwood Lake area. He is looking at starting to work on this mid-April to the end of April. Fritz is looking into permit vs. lease and evaluating the two of those types against each other. There are significant issues and complications from the prior contract that will need to be addressed and some of those could be political issues. This would be a good time to clean up the old contract. A subcommittee consisting of Dave Schwartz, Casey Bradley, Mark Schlecht, Sandra Eckelberg, and Fritz Fremgen will meet at 8:00 a.m. Wednesday, April 4, 2012 in the commissioner room to review the lease agreement and to address any concerns.

Denny Ova recommended that the 81.7 acres of CRP land be allowed to expire from the program and not

be renewed. The CRP program has certain requirements to meet. One of them is to not have any volunteer trees. The CRP program also requires certain grasses be maintained. If the correct grass is not growing; Stutsman County is liable and will have to replant at our expense. If Stutsman County bids the CRP land and it is accepted, then Stutsman County has to accept it. Ova made a motion, seconded by Schwartz to approve the 81.7 acres of CRP land to expire from the program at the end of its term. Roll call vote: Marks, Schwartz, Neys, Klose, Woodward, Schlecht, Ova voted aye.

Neys made a motion, seconded by Schwartz to approve a Stutsman County Rural Water agreement for Pelican Point landing. The Bureau of Reclamation did not have a problem with this agreement. Roll call vote: Schwartz, Neys, Klose, Woodward, Schlecht, Ova, Marks voted aye.

Ova made a motion, seconded by Schlecht to approve the four private boat dock permits on the Jamestown Reservoir and set the fee at \$150.00 per year. Motion Carried.

Larry Kuntz, Bureau of Reclamation presented information on Title 28 funding. Stutsman County received a \$42,000.00 matching grant earlier. The Bureau has an additional 50/50 matching grant in the amount of \$40,000.00 and Stutsman County matching an additional \$40,000.00. This grant can be used for recreational development at Pelican Point. Schwartz made a motion, seconded by Woodward to approve of the \$40,000.00 matching grant. Motion Carried.

At 6:03 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Neys, seconded by Woodward. Motion Carried.

At 6:03 p.m., the Stutsman County Commission Meeting reconvened.

It is the consensus of the board to summarize Casey Bradley's evaluation on one form. Mark will compile the information and he will present it to Casey.

Marks made a motion, seconded by Schwartz to approve the bills for payment. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.
