Schwartz made a motion to approve the minutes of the March 2018 meeting, seconded by Marks. Motion carried.

Montpelier City Council was present regarding County property in Montpelier, ND. A motion to allow the former owner to take the personal belongings no later than one week from the commission meeting was made by Marks, seconded by Ova. Motion carried.

Ryan Odenbach, Stutsman County Soil Conservation District gave the commissioners a notice for the PTMApp (Prioritize, Target, and Measure Application) Tool. Mr. Odenbach thanked the Stutsman County Commission for contributing to the PTMApp Tool project back in 2015.

Tyler Perleberg, Director of Tax Equalization/Zoning Administrator, presented an Application for Property Tax Exemption for Improvement to Residential Buildings for parcel # 16-0421022. Schwartz made a motion, seconded by Neys to approve the exemption for 3 years, seconded by Neys. Motion carried.

A letter of support for DSA (Dakota Spirit AgEnergy) revaluation was presented by Perleberg. Ova made a motion, seconded by Neys to approve the letter of support. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye.

Nicole Meland, Auditor/COO, proposed to establish the poll worker wage for the 2018 election at \$12.00/hour. Meland also proposed establishing polling hours. Nenow also requested to purchase a skid steer mount pavement / grinder. The amount budgeted for both attachments was \$25,000.00. Schwartz made a motion, seconded by Ova

to approve the requested purchase. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye. Motion carried.

Jerry Bergquist, Emergency Manager/91-1 Coordinator, presented membership changes to the Stutsman County Local Emergency Planning Committee (LEPC). Neys made a motion to approve the changes as presented, seconded by Ova. Motion carried.

Bergquist requested out of state travel for Joshua Greeney for training. A grant was received that will cover the majority of the costs. Schwartz made a motion to approve the out of state travel request, seconded by Marks. Motion carried.

The County Commission meeting recessed for the County Park Board Meeting.
