

Official Proceedings of the Stutsman County Commission – April 17, 2018

At 4:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Denny Ova, Mark Klose and Craig Neys answered the roll call.

Robin Iszler, Central Valley Health District, presented the Annual Report for 2017, as well as the Budget Review.

David Schwartz, Commissioner, spoke in regards to a letter of support from the commission pertaining to a roadway easement for Stutsman County Highway 39 Road project. This requested letter of support would be expedited to Governor Doug Burgum. A motion to send the letter of support was made by Ova, seconded by Neys. Motion carried.

Schwartz also indicated that the County received copies from the State for the road easements for the Stutsman County Highway 39 Road project. The easements were reviewed and appear to be acceptable. Schwartz made a motion, seconded by Marks to approve and sign the easements and return to the State. Motion carried.

Nicole Meland, Auditor / COO, made a request to appoint Jessica Alonge as Chief Deputy Auditor / Recorder. Ove made a motion, seconded by Schwartz to approve the appointment. Motion carried.

Meland made a request to appoint Jessica Moser as Treasurer. Schwartz made a motion, seconded by Neys to approve the appointment. Motion carried.

A motion to approve the liquor license and beer license for the Jamestown Country Club was made by Ova, seconded by Schwartz. Motion carried.

Meland presented an update on the Janice Harr property clean up. A total of 36.52 tons of garbage was brought to the landfill. Overall costs amounted to \$6,288.57 and will be special assessed against the property if not paid.

Marks made a motion to approve the taxable meals and mid-month bills, seconded by Ova. Schwartz, Neys, Klose, Ova, and Marks voted aye. Motion carried.
