

Official Proceedings of the Stutsman County Commission – April 19th, 2016

At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Fritz Fremgen, State's Attorney, presented a review of the grievance process to the commissioners according to Chapter eight of Stutsman County Personnel Policy.

Schwartz made a motion, seconded by Neys that there were reasonable grounds to support one of more of the allegations. Roll call vote: Ova - aye, Marks - nay, Schwartz – aye, Neys – aye, and Klose – aye. Motion carried.

Ova made a motion, seconded by Schwartz that the sustained allegations did warrant the negative personnel action taken by the department head. Roll call vote: Marks – nay, Schwartz – aye, Neys – aye, Klose – aye, and Ova – aye. Motion carried.

Tim Greshik spoke to the board regarding the Elizabeth Kapp grievance.

Barb Johnson voiced her concerns about the Elizabeth Kapp grievance to the commission.

Nellie Degen spoke to the commissioners on the Elizabeth Kapp grievance.

Duane Johnson expressed to the commission board regarding moving forward from the Elizabeth Kapp grievance.

Linda Perleberg spoke before the commission on the Elizabeth Kapp grievance.

Connie Ova, Jamestown/Stutsman Development Corporation (JSDC) is requesting approval of the New Energy Spirit Biomass Refinery (NESBR), LLC to match to Ag Products Utilization Commission (APUC) Grant match for update of biomass study, project feasibility study and business plan completion. These dollars are contingent upon approval of the APUC request. The proposed project NESBR, LLC is planning to develop, construct, own and operate a commercial scale biomass refinery converting local biomass residues such as corn stover, wheat straw and energy crops into cellulosic ethanol, lignin pellets, biogas and bio-chemicals at the Spiritwood Energy Park (SEPA). New Energy Spirit Biomass Refinery LLC has submitted an application to the ND Ag Products Utilization Commission requesting \$225,000 in grant funding from the "Marketing and Utilization Grant Program". The proposed funding is as follows: NESBR, LLC \$300,000; JSDC \$75,000; APUC \$225,000 for a total of \$600,000. The City of Jamestown/Stutsman County split is 90/10 percent with the county's portion being \$7,500. Schwartz made a motion, seconded by Marks to approve the request as presented. Roll call vote: Schwartz, Neys, Klose, Ova, and Marks voted aye. Motion carried.

Connie is requesting renewal of support for matching funds for the North Dakota Trade Office (NDTO) for the 2016-2018 biennium. The JSDC funding request is for \$25,000 to match \$55,000 in dues from local companies who have benefited from working with the North Dakota Trade Office. This will assist in the continuing effort to open new overseas markets to the businesses locally and statewide. The request is an 80/20 percent split between Jamestown and Stutsman County with the county's portion being \$5,000. Neys made a motion, seconded by Schwartz to approve the renewal request as presented. Roll call vote: Neys, Klose, Ova, Marks, and Schwartz voted aye. Motion carried.

Connie informed the commissioners the JSDC annual meeting is April 27th, 2016 from 5:00 p.m. to 7:00 p.m. at the Holiday Inn.

Darrell Wollan, City of Jamestown Assessor, is presenting an abatement request for parcel number 74-7122000. Wollan stated the Jamestown City Council recommended a denial of the abatement application. Ova made a motion, seconded by Neys to deny the abatement request for parcel number 74-7122000 as presented. Motion carried.

Mickey Nenow, County Highway Superintendent, is requesting to select a committee for construction engineering for the Ypsilanti Bridge. New road regulations went into effect for federal funded projects and now the county has to have a selection committee to perform interviews for federal projects. The Ypsilanti Bridge requests for proposals (RFP) are due 4:00 p.m. on May 5th, 2016 with the bid opening on May 13th, 2016. The selection committee interviews will take place around May 11th and 12th, 2016. The federal government provides the interview questions to ask. Mickey requested to have Commissioner Schwartz, Commissioner Marks, Assistant Highway Superintendent Michel, Auditor Bradley, and himself on the Selection Committee. Neys made a motion, seconded by Ova to approve the selection committee for the construction engineering on the Ypsilanti Bridge as presented. Motion carried.

Tammie Dillman, Central Valley Health District, is requesting approval of a Redemption of Central Valley Health Bond and resolution for providing for redemption of the 2017-2025 maturities of the limited tax revenue refunding bonds. Each bond for redemption will become due and payable on June 1st, 2016 at a redemption price equal to its face value plus accrued interest thereon. The Central Valley Health Board approved paying off the bonds early which is a savings of over \$40,000. Ova made a motion, seconded by Neys to adopt the resolution and the redemption of bonds as presented. Motion carried.

Schwartz made a motion, seconded by Ova to approve the taxable meals and mid-month bills. Roll Call vote: Klose, Ova, Marks, Schwartz and Neys vote aye. Motion carried.
