

Official Proceedings of the Stutsman County Commission – May 1st, 2012

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Schwartz made a motion, seconded by Neys to approve the minutes of the April 2012 meetings. Motion Carried.

Ova made a motion, seconded by Neys to approve a local raffle permit for the benefit of Carissa Tripp's three children at the Stutsman County Fairgrounds. Motion Carried.

Lutheran Social Services is requesting approval to adopt a resolution relating to a project under the municipal industrial development act (MIDA) bond giving the project preliminary approval and is dependent upon a public hearing. Jon Arnston from Arnston, Wegner, and Stewart informed the board that Lutheran Social Services is renovating the old Jamestown Hospital building. It will be used for elderly housing and other community uses. Jon is requesting from the commission board to set a public hearing to consider issuing MIDA bonds. The public hearing is scheduled for June 5th at 4:15 p.m. The bond request is for five million to five and one-half million dollars not to exceed the five and one-half million dollars. The total project is estimated to cost approximately ten to ten and one-half million dollars. Ova made a motion, seconded by Schwartz to approve to adopt a resolution dependent upon the public hearing on June 5th at 4:15 p.m. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Bids were opened for grazing leases. Bid is as follows: Ron Holzworth from Buchanan, ND, 55 acres at \$10.00 per acre for Section 23, Township 141. Ova made a motion, seconded by Neys to accept the bid from Ron Holzworth. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Casey Bradley, Auditor/COO sent a letter to the North Dakota Historical Society regarding the status of the old courthouse. Casey, Tracey Trapp, Ramone Gumke, David Schwartz, Jerry Bergquist, Mark Klose, Chad Kaiser, some of our maintenance staff, the director of the ND Historical Society, the assistant director and a member of their staff came here approximately a month ago and toured the facility. The historical society hired a contractor who performed an air quality test. Various types of mold were found to be present which requires the building to be quarantined. Some of their security personnel were also present to address the security issues. The North Dakota Historical Society presented a tentative schedule of various tasks for the Historic Stutsman County Courthouse. They identified areas that need to be addressed such as mold, asbestos, general maintenance inside and outside the facility, wiring, and security issues. The Historical Society is working with Badlands Environmental to mitigate the mold and asbestos. Stutsman County is working on this issue before it affects our facility.

A public hearing was held for Great River Energy's resolution authorizing the issuance of solid waste disposal revenue bonds under the municipal industrial development act (MIDA) increasing from \$50

million to \$70 million. Ova made a motion, seconded by Schwartz to approve the resolution authorizing the increase from \$50 million to \$70 million in MIDA bonds. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye. There were no comments heard from the public.

Nina Schneider, Buffalo City Tourism Foundation updated the commissioners on the audit results and also requested a release of funds in the amount of \$6,000.00 for the Frontier Village Association. The audit identified approximately ten areas where the Frontier Village Association needs improvement such as a better way to manage and track transactions. Schwartz made a motion, seconded by Marks to approve the request of funds in the amount of \$6,000.00. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Neys made a motion, seconded by Schwartz to accept a proposal from Interstate Engineering for Construction Engineering Services for CER-4717(082), CER-4717 (083), and CER-4717 (084). Roll call vote: Klose, Ova, Marks, Schwartz, Neys voted aye.

Schwartz made a motion, seconded by Marks to approve the grant maintenance agreements for projects CER-4717 (085) and CER-4717(090). Motion Carried.

Mickey Nenow, County Highway Superintendent presented his monthly report to the commissioners. The crews are working on crack sealing and rocking. Mickey is keeping the road restrictions on. The roads are still in rough shape.

The purchase prices were almost identical with the trade in and buy back. It came down to the fuel consumption. The John Deere was on average of 5.6 gallons per hour and the Cat was at 4.9 gallons per hour. Schwartz made a motion, seconded by Marks to accept the bid from Butler Machinery. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Originally we were going to purchase two motor graders, however the winter was mild and the road department decided to only trade out one high hour motor grader. The road department also had in the budget to purchase two dump trucks and a pickup. The road department received one dump truck for free which means they will be under budget on the purchase of assets this year. If measure two passes the road department does not know what the 2013 budget will be like. The permanent grade raises will not be done this year due to the bidding of the project happening in November with the construction being started in 2013. Mickey is requesting approval to bid a new motor grader. Schwartz made a motion, seconded by Marks to approve publishing a bid solicitation for a new motor grader as requested. Motion Carried.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager updated the commissioners on the burn ban. Foster County rescinded their burn ban as of today. Jerry informed the board that Stutsman County only had three grass fires since the last commissioner meeting we did not have any days that were classified as very high or extreme conditions. It is the recommendation from the Fire Chiefs in Stutsman County to rescind the burn ban. Jerry mentioned that Chad Kaiser, Stutsman County Sheriff, is very much in favor that the Fire Emergency Declaration/Burn Ban Proclamation would become a permanent ordinance. Schwartz made a motion, seconded by Marks to rescind the Fire Emergency

Declaration/Burn Ban Proclamation. Motion Carried.

Jerry is requesting permission to allow the State's Attorney to continue working on an agreement with Richland County to purchase 9-1-1 equipment together that is the same brand. Richland County and Stutsman County use the same mapping software and are very similar in the day to day operations in the dispatch center. We could link the 9-1-1 systems and eventually the radio system together and be a back-up for each county in cases of emergencies. Ova made a motion, seconded by Schwartz to approve a joint purchase of 9-1-1 equipment with Richland County as presented. Motion Carried.

A vulnerability assessment was completed late last year on the Law Enforcement Center and the Courthouse. The assessment suggested having a plan available for employees and visitors in the event of an emergency. Jerry Bergquist and Todd Volk presented an emergency preparedness plan for Stutsman County. Marks made a motion, seconded by Ova to adopt the emergency preparedness plan as presented. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Ashley Hietkamp, Assistant State's Attorney, updated the board on the monthly report. Ashley stated that Fritz Fremgen, State's Attorney is working on the upcoming murder trial in August. The Defense Attorney did file a motion for a change of venue. There is a possibility that the trial will be venued somewhere else, however, it has not been decided as of yet. Ashley presented information on Title VI compliance. Ashley stated that she has filed the appropriate paperwork in December and has not heard back from the State of North Dakota. We are one of four counties that we have got into compliance.

Fritz Fremgen, State's Attorney, updated the board with his monthly report. Fritz is currently working on the mobile home case. Fritz stated he will read a case that may be similar to the mobile home case. The case regarding the Family Medical Leave Act is finished since the employee resigned. It is of Fritz's opinion that the Right of Way is going along smoothly. Fritz informed the board that the North Dakota Insurance Reserve Fund appointed a lawyer in the case of Sissell vs. Stutsman County. Fritz had a phone conference with Richland County regarding the potential joint powers agreement with Richland County for the 9-1-1 upgrade material. Fritz is receiving information from Aaron Burst from the North Dakota Association of Counties since they have gone through this before. It is of Fritz's opinion that the real legal work is bidding for the project.

Marks made a motion, seconded by Neys to approve the bills for payment. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Dennis Lorenz, Stutsman County Park Superintendent presented his monthly report. At Pelican Point, the painters are almost done with the restroom facility, the grass is seeded, and the water sample report was good. The Roaming Buffalo organization came in to clean up the Lakeside campgrounds. There is a wedding being held on the island this weekend. At the Marina, the air conditioner unit needs replacing. Dennis received three quotes from: Lifestyle submitted a quote for a 25,000 BTU wall air conditioner unit for \$679.00; Sears submitted a quote for a 25,000 BTU wall air conditioner unit for \$569.99 and Lifestyle submitted a quote for a Fairbrecks brand 24,000 BTU wall air conditioner unit for \$800.00. The Fairbrecks unit is the only one that will fit in the existing hole in the wall; the other two units would need additional construction to make the units fit. Marks made a motion, seconded by Woodward to accept the quote from Fairbrecks. Roll call vote: Klose, Schlecht, Woodward, Ova, Marks, Schwartz, Neys voted aye. Pelican Point project received \$10,500.00 from the Garrison Diversion.

At 6:35 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Schwartz, seconded by Woodward. Motion Carried.
