At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call.

A motion was made by Kaiser seconded by Ova to approve the minutes of the May 2010 meetings. Motion carried.

Noel Johnson, County COO, reviewed the pay statute for election workers and recommended paying the poll workers for the 2010 Primary Election \$10.00/hr with the rural precinct workers to receive a \$15.00 meal allowance – meal would be provided at the Vote Center in Jamestown for the poll workers. Ova made a motion seconded by Kaiser to set the wage at \$10/hr, with rural precinct workers to receive \$15 meal allowance. Roll Call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Johnson recommended renewing the contract with Computer Professionals. He stated that they do the County's software and support for the IBM Mainframe and have been an excellent company to work with. The length of the contract was the only change, with it now being a five (5) year contract. Marks moved that the contract be approved and Neys seconded the motion. Roll Call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

Neys made a motion seconded by Ova to approve the site authorizations for the Knights of Columbus at the Windsor Bar, Sportsman Bar, Hitching Post Bar and Ypsilanti Bar & Grill. Motion carried.

A motion to approve the liquor licenses and Sunday alcoholic beverage permits as presented was made by Ova and seconded by Kaiser. Motion carried. Liquor licenses/Sunday alcoholic beverage permits: Jamestown Country Club, Wayne and Hilda Kuntz d/b/a Sportsman Bar, Sandra Norquist d/b/a Ypsilanti Bar & Grill, Carmel Demaray d/b/a Windsor Bar, Ronald Davis d/b/a Cuz'n Rons Saloon & Steak Outfitters, Judy Ganser d/b/a Anchor Bar, Joey Uehran d/b/a 281 Stop. Liquor license: Krewzer's Dream, Inc. (Krissi & Robert Wenzel) d/b/a Buchanan Bar.

Johnson presented a new business property tax exemption application from Allied Agronomy. Gene Erpelding, General Manager of Allied Agronomy, stated that it would be a repackaging warehouse for farm chemicals and possibly some seed storage and redistribution. He stated that they would not be dealing with fertilizers. Erpelding said that they would not be competing, would just be using it for repackaging and support of their existing business. There would be a fair amount of truck traffic, part of the reason for locating on the truck bypass. They would also employ four to six people in their first five years. He stated that their intent was not to compete in the area. With the change in regulations required by 2014 they were looking at what they needed to do to support their existing business. They could possibly do repackaging for Winfield Solutions but Allied would not be the ones selling chemicals into the marketplace, they would be more of a wholesale operation.

John Grabinger asked if they would be in competition for seed since there is a seed supplier just down the road from their location. Erpelding said that yes per se they would. Grabinger stated that he thinks it's time to stop giving tax exemptions to competing businesses, that tax exemptions need to be given to something new coming into the area. Let the competition stand on their merit. Marks stated that he said that he would not vote in favor of exemptions for competing business.

Klose reviewed the exemptions that had been approved in the past. Marks said that he had approved exemptions for competing business in the past and he regrets that now. Kaiser voiced concerns about the additional truck traffic on our roads and that the County was not receiving anything right away to go towards the roads.

Connie Ova, personally not representing JSDC, questioned if there was a compromise that could be considered other than what was presented. She also wondered what the estimated taxes would be. Johnson said that the taxes would be about \$35,000/year. Ms. Ova stated that she did not want to send a message that the County discouraged competition.

Art Perleberg, Midway Township Supervisor, wanted clarification on the extent of the seed business. Erpelding said that the majority would be for support of their existing business but that their market has reached the edge of the Jamestown area so there could be some retail sale. Ova stated that he hated to see no exemption but feels that the Commission needs to cut back.

Marks made a motion to deny the request for exemption. Neys seconded the motion. Roll call vote – Kaiser, Neys, Klose, Ova and Marks voted aye. The request for a 10 year 100% exemption was denied.

Luella Morehouse, Nutrition Education Assistant with the NDSU Extension Service/Stutsman County, requested continued funding of the Family Nutrition Program. This was the 16<sup>th</sup> year of the program. The total match was \$50,483.98 from the County for 2011 in-kind funds. The schools had received grants for the fresh fruits and vegetables program so she would also be doing nutrition training to the schools. Marks made a motion seconded by Ova to approve the funding for the Family Nutrition Program. Roll call vote – Neys, Klose, Ova, Marks and Kaiser voted aye.

Fritz Fremgen updated the Commission on the maintenance agreement between the ND DOT and the County for the intersections between State and County roads.

Dave Orr, County Sheriff, reviewed options for traffic control on 3<sup>rd</sup> street during the milling of County Highway 10. Signs had been posted for no thru traffic.

Connie Ova on behalf of Jim Boyd, JSDC Board President, wanted to state that JSDC was in support of County Measure #2, the increase of the mill levy and sales tax, that it was important for economic development.

Neys made a motion seconded by Kaiser to approve a \$10,000 loan from the General Fund Sub-account for Griffin Township for 5 years at 5% interest for road work within the township. Roll call vote – Klose, Ova, Mark, Kaiser and Neys voted aye.

Ova made a motion to nominate Dr. Edward Anderson to the Central Valley Health District Board, Alice Pekarski to the School Reorganization Committee and Carolyn Cichos to the Housing Authority Board. Kaiser seconded the motion. Motion carried.

Erpelding asked if Allied Agronomy could reapply for something less than the original property tax exemption request. Klose said that they could and to visit with Auditor Johnson regarding alternatives.

Johnson requested that the Commission visit with Mike Zimmerman, County Road Superintendent, regarding who has what authority and who was responsible for what regarding the whole road milling process. Kaiser said that he would address the concerns.

At 4:41 p.m. the County Commission meeting was recessed for the County Park Board meeting.

He had checked with Sears and was quoted a price of \$569.99/unit for 25,000 btu window units.

Lorenz gave an update on the progress at the Marina and at Pelican Point Landing. The Marina Campground was open and was full over the past weekend. They're getting bids for the cement work at Pelican Point with work to be completed by the 15th. Pelican Point was also full. His crew was also busy mowing grass. The fish grinder at the Marina was ready to go. Parkhurst was also busy.

A motion to adjourn was made by Ova seconded by Neys. At 5:09 p.m. the June 2010 County Park Board meeting was adjourned.

At 5:10 p.m. the regular Commission meeting was called back to order with all Commissioners present.

The bills were reviewed. Auditor Johnson raised a question on the mileage voucher for Zimmerman.
