At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Craig Neys, Doug Kaiser and Mark T. Klose answered roll call.

Ova made a motion that was seconded by Neys to approve the minutes of the May, 2009 meetings. Motion carried.

Kaiser made a motion that was seconded by Ova to nominate the following to the Stutsman County School Reorganization Board: Terry Schwartz (Dist 3), Don Hofmann (Dist 5), Charles Axtman (Dist 1 Alternate), Ann Marks (Dist 2 Alternate), Dwight Hofmann (Dist 5 Alternate). Motion carried.

A motion was made by Ova and seconded by Neys to nominate Cindy Schaar to the Central Valley Health District Board. Motion carried.

Kaiser made a motion that was seconded by Ova to nominate Jane Trautman to the Jamestown City Planning Commission. Motion carried.

Neys made a motion that was seconded by Kaiser to nominate Wade Williams to the Stutsman County Housing Authority. Motion carried.

Fritz Fremgen, State's Attorney, gave his monthly report. He was busy working on the back log in the office created by him assisting with the flood efforts.

Ova made a motion that was seconded by Neys to approve the following liquor licenses and Sunday alcoholic beverage permits: Jamestown Country Club, Krewzer's Dream, Inc. (Krissi and Robert Wenzel) d/b/a Buchanan Bar (liquor license only), Wayne and Hilda Kuntz d/b/a Sportsman Bar, Sandra Norquist d/b/a Ypsilanti Bar & Grill, Carmel Demaray d/b/a Windsor Bar, Ronald Davis d/b/a Cuz'n Rons Saloon and Steak Outfitters, Lucas Gudmestad d/b/a Hitchin' Post Bar. Motion carried.

Mike Zimmerman, County Road Superintendent, presented a letter to terminate contracts CER-4717(064) & CER-4717(065) to pave the grade raises on County Highway 67 south of Cleveland and north of Gackle due to high water. Kaiser made a motion that was seconded by Marks to terminate the contracts. Motion carried.

Zimmerman presented options for County Highway 67 south of Cleveland. A survey indicated that a 10 foot grade raise would be necessary. The water could not exceed this height – it would drain into another wetland. A 10 foot grade raise would cost \$1.856 million. Realignment around the east side of the basin wetland would cost \$1.065 million. ND Department of Transportation ER funds were available on an 80/20 split – 20% County. 100% emergency funds were available for a temporary fix to get through this year. A lesser grade raise or a temporary road around the wetland were potential options. Marks made a motion that was seconded by Ova to realign the road and go around the wetland to the east. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Zimmerman presented a break down of pavement patching costs for the past five years by road segment. Total patching costs for those years were \$686,000. The highest cost for any individual road segment was \$93,000 for part of County Highway 62.

Ova made a motion that was seconded by Kaiser to solicit proposals for engineering services for repairing the County roads that use ER (Emergency Relief) funds. Motion carried.

At 4:42 p.m. the County Commission meeting was recessed for the County Park Board meeting.

Kaiser made a motion that was seconded by Schlecht to approve the special use permit for Buffalo City RC Squadron at the Jamestown Reservoir June 12 through June 14. Motion carried.

Dennis Lorenz, County Park Superintendent, presented a bill for \$3,662 from Northern Excavating for putting in a culvert and a temporary road on a west side cabin road. The Bureau of Reclamation had authorized the road, but Lorenz had not authorized that the Park Board would pay for the repairs. Rob Lindberg indicated that the temporary road had to be done to provide access to the cabins. He was trying to recover some of the cost for the repairs. Lorenz indicated that the roads on the Bureau land that provided access to the cabins were not Township or County roads. There was no motion made to approve payment of the bill.

Dennis Lorenz, County Park Superintendent, gave his monthly report. Pipestem Reservoir was now open to boating. Access was available at the high water ramp at Parkhurst. Boating was also allowed on the Reservoir north of the Highway 20 five-mile curve (north of the cabins). Access was available by a portable boat ramp supplied by Game and Fish.

The Board needed to decide where they wanted to locate the buildings that had been moved at the Marina and at Pelican Point landing. The concessionaire committee would review potential sites and make a recommendation to the Board.

Lorenz would be hiring a helicopter to spray weeds at the Reservoir. The helicopter had an injection system so spray drift was minimal. The Bureau of Reclamation would participate in the cost. Property owners would be notified when the spraying would be done – likely late June or early July.

Schlecht made a motion that was seconded by Woodward to authorize Lorenz to purchase a 5 foot rotary mower for around \$2,500. Roll call vote – Woodward, Ova, Marks, Kaiser, Neys, Klose and Schlecht voted aye.

Lorenz reported that there was a lot of debris washing up on the shores in and around the cabins. He requested lifting the burning ban at the Reservoir so the cabin owners could clean up the debris. Ova made a motion that was seconded by Neys to allow burning provided a project application was made and approved. Motion carried.

Lorenz indicated that cabin owners had asked about how to properly dispose of their sandbags. Jerry Bergquist, 911 Coordinator/Emergency Manager, reported that the City would accept all sand bags and they were working on a plan to reclaim the sand at the City baler facility. A letter would be sent to the cabin owners explaining their options.

A motion to adjourn was made by Neys and seconded by Woodward. At 5:21 p.m. the June 2009 County Park Board meeting was adjourned.

At 5:22 p.m. the regular Commission meeting was called back to order with all Commissioners present.

Ova made a motion that was seconded by Marks to approve payment of the monthly bills. Roll call vote: Marks, Kaiser, Neys, Klose and Ova voted aye.
