At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Marks made a motion, seconded by Neys to approve the minutes of the May 2016 meetings. Motion carried.

Dale Marks, First Street Bridge Resolution, James Carlascio, recently passed away and was a very active member of the community. Mr. Carlascio was and avid spokesman to replace the First Street bridge after it had been removed due to flooding. Marks made a motion, Schwartz made a second to adopt the resolution of naming the bridge and moving forward in requesting the naming at the State level and also with the City of Jamestown. Roll call: Marks, Schwartz, Neys, Klose and Ova all vote aye, motion carried.

Tyler Perleberg, Tax Director, Shawn Ratts #36-3330000 does qualify for a farm residence exemption and has filed an abatement. Perleberg does recommend the approval. Ova made a motion, seconded by Marks to approve the abatement on parcel #36-3330000. Motion carried.

Perleberg, continuation of GIS system, which tracks land use data & parcel layers. Contract is \$700 for the year. Schwartz made a motion to approve the renewal, seconded by Neys. Motion carried.

Jim Fettig, Maintenance supervisor, cooling tower is about 20 years old & he has been fixing as needed. Requesting to replace before the system fails & brought in Trane representatives to explain how to phase in without having to get architects involved. Estimated cost would be around \$250,000 to buy everything & setup. Budgeting has begun but the full amount has not been set aside yet. Fettig is hoping to get around 2-3 years out of the current cooling system and start replacing parts of it in phases. Commission would like the representatives to work with Jim Fettig & Howie Peuser on putting a plan together and bringing it back to another commission meeting.

Fettig made the request to do out of state travel to see the new cooling system in Minneapolis. Neys made a motion, seconded by Ova to approve the out of state travel for 2-3 maintenance workers. Motion carried.

Howie Peuser, LEC maintenance, asked local contractors and received 3 lawn service bids. Double S lawn service formally known as green lawns was the low bidder \$198.90 per spray. Neys made the motion to accept the low bid from Double S lawn service, seconded by Schwartz. Motion carried.

Mickey Nenow, Highway Superintendent, presented his monthly report to the commissioners. Road department has been graveling, placing culverts, and the shop in Jamestown is finished other than electrical work. Chip Seal north of Woodworth and county roads 44, 67 & 69 are finished as of Saturday. Signage will be placed by Ypsilanti and Montpelier and will start grinding the last mile of pavement by next week.

Backhoe quotes were received from Butler, RDO and Titan with Titan with the low bid including a 5-year warranty at \$91,440. Schwartz made a motion to award the bid to Titan with the 5 year warranty, seconded by Marks. Roll call: Schwartz, Neys, Klose, Ova and Marks all aye. Motion carried.

Casey Bradley, Auditor/COO, updated that they met with Interstate Engineering to look at options to possibly pave and repair 2 miles east of Spiritwood on Old Highway 10. \$933,043.50 which would take it all the way to the black top surface, road is in need of stabilization & engineers designed it for 5 inches. Bids have been coming in around 30% less than the engineering estimates. Barnes county has finished overlaying up to the county line using state funding so the road needs to remain open but can put axel weight restrictions on the road if seen necessary. Ova made a motion, seconded by Neys to proceed with the bidding process. All aye, motion carried.

Bradley received a supplemental agreement with Interstate Engineering based on percentage with estimated projects with a not to exceed amount. Rough estimate would be around \$13,800 for design and \$87,000 for construction engineering. Schwartz mad a motion, seconded by Marks to enter into agreement with Interstate Engineering. Roll call: Neys, Klose, Ova, Marks, and Schwartz all vote aye, motion carried.

Chad Kaiser, Sheriff, and Jamestown Police Chief Scott Edinger, gave an update that the city of Jamestown would like to add to the brim on the east and south side and layer with dirt and put up fencing all the way around it. Depth difference is about 15 feet; the property line would need to be built back up. A request for a baffle system was made at the old range and quotes were around \$733,000 in 2008 with a second quote around 2009 at \$400,000 when the price of steel dropped. Pistols, rifles & shotguns are done four times a year but they are not all done at the same time. Agencies are also considering cutting down the barrels & using a sound suppressor which could run around \$800 per gun.

Sheriff Kaiser received a retail firework application from Memory Fireworks Inc. for June 27<sup>th</sup>-July 5<sup>th</sup>, 2016. Ova made a motion, seconded by Schwartz to approve the application for Memory Fireworks Inc of Bismarck, North Dakota. Motion carried.

Bradley requested authorization to advertise to hire a new Assistant State's Attorney since Troy LeFevre is running in the Primary election unopposed for a judge position; Fritz would like to have some cross-over period to train in a new staff member. Looking at advertising in July and interview in August, possible hiring date would be mid to late September. Marks made a motion, Ova seconded as presented to start the hiring process. Motion carried.

Bradley presented an amendment to the poll worker listing & the appointment of the Canvas Board. Motion made by Neys, seconded by Ova to approve as presented and Marks being appointed as the Commission representative at the June 20, 2016 Canvas Board. Motion carried.

Ova made a motion, seconded by Schwartz to approve the liquor licenses as presented for Sportsman Café, Windsor Bar, Jamestown County Club, the Anchor Bar, Hitching Post, 281 Stop and Buchanan Bar. Motion carried.

Housing authority received an application from Elizabeth Martin, cannot conflict with section 8 requirements, forward Elizabeth Martin's application to make sure there isn't a conflict of interest. Zoning Board, Harold Bensch has decided not to reapply, 4 at large members with city and county representatives. Current members Brian Amundson & Duane Anderson reapplied but Ryan Odenbach did not apply & two new applications from Paul Bensch & Tom Shultz were received. Schwartz made a motion, seconded by Marks to appointment the Zoning applicants & forward Elizabeth Martin's application to Dave Klein.

Wage and Benefit committee, take Linda Ebel off & replace with Susan Reichenburger-Scott. Motion to approve the replacement as presented made by Ova, seconded by Schwartz. Motion carried.

At 5:07 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.
