

Official Proceedings of the Stutsman County Commission – July 2nd, 2013

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Ova made a motion, seconded by Schwartz to approve the minutes of the June 2013 meetings. Motion carried.

Dustin Bakken, Interim Tax Director, requested an addition of omitted property assessments for parcels 09-3010000, 28-0930000, and 28-1241000. Bakken was reviewing the GIS information on agricultural land and noticed the omitted properties. Parcel number 09-3010000 in 2012 received a value of \$5000.00. The property value for 2013 will increase to \$42,900.00. Parcel number 28-0930000 had a value of \$5700.00 for 2012; it will increase to \$55,300 in 2013. Parcel number 28-1241000 was mistakenly deleted off the tax rolls in 2010. The value for 2013 is \$14,100.00. All property owners have been notified at least 15 days prior to this commission meeting. Neys made a motion, seconded by Ova to approve the recommendation as presented. Motion Carried.

Schwartz made a motion, seconded by Marks to award the motor grader bid to Butler Machinery. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

The bid opening of the low water crossing in Sydney Township was held yesterday. The county received three bids from RTS Shearing, Bohlman Trenching, and Sellin Brothers. RTS Shearing's bid was returned back to them unopened due to the bid bond being in the name of Sydney Township instead of Stutsman County. Bohlman Trenching's bid was \$242,806.21 with a completion date of October 1, 2013. Ova made a motion, seconded by Marks to award the bid to Bohlman Trenching. Roll call vote: Marks, Schwartz, Ova, Neys, Klose voted aye.

Mickey Nenow, County Highway Superintendent, presented his monthly report. Nenow stated County Road 67; sites one and two have spots on the road that are broken up. Mickey spoke with Border States on an estimate to repair the broken spots on the road since they are already there working on the area. Border States estimated for site 1 it would cost \$21,500 for a two and a half inch overlay and will run for 640 feet and for site 2 it would cost \$26,400 for a two and a half inch overlay for 750 feet. Marks made a motion, seconded by Schwartz to approve the repair on County Road 67 for site one and two as presented. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Nenow requested to switch the Road Department's work week from Friday to Thursday to Sunday to Saturday. Schwartz made a motion, seconded by Neys to approve the request as presented. Motion Carried.

Mickey informed the commissioners the road department will start patching on Monday and will be chip sealing the week after.

A question was raised regarding the Central Valley Health Board Appointments. A misunderstanding occurred; it was the intent of the Central Valley Health Board by-laws the board appointment is made by the City of Jamestown. The county appointed Elizabeth Koenig which was not a City of Jamestown resident. Elizabeth withdrew her candidacy. The City of Jamestown will appoint a person to the board and the city will administer the oath. Central Valley Health Board will be updating the verbiage of their by-laws. Ova made a motion, seconded by Neys to re-appoint Dr. James Torrence and Dr. Philip Jystad. Motion Carried.

Fritz Fremgen, State's Attorney, was not available to present his monthly report.

Commissioner Schwartz requested approval to bid out Old Highway Ten project. The House Bill multiple requirements that have to be met for federal aid standards such as sloping for ditches and intersecting roads; to meet these requirements it is anticipated that all of the funding allocated for Stutsman County would have to be used only on this road and no other projects. There is excessive traffic on the road currently. Schwartz stated with the influx of construction this project needs to be done. Schwartz recommended designing the project in-house of re-grinding the existing asphalt that is there, leveling it to make a better base, and doing a four inch overlay. The county received \$1.6 million from a Senate Bill; however, the county may have to take the road off of the federal aid system since it won't meet federal standards. Currently, it

won't have that much of an impact, but may in the future. Schwartz suggested doing an in-house project and go to bid to get the final dollar amount with a completion date of October 15<sup>th</sup>. If the bids come in where it is feasible with the funding the county has; and without jeopardizing the ten percent match with the house bill, 20% match for federal aid money, and additional dollars the county needs for existing grade raises; the county can then reject the bids and not do the project. There is also a possibility of attaining private funding. Ova made a motion, seconded by Marks to approve the bid request as presented. Motion Carried.

Josh Smaage, IT Director requested permission to advertise for an Information Technology (IT) Assistant position. The IT Assistant job description was rewritten and would require a bachelor's degree. The IT Assistant position was not included in the salary study from Springsted. Smaage did his own research and came up with a range of \$28,000 to \$80,000.00 for an average annual salary. The position is currently at a grade nine; Smaage would like to get the position to a grade 13 or 14 and have an approximate annual salary amount of \$43,000 to \$45,000.00. Schwartz made a motion, seconded by Marks to approve advertising for an IT Assistant position as presented. Motion Carried.

Casey Bradley, Auditor/COO, updated the commissioners Cargill accepted the full \$130,000.00 for the purchase of the road and the right of way. Spiritwood Township came in to sign the documents. The county is taking possession of the road that needs to be improved and have all of the right of ways for the improvement. The bid information will be advertised in the paper on Friday with the awarding of the bid in early August.

Tracey Trapp, Jail Administrator, requested approval of a lease agreement between Stutsman County, the Highway Patrol, and the Bureau of Criminal Investigations. Trapp stated the rent is increasing from \$11.21 per square foot to \$12.00 per square foot. Ova made a motion, seconded by Neys to approve of a lease between Stutsman County, the Highway Patrol and the Bureau of Criminal Investigations as presented. Motion Carried.

Laurie, James River Senior Citizen's Center informed the commissioners the Senior Citizen's Center has moved into their new facility at the old hospital. There are some items still left for sale in the old James River Senior Citizen Center building. Laurie asked the commissioners what they wanted her to do with the items and the building. The consensus of the board was to leave everything sit as is and hand in the keys.

It is the consensus of the board to get quotes for putting up a shop at the Road Department. This would be used for cold storage for the Sherriff's Office and Maintenance Department.

At 4:53 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

Ova made a motion, seconded by Houge to approve a special event permit for Hugo's Family Fun Day. Motion Carried.

Dennis Lorenz, County Park Superintendent, presented his monthly report. Lorenz stated the road to the Island is open; however, the Jamestown Reservoir water is green and slimy. The carp are disappearing quickly with the heat and appears to be slowing down. The vendors are getting busier with the upcoming holiday. Commissioner Neys questioned Lorenz about carp removal at Sandy Beach. Hank Telken informed a commissioner he was picking up the dead carp and disposing of them. Denny Lorenz stated Hank had a place to dispose of the dead fish. It was stated to treat the vendors the same at the Marina and at Pelican Point.

A few trees need to be trimmed at Pelican Point. A question was raised as to who was responsible to trim the trees. It is the consensus of the board to identify the trees which need trimming; if the trees are on private property then the neighbor is responsible for trimming the trees; if the trees are in the county right of way then the county is responsible for trimming the trees, or if the trees are on the Park Department's land the concessionaire is responsible for trimming the trees.

At 5:12 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Houge, seconded by Woodward. Motion Carried.

At 5:12 p.m., the Stutsman County Commission Meeting reconvened.

Marks made a motion, seconded by Schwartz to approve the monthly bills for payment. Motion Carried. The Stutsman County Commissioners expressed their gratitude and thanked everyone for all of their hard work on working with Tyler Technologies Software.
