

Official Proceedings of the Stutsman County Commission – July 2, 2019

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke, David Schwartz, Steven Cichos, and Mark Klose answered the roll call.

Ova made a motion, seconded by Gumke to approve the June 2019 meeting minutes. Motion carried.

Mark Attleson, Maintenance Engineer, requested approval to replace a coil on the rooftop unit at Social Services. Gumke made a motion to approve the request, seconded by Schwartz. Roll call vote: Ova, Gumke, Schwartz, Cichos and Klose voted aye. Motion carried.

Mayor Heinrich made a request of Chairman Klose to propose by-passing the Jamestown Stutsman Development Corp (JSDC) when determining the payment of South Central Dakota Regional Council (SCDRC) dues. Connie Ova, CEO JSDC, read official minutes and JSDC policy regarding SCDRC dues. Concerns were stated regarding violation of JSDC policy and it was determined the issue would be presented to the JSDC Board.

Scott Wegner spoke on behalf of Arntson Stewart Wegner PC regarding the issuance of municipal bonds for Eventide Jamestown LLC.

A public hearing was held on a resolution authorizing the issuance of senior housing revenue bonds on behalf of Eventide Jamestown LLC. No comments in opposition to the issuance were received or heard. Cichos made a motion, seconded by Gumke, to approve the requested resolution authorizing the issuance of senior housing revenue bonds. Roll call vote: Gumke, Schwartz, Cichos, Klose and Ova voted aye. Motion carried.

Funding for Stutsman County Museum sidewalk repairs were discussed by Alden Kollman. Historic timelines would be stamped into the sidewalk. Kollman requested \$4,000.00 from the Historical Society fund balance. Schwartz made a motion to approve the presented request of \$4,000.00, seconded by Ova. Roll call vote: Schwartz, Cichos, Klose, Ova and Gumke voted aye. Motion carried.

A motion not to join the opioid litigation was made by Ova, seconded by Gumke. Motion carried.

Schwartz made a motion, seconded by Gumke, to approve the Victim Witness Advocate Fair Labor Standards Act status change request from exempt to non-exempt. Motion carried.

Nicole Meland, Auditor/COO, discussed rural voting precincts for the 2020 election year. It has been difficult finding, keeping and training rural workers. Letters will be sent to the city auditors and district chairs regarding closure of the rural voting precincts.

At 4:40 p.m., the County Commission meeting recessed for the County Park Board Meeting.

Ova made a motion to approve the cabin lease transfers upon sale for cabins 45W and 65W, seconded by Schwartz. Motion carried.

Dean Alber, Pelican Point Concessionaire, presented electrical and campsite issues at Pelican Point campground.

Cichos made a motion to approve two electrical pedestal installations at Pelican Point, seconded by Gumke. Roll call vote: Morris, Houge, Ova, Gumke, Schwartz, Cichos and Klose. Motion carried.

At 5:28 p.m., Houge made a motion, seconded by Schwartz, to adjourn the Park Board Meeting.

At 5:28 p.m., the Commission meeting was called back to order.

The 2020 preliminary budget discussion was presented by Meland.

A Special Budget Hearing was set to be held July 15, 2019 at 8:00 a.m. to discuss the preliminary budget.

A motion to approve the presented special event permit for the Hitchin' Post was made by Schwartz, seconded by Ova. Motion carried.

Ova made a motion to approve the monthly bills, seconded by Schwartz. Ova, Gumke, Schwartz, Cichos, and Klose voted aye. Motion carried.
