

Official Proceedings of the Stutsman County Commission

July 5, 2011

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

Jacki Lindell, Interim County Treasurer, introduced Lindsay Baumgartner, the new Special Deputy Treasurer to the Commission.

Schwartz made a motion seconded by Marks to approve the minutes of the June 2011 meetings. Motion carried.

Connie Ova, CEO-JSDC, presented the 2011 draft budget for JSDC. The budget requested an increase in County tax dollars from \$78,000 to \$82,000. The overall expenditure budget was increased by 3% plus a \$9,000 new line item to fund interns from Jamestown College. Marks made a motion seconded by Schwartz to approve the 2011 JSDC budget. Commissioner Ova declared a potential conflict of interest. Roll call vote – Marks, Schwartz, Neys and Klose voted aye.

Steve Thompson, Interstate Engineering, provided a list of locations on the County major collectors that were under water. Twenty-four sites were identified as potential sites for Emergency Relief (ER) projects. Federal Highway rejected a few of the sites and several more were withdrawn – some of these sites could be completed by the County Highway Department and/or completed by private contractors. Twelve sites were recommended as ER projects. These sites needed be completed by September 18<sup>th</sup> to qualify for 100% reimbursement. The cost estimate for these sites was \$2.5 million for temporary emergency work and an additional \$5.0 million for permanent restoration. The temporary work was 100% reimbursed by Federal Highway – the permanent work was 80% Federal Highway and 20% County funds. Noel Johnson, County COO, pointed out that all costs for the temporary work would be paid by the County and reimbursed by Federal Highway through ND DOT. The reimbursement could take several years. The County had about \$3.5 million available for the projects, but the County could have liquidity problems in the future waiting for the reimbursements. Marks made a motion seconded by Neys to submit the twelve 2011 ER projects to ND DOT for their approval. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye. Ova made a motion seconded by Schwartz to authorize Interstate Engineering to obtain quotes for and to proceed with contracts for the temporary emergency work projects. It was discussed that if there was a significant difference in project estimates and/or requirements another meeting would be necessary before proceeding. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye.

The States Attorney’s monthly report was acknowledged and filed.

Josh Smaage, County Network Administrator, introduced Chris Heaney, the new IT Assistant to the Commission.

At 4:42 p.m., the Commission meeting was recessed for the Park Board meeting.

Stutsman County Park Board Meeting

July 5, 2011

At 5:00 p.m. Chairman Klose called the Stutsman County Park Board meeting to order. Park Board members present were Dennis Ova, Dale Marks, David Schwartz, Craig Neys, Mark Klose, and Bob Woodward. Mark Schlecht was absent.

Woodward made a motion seconded by Ova to approve the June 7, 2011 minutes. Motion carried.

Ova made a motion seconded by Woodward to pay the following bills. Roll call vote – Woodward, Ova, Marks, Schwartz, Neys and Klose voted aye.

Ron Qual requested release of the budgeted funds for the access roads to the Jamestown Reservoir cabins. Three projects had been identified for the funds - repair the low spot north of Lot 38 West side, gravel approximately 600 feet of the North End of Cabin Area C and gravel the high water access approach to the south cabins on the west side. Woodward made a motion seconded by Schwartz to authorize funds not to exceed \$10,000 for these projects. Roll call vote – Ova, Marks, Schwartz, Neys, Klose and Woodward voted aye.

Sandy Eckelberg, Accounts and Property Coordinator, reviewed the Operation and Maintenance Agreement between the Park Board and the Bureau of Reclamation. The sole source contract outlined hourly rates and quantities for services that the Park Board employees performed for the Bureau of Reclamation – (gate changes, mowing, weed spraying, etc.). Hours for various duties had been estimated based on prior years and forced accounting rates had been developed. Ova made a motion seconded by Schwartz to approve the one year contract. Roll call vote – Marks, Schwartz, Neys, Klose, Woodward and Ova voted aye.

Dennis Lorenz, County Park Superintendent, presented plans and specifications for installing rural water at Pelican Point Landing. The Bureau of Reclamation had funds to pay for half of the estimated \$80,000 cost. Nick Grosulak, Smokey’s Campground and Services, Inc., was asked to participate in the cost considering the water line would run past his campground. Geneva Kaiser, Manager of Stutsman Rural Water District, commented that she had recently received confirmation that Rural Water would be receiving grant money (\$6.80 million) next year to do about a \$9.0 million project. The money would be used to install rural water in the area around and including the Pelican Point Campground next year.

Consensus of the Board was to wait for Rural Water to install the line next year and to request funds from the Bureau of Reclamation to be re-appropriated for a new bath house at the campground.

Gene Van Eeckhout, ND Game & Fish Department, inquired about NDIRF insurance coverage for a boat dock owned by the Medina Sportsman Club. The County’s insurance carrier would not provide coverage without a written agreement. Mr. Van Eeckhout would try and get a copy of an agreement that the County could use to develop an agreement so that the club could get insurance coverage.

Lorenz gave his monthly report. The road at the Ypsilanti Park was being torn up due to high water. The County Park crew would assist with cleaning up the Park when the water levels were back to normal. The cabins at Pelican Point Landing had not been moved back pending the areas drying up permanently. Since the cabins needed to be moved every year to avoid high water, Lorenz suggested relocating the cabins. Many boat docks had not been put in because of the high water levels and some docks may not be put in as the water levels would remain too high until this fall. Sewage holding tanks at the Grosulak campground above Pelican Point campground were being pumped and draining through Pelican Point campground. Authorities had been notified. Neys asked if all septic systems on the east side of the Reservoir were in compliance. It was reported that all of the lots were originally approved.

A motion was made by Ova seconded by Woodward to adjourn. At 5:51 p.m. the County Park Board meeting was adjourned.

At 5:52 p.m., the regular Commission meeting was called back to order with all Commissioners present.

A motion was made by Marks seconded by Neys to approve the bills for payment. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye.
