

Official Proceedings of the Stutsman County Commission – July 6, 2021

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris, Steven Cichos, and Mark Klose answered the roll call.

Cichos made a motion, seconded by Morris, to approve the minutes of the June 2021 meetings. Motion carried.

Tyler Perleberg, Tax Director, presented an omitted property assessment. One parcel did not qualify for the farm residence exemption, so it was assessed after the township equalization meeting. Morris made a motion to approve, seconded by Ova. Ova, Gumke, Morris, Cichos, and Klose voted aye. Motion carried.

Perleberg discussed a promotion for Staff Assessor Chad Warner. He has met the requirements for the promotion to Assessor II to increase from Grade 11 to Grade 12. Cichos made a motion to approve, seconded by Gumke. Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion carried.

Corry Shevlin, JSDC, discussed additional funding for the FlexPACE program. The JSDC board voted to fund the program up to \$1,000,000 for 2021, which would be an additional \$144,000 from the county. They also made some changes to the application process and voted to cap the funding at 500,000 for next year. Gumke made a motion to approve the additional funding, seconded by Ova. Morris, Cichos, Klose, Ova, and Gumke voted aye. Motion carried.

Shevlin also discussed de-obligating funds from the Airport Business Park that were not used. The total balance for county funds that will be de-obligated is \$106,557. Morris made a motion to approve, seconded by Cichos. Motion carried.

Mickey Nenow, Highway Superintendent, presented two quotes for a guardrail repair west of Medina. Custom Contracting Solutions quoted \$8,685 and 3D Specialties quoted \$6,887. He would like to award the bid to 3D Specialties. Cichos made a motion to approve, seconded by Ova. Cichos, Klose, Ova, Gumke, and Morris voted aye. Motion carried.

Shannon Larson, Human Resource Director, discussed the 2022 Health Insurance Premiums. NDPHIT has said that they are looking at a 0% increase, but the budget will include a 3% increase just in case.

Tom VonBische from NextEra Energy Resources discussed a potential wind farm in Stutsman County. This wind farm would be in southern Stutsman County and LaMoure County. They have 128 wind farms across the United States and 15 in North Dakota. They are in the process of talking to land owners and he wanted to introduce himself to the Commission and answer any questions.

At 4:02 p.m., the County Commission meeting recessed for the County Park Board Meeting.

At 4:02 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris, Steven Cichos, Mark Klose, Jason Houge, and Robert Martin answered the roll call.

Jessica Alonge, Interim Auditor/COO, discussed a Special Use Permit from the Bureau of Reclamation. This would replace the current land management agreement. It is regarding the shared areas that the Bureau kept and the Park Board has been maintaining. Joan Morris and Bob Martin questioned some of the areas that were included on the map. Martin would also like to clarify who gets to keep the profit from the hay land that is included. Klose would like to hold a meeting with the Bureau of Reclamation to discuss further.

Karl Bergh, Park Superintendent, discussed closing a road in the park in the Farmer’s Union camp to car traffic. Cichos would like to go out and look at the area and discuss it again at the next meeting.

A pre-approval for a dock permit and placement of dock was discussed for Aaron & Tamera Johnson. Their property is directly above the public boat access at Five Mile corner on the East side of the Reservoir. They have spoken with Karl Bergh, Jason Houge, and Sherriff Kaiser and have selected a location for the dock. They might not install a dock this year but wanted a spot approved. Cichos made a motion to approve the placement, seconded by Ova. Motion carried.

Jamestown Reservoir dock permits for Severson and Mathison were presented. Morris made a motion to approve, seconded by Martin. Motion carried.

A project application for Cabin 24W (Mooridian) was presented. The issue was tabled until the next meeting.

Houge made a motion to approve the monthly bills, seconded by Cichos. Klose, Martin, Houge, Ova, Gumke, Morris, and Cichos voted aye. Motion carried.

departments. The initial cost for the equipment will be approximately \$7,000 and a yearly cost after that of \$4,000. Cichos made a motion to approve the purchase, seconded by Morris. Ova, Gumke, Morris, Cichos, and Klose voted aye. Motion carried.

Ova made a motion to approve the monthly bills and taxable meals, seconded by Cichos. Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion carried.
