At 4:00 p.m. the regular monthly meeting of the Stutsman County Commission was called to order by Chairman Klose. Roll call was answered by Douglas Kaiser, Craig Neys, Dennis Ova, Dale Marks, and Mark T. Klose.

A motion to approve the minutes of the June meetings was made by Kaiser and seconded by Ova. Motion carried.

Jan Thompson, County Treasurer, presented the depositories/pledge of securities as follows: Bank Forward - \$5,018,000.00/\$6,080,202.78; First Community Credit Union - \$250,000.00/\$298,000.00; Northland Financial - \$90,000.00/\$100,000.00; Unison Bank - \$1,787,876.78/\$2,349,716.96; US Bank - \$614,359.25/\$2,999,119.17; Wells Fargo Bank NA - \$2,917,780.48/\$6,909,811.17. A motion was made by Ova and seconded by Marks to approve the depositories/pledge of securities. Roll call vote - Ova, Marks, Kaiser, Neys and Klose all voted aye.

Randy Jones requested signs prohibiting Jake Brake usage on the road that connected the sales barn to the 281 by-pass. He lived along the road and worked nights. Truckers were using their Jake Brakes unnecessarily - it was not a safety issue. He had driven over the road for 28 years and knew that Jake Brake usage was unnecessary. Other states had signs and penalties for using the Jake Brakes in certain areas. Merle Weatherly spoke on the usage of Jake Brakes on the same road leading west from the by-pass towards the Peavey Elevator. The road was flat so Jake Brake usage was not necessary. Marks made a motion that was seconded by Neys to place signs according to the Uniform Traffic Control standards prohibiting Jake Brake usage along the east- and west-bound roads off of the by-pass. Motion carried.

Mike Zimmerman, County Highway Superintendent, gave his monthly report. Crews were busy chip sealing and graveling township roads. Governor Hoeven had requested a Presidential disaster declaration that would free up federal funding for roads damaged by the high water. Federal funds would pay for 75% of the cost to repair the township roads. No word yet on ER (Emergency Relief) funds for the flooded county roads. He would contact ND Department of Transportation (DOT) about the funding and get cost estimates for going around the flooded basin just south of Cleveland on County Highway 67 and estimates for raising the existing grade.

Fritz Fremgen, State's Attorney, presented his monthly report. He requested out-of-state travel for Assistant State's Attorney, Troy LeFevre, to attend a training conference in Columbia, South Carolina. The cost for the travel was within the Department's budget. Mr. LeFevre had received a tuition scholarship. Ova made a motion that was seconded by Marks to approve \$700 for the out-of-state travel. Roll call vote - Marks, Kaiser, Neys, Klose and Ova all vote aye.

A motion was made by Kaiser and seconded by Neys to cancel \$176.56 in consolidated taxes on City of Courtenay's parcel #'s 70-9700140 and 70-9700160. Motion carried.

Kaiser made a motion that was seconded by Neys to appoint Alice Pekarski to the School Reorganization Committee. Roll call vote: Kaiser - aye, Neys - aye, Klose - aye, Ova - aye, Marks - Nay. Motion carried.

A motion was made by Neys and seconded by Ova to increase the mileage re-imbursement rate from \$0.41 to \$0.45 per legislative mandate. Motion carried.

Linda Chadduck, Deputy County Auditor/MIS Director, presented a request to purchase a new AS400 mini-mainframe computer. The current computer was 8 years old and could no longer be supported or up-dated. The Data Processing Department (DP) had budgeted \$25,000 annually for computer updates. Most of the money was not spent, but banked for future larger purchases. The projected 2007 year end balance in the DP fund after the projected \$57,512 cost was \$45,723. A motion was made by Kaiser and seconded by Neys to purchase the computer including the appropriate software. Roll call vote - Neys, Klose, Ova, Marks and Kaiser all voted aye.

Ova made a motion that was seconded by Kaiser to approve the following permits: Raffle Permits - Windsor 125<sup>th</sup> Anniversary and Ypsilanti Community Club; Bingo and Raffle Permit - Spiritwood Betterment Club; and Special Event Permit - Anchor Bar at the Fair Grounds. Motion carried.

Nellie Degen, Jamestown Reservoir cabin owner, thanked Commissioner Ova for his efforts in getting Central Valley Health to do the sewer inspections at the Reservoir.

Mike Zimmerman returned to give cost estimates for the grade raises on County Highway 67 south of Cleveland. The estimated cost to raise the existing grade was \$454,740, and the estimated cost to go

around the basin wetland was \$624,590. Commissioner's Marks and Kaiser would review the options and make a recommendation at the next commission meeting.

The next Commission meeting would be July 24, 2007 at 8:00 a.m.

At 4:57 p.m. the Commission meeting was recessed for the Park Board meeting.

July 1, 2007 had been the target date for completion of the sewer inspections. Central Valley Health (CVH) was unable to meet the target date. Jim Michael, Environmental Health Practitioner for CVH, indicated that he could complete the inspections by the next Board meeting. He indicated that about 12 people had not contacted him for appointments. A motion was made by Marks and seconded by Kaiser to extend the inspection and reporting requirements to August 7, 2007 and to send certified letters to all individuals that had not contacted Mr. Michael informing them of the deadline and the sewer inspection requirements of the permit. Motion carried.

Jack Uehran, Owner of Shady Grove Campgrounds at Spiritwood Lake, indicated to the Board that his offer to convey his campground and dwelling to the Park Board for \$75,000 still stood. He requested more time to work out the details, and that he had some suggested solutions for some of the issues with the campground. He requested support from the Board regarding a zoning issue with the City of Spiritwood Lake. The City was mandating that he remove three campers located on the Lake as they were not in compliance with City Zoning. Mr. Uehran indicated that there were other campers in violation. He was informed that the Park Board had no jurisdiction regarding zoning issues within the incorporated city. Park Board member Schlecht would attend the City Council meeting on behalf of the Board.

Nellie Degen, cabin owner at the Reservoir, thanked the Board for clarifying the septic system extension and requested that the letter to the permit holders indicate that the sewer inspection is a requirement to comply with the permit and that it does not change the status of year around or seasonal permits.

Dennis Lorenz, County Park Superintendent, gave his monthly report. Pelican Point Landing had some electrical issues in the portion of the campground that had not been updated. Those issues would be abated this fall when the system was updated. The campground had some wash outs from drainage due to the high moisture. Two new vault toilets would be installed at the Reservoir - one south of the ND Game & Fish building and one south of the marina. The Bureau of Reclamation was paying for the toilets. The Park Board's cost share would be the excavation and concrete. The CAST (Catch a Special Thrill) had over seventy participants. Four wheelers and golf carts at Pelican Point Landing were causing some problems on the section line road between Smokey's Campground and Pelican Point Campground. The problems included underage drivers and golf carts without headlights or taillights. Board member Schlecht suggested handing out the rules for these vehicles to the campers when they entered the campground.

Mr. Lorenz requested permission to purchase a used loader. The 2006 John Deere 5325 with loader and front wheel assist was priced at \$30,000 less \$4,000 trade. The item was not in his budget. Jamestown Implement Company would go down to \$29,000 and provide rear wheel weights and chloride with tubes, if necessary. Kaiser made a motion that was seconded by Schlecht to purchase the loader for \$29,000. Roll call vote - Marks, Kaiser, Neys, Klose, Schlecht and Ova all voted aye.

Carol Kelly, property owner in Gray Lots of Spiritwood Lake City, shared a problem with the Board that she is having regarding the location of her surveyed lot lines compared to her assumed lot lines. She requested that the Board consider selling her a portion of the Park Board's adjacent property or enter into some type of a lease so she can build on the property. The acquisition documents would be reviewed to see if there were any deed restrictions when the county acquired the property.

A motion to adjourn was made by Neys and seconded by Ova. At 6:23 p.m. the July 10, 2007 County Park Board meeting was adjourned.

At 6:24 p.m. the Stutsman County Commission meeting was called back to order with all Commissioners present.

Neys made a motion that was seconded by Kaiser to pay the monthly bills. Roll call vote - Klose, Ova, Marks, Kaiser and Neys voted aye.
