Official Proceedings of the Stutsman County Commission – July 10th, 2012

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered the roll call.

Neys made a motion, seconded by Schwartz to approve the minutes of the June 2012 meetings. Motion Carried.

Chad Kaiser, Stutsman County Sheriff, informed the commissioners that Jason Falk's Ford Expedition was up for trade. RM Stoudt submitted a proposal for a 2011 Ford Expedition with 13,000 miles on it for \$22,450.00; a new Ford Expedition with a trade in would cost \$35,500.00. Don Wilhelm's would not give a price on a used vehicle because a new suburban would come in cheaper than a used vehicle. The Sheriff's Department purchased a 2012 Suburban from Don Wilhelm's for \$22,945.41. There is money in the budget for this purchase. This fall, the Sheriff's Department will have bidding for a pickup. Brad Kapp retired last month and the Sheriff's Department advertised for an officer in the drug task force department. They received many applications. The Sheriff's Department has eight interviews scheduled starting next Wednesday. Ova made a motion, seconded by Schwartz to approve the purchase of a 2012 Suburban from Don Wilhelm's. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Schwartz made a motion, seconded by Ova to approve Troy LeFevre, Teresa Steele, Warren Tobin, and Robin Harrington as re-appointments and Gwen DuBord as a new appointment to the Wage and Benefit Committee. Motion Carried.

Ova made a motion, seconded by Marks to approve the application for a local raffle permit for the Teresa Steele Benefit. Motion Carried.

Neys made a motion, seconded by Schwartz to approve the application for a local raffle permit for the Jamestown Regional Medical Center Foundation. Motion Carried.

Dustin Bakken, Zoning Administrator, requested a conditional use permit for feedlot expansion for Brandon Schlecht, Section 20 of Peterson Township. Brandon Schlecht has been approved by the NRCS, the Department of Health, and had an engineered site plan developed. The planning and zoning committee met on June 26<sup>th</sup>, 2012 and reviewed the setback requirements. All of the landowners and townships were notified according to the zoning ordinance. It is the recommendation of the planning and zoning committee to approve his application of his conditional use permit. Ova made a motion, seconded by Marks to approve the request as presented. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Dustin Bakken, Interim Tax Director, requested approval for out of state travel for Tyler Perleberg, appraiser, for the South Dakota Annual Assessor's School in Pierre, South Dakota. Schwartz made a motion, seconded by Marks to approve the out of state travel request. Motion Carried.

Marks made a motion, seconded by Ova to approve the request for enrollment in the online appraisal course for educational credit towards certification for Dustin. Motion Carried.

Mickey Nenow, County Highway Superintendent, requested to hire two part-time seasonal employees. Schwartz made a motion, seconded by Marks to approve the request as presented. Motion Carried.

Ova made a motion, seconded by Schwartz to approve the road department employees overtime and work a few Fridays in order to get caught up with chipping and graveling. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Mickey requested approval to pay RTS Shearing \$123,931.15 for a progress estimate on the Stink Lake project. Stutsman County did receive the money from FEMA. The work has been done. Schwartz made a motion, seconded by Marks to approve the request for payment. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Casey Bradley, Auditor/COO, requested approval to hire Noel Johnson on an hourly basis of \$75.00 to negotiate acquisitions and appraisals for the GRE Project. GRE will pick up all cost if the project doesn't go forward. Ova made a motion, seconded by Schwartz to approve the request as presented. Motion Carried.

The North Dakota Association of Counties (NDACO) and North Dakota County Commissioners Association (NDCCA) will be in Stutsman County for a 2012 Presidents' Tour of the courthouse facility on Thursday, July 26, 2012 at 10:30 a.m. The purpose of the tour is to increase communication among county officials, NDACO and NDCCA and to answer any questions the county has about the services and programs the organizations provide. Dennis Ova, Dale Marks, and Mark Klose will be available for the tour.

The NDACO Annual Conference will be held October 7-10 at the Bismarck Ramkota Hotel. Dennis Ova, Dale Marks, Craig Neys, and Dave Schwartz will be attending the conference.

Bid Opening for Lowery Township Site six were opened. The bids were as follows: R.J. Zavaral & Sons, East Grand Forks, MN, \$397,000.00; GrayTech LTD, Berthold, ND, \$541,556.85; Guthmiller Earthmoving, Medina, ND, \$352,784.00. The bids will be turned over to Lowery Township for their recommendation.

Todd Volk, Assistant 9-1-1 Coordinator/Emergency Manager, updated the board on the 9-1-1 equipment purchase process. The request for bids process has been finished. The information is posted on Richland County and Stutsman County's website. The bid is due on July 16<sup>th</sup> with the bid opening on August 7<sup>th</sup>, 2012 and a completion date of December 20, 2012. An addendum was posted on the websites and sent to our bidders. There were two requests for an extension. Both requests have been denied because the company does not have a product that would meet bid specifications.

Todd updated the board on the second long distance outage and its effect on the 9-1-1 services. The second outage occurred less than 10 days after the first long distance outage. The cables were severed when the farmer was working in his field. The cables were not buried yet by CenturyLink. The outage

lasted approximately for four hours. The State of ND IT Department has allocated funds and will be surveying communication centers in North Dakota to help maximize the redundant 9-1-1 connections so the outages do not occur.

Todd informed the board of the Homeland Security Radio Narrow Banding Grant Extension. The FCC approved the radio licenses for the Sheriff's Department the last week of June. Stutsman County had to request an extension from the state DES to July 10<sup>th</sup>, 2012. All work for the grant was completed as of July 10<sup>th</sup>, 2012. It was a 93% federal grant with a 7% local match. The total cost of the project was \$60,730.00 with the federal portion was \$56,478.90 and the local match was \$4,251.10.

Todd presented information regarding a meeting that Casey Bradley and Jerry Bergquist had with Barnes County/Valley City Officials. Barnes County and Valley City officials inquired about the joint agreement that is between Richland County and Stutsman County on the 911 equipment. Barnes County and Valley City have a long way to go in order for them to be compatible.

Steve Thompson, Interstate Engineering, requested approval of project concept reports for the following: J11-00-171, Spiritwood North, CER-4745(058);J11-00-172, Cleveland South 3, CER-4717(086);J11-00-173, Gefroh, CER-4717(087);J11-00-174, S of 38 (1), CER-4717(088); J11-00-175, S of 38(2), CER-4717(089); J11-00-178, west side Streeter, CER-4746(054); J11-00-179, 3 west of Streeter, CER-4746(055); J11-00-180, 1 North of Gackle, CER-4717(091). These projects are grade raises from the 2011 event. The projects have three choices: to do nothing, grade raise, or a realignment. The cost are as follows: CER-4745(058) \$671,000 for a grade raise or \$694,000 for a realignment; CER-4717(086) \$1.316 million for a grade raise or \$1.345 million for a realignment; CER-4717(087) \$1.479 million for a grade raise or \$1.495 million for a realignment; CER-4717(089) \$614,000 for a grade raise or \$651,000 for a realignment; CER-4717(091) \$838,000 for a grade raise or \$894,000 for a realignment. Schwartz recommended pulling out and tabling CER-4746(054) and CER-4746(055). These project concept reports would be an 80%/20% share. Stutsman County's share would be approximately \$1.2 million dollars. It is the consensus of the board to table these project concept reports until the next meeting so the board can have an opportunity to review each alternative as well as explore other options that may have not been presented.

It is the consensus of the Stutsman County Commission Board to change the meeting time on July 17<sup>th</sup>, 2012 to the following Tuesday, July 24<sup>th</sup>, 2012.

At 5:00 p.m., the Stutsman County recessed for the County Park Board Meeting.

Dennis Lorenz, Stutsman County Park Superintendent, presented his monthly report. The Bureau of Reclamation's engineers drafted a new camping area at Pelican Point Landing. In this draft, Pelican Point Landing would lose four existing camping pads to build a new road. At the top of the hill, an additional 15 camping pads, a fish cleaning station, and bathrooms would be added. The placement of the road would still provide access to the campground in the event of a flood. The Bureau of Reclamation would get a cost estimate of the approved plan for Stutsman County. Ova made a motion, seconded by Woodward to approve the Bureau of Reclamation's draft of Pelican Point Landing as presented.

Stutsman County Rural Water will start laying pipe. The pipe will be placed on the west side of the road and will run up the hill to Pelican Point Landing. Rural water will bore under the road. It will be four to six weeks before the rural water will be turned on at Pelican Point Landing.

The Dakota helicopter out of Beulah is in town and will begin spraying later this week.

There have been some complaints about the use of ATV's and golf carts at the campgrounds. It is the consensus of the Park Board to put signage up for a noise ordinance and a speed limit.

Neys mentioned the old dock at Pelican Point is in bad shape. It is the consensus of the board to block off the old dock or take it out. Lorenz will get an estimate to take the old dock out.

Schlecht mentioned that there are a lot of weeds on the CRP land at Spiritwood Park. It is the consensus of the board to contact the operator of the CRP to have them spray for weeds. Two issues regarding Sandy Beach were brought up. There is rebar sticking up on the old foundation near the

beach and sand needs to be hauled in to make a beach. It is the consensus of the board to get estimates.

It is the consensus of the board to visit with Ted Steckler regarding the having and spraying of weeds.

At 5:52 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Marks, seconded by Ova. Motion Carried.

At 5:52 p.m., the Stutsman County Commission Meeting reconvened.

Marks made a motion, seconded by Neys to approve the bills for payment. Roll call vote: Klose, Ova, Marks, Schwartz, Neys voted aye.
