

Official Proceedings of the Stutsman County Commission – July 16, 2019

At 4:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dave Schwartz, Steve Cichos, and Mark Klose answered the roll call. Ramone Gumke was absent.

Holden Syverson requested putting his \$0.25 candy machine in the Law Enforcement Center. Chad Kaiser, Stutsman County Sheriff, approved allowing this request and placing it in the lobby. Ova made a motion, seconded by Schwartz, to allow the candy machine. A Hold Harmless contract will be signed. Motion carried.

Nicole Meland, Auditor/COO, presented additional 2018 budget amendments. Cichos made a motion to approve the presented amendments, seconded by Ova. Motion carried.

Preliminary budget and salary discussions were held.

Another preliminary budget meeting was set for Tuesday, July 23, 2019 at 8:00 a.m. in the commission room.

A request to approve the South Central Dakota Regional Council 2020 dues was made by Jamestown Stutsman Development Corp (JSDC). Cichos made a motion, seconded by Ova, to approve the presented request. Roll call vote: Cichos, Klose, Ova and Schwartz voted aye. Motion carried.

Connie Ova, Director of JSDC, requested funding for the Train ND Program. A motion to approve this request was made by Schwartz, seconded by Ova. Roll call: Klose, Ova, Schwartz and Cichos voted aye. Motion carried.

Cichos made a motion, seconded by Ova, to approve the taxable meals and bills. Roll call vote: Ova, Schwartz, Cichos and Klose voted aye. Motion carried.
