

Official Proceedings of the Stutsman County Commission

July 20, 2010

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys, and Mark T. Klose answered roll call.

Jerry Brickner, Road Recycling Project Manager, updated the Commission on the recycling of County Road 40 (Old Highway 10). The recycling was completed last week. The work took longer than anticipated due to pavement depth of 7 to 15 inches. They were working out the irregularities in the road surface from differential compaction – work should be completed this week. A cost analysis will be completed and provided to the Commission to assist with budgeting for future projects.

Jan Thompson, County Treasurer, presented the pledge of securities as follows: (Institutions, total deposits, and securities pledged) Bank Forward, \$1,611,691.62, \$1,749,823.65; First Community Credit Union, \$4,850,000.00, \$5,425,000.00; Gate City, \$225,500.00, \$250,000.00; Northland Financial, \$240,000.00, \$250,000.00; Unison Bank, \$2,753,836.95, \$3,095,025.90; U S Bank, \$790,002.99, \$1,852,359.36; Wells Fargo Bank NA, \$2,199,154.38, \$3,839,425.90. Ova made a motion seconded by Kaiser to accept the pledge of securities as presented. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Thompson presented a letter of resignation effective January 1, 2011. She was retiring after 25 ½ years of employment with the County. The Commission expressed their gratitude for her many years of service.

Neys made a motion seconded by Marks to approve the County Road Mileage Certification of 1,747 miles of organized township roads and 40 miles of unorganized township roads. Motion carried.

Noel Johnson, County COO, presented a draft policy for considering applications for using the County’s allocation of Recovery Zone Facility Bonds (RZFBs). The policy was tabled pending review and comment by JSDC.

A motion was made by Marks seconded by Neys to make the following membership changes to the LEPC (Local Emergency Planning Committee): Spencer Johnson, Deanna Van Bruggen, Lt. Mitcheal Brecto, John DeVary, Tom Lindberg, Brenton Nesemeier, and Todd Volk to replace LeAnne Hayes, Major Harold Baugh, Eugenie Lang, Ray Martinez and Jack Parisien. Motion carried.

Ova made a motion seconded by Kaiser to approve the beer license application of Famous Dave’s restaurant at Gavilon Grain, LLC in Midway Township. Motion carried.

Commissioner Marks commented on the need to get another road funding issue on the ballot. Consideration was being given to a similar measure as the June primary election with a provision to share some of the funding with Townships. Commissioner Klose questioned what would be in it for the small cities and Jamestown. Johnson indicated that any measure would need to be ready for the ballot by mid to late August.

Kaiser made a motion seconded by Neys to approve \$210.00 in taxable meals. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

A motion was made by Marks seconded by Ova to pay the mid-month bills. Roll call vote – Kaiser, Neys, Klose, Ova and Marks voted aye.
