At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Mark T. Klose, Craig Neys, Dale Marks, and David Schwartz answered the roll call. Dennis Ova is absent.

Robert Toso, Jamestown/Stutsman Development Corporation (JSDC) presented the JSDC 2016 Budget. The JSDC 2016 budget was adjusted to a three percent salary increase with the remaining items staying at the original five percent. The levy is capped at a three percent increase. Schwartz made a motion, seconded by Neys to approve the 2016 JSDC budget as presented. Roll call vote: Marks, Schwartz, Neys, and Klose voted aye. JSDC will need to submit a full line item budget to Stutsman County.

Toso presented a request from Bechtel asking for a shortened lease at the JSDC Building. Bechtel would like to lease the space at JSDC; however, they would like to have the option to renew 1/1/2016 to ensure they actually have the CHS contract and that the office space is the correct location for them instead of at the project site. Bechtel is the management company who is building the fertilizer plant at Spiritwood. Neys made a motion, seconded by Marks to approve the shortened lease request from Bechtel as presented. Motion carried.

Bechtel is requesting to choose 80 acre parcel in JSDC 320 Section 28 at Spiritwood Township with final approval by JSDC Executive Committee. There were some issues with easements from Rural Water, WBI gas line, and the WAPA power line; and Bechtel wants to move the crew camp to a better area. JSDC's only concern is to make sure it is in a corner where it doesn't take up to much space. Schwartz made a motion, seconded by Marks to approve the request as presented. Motion carried.

Jamestown/Stutsman Development Corporation is requesting to rezone the JSDC Spiritwood Township property at the E1/2 of Section 28, Township 140, Range 62 from agricultural to industrial. Marks made a motion, seconded by Neys to approve the rezoning request as presented. Motion carried.

Chad Kaiser, Sheriff, presented monthly report to the commissioners. Brian Davis has been hired for the Sheriff Deputy position. He came from the City of Jamestown Police Department and started July 1, 2015.

Jeff Fuchs, City of Jamestown Administrator, submitted a request for a letter of support for an extension of the renaissance zone for the City of Jamestown. The renaissance zone program expires in August of this year and the NDCC 40-63-03.1 allows a city to request to extend the duration of the renaissance zone status in five year increments. This is an extension to continue with the current renaissance zone program. Neys made a motion, seconded by Schwartz to approve writing a letter of support for the extension of the renaissance zone as presented. Motion Carried.

Casey Bradley, Auditor/COO, informed the commissioners the Jail Committee will be meeting at 10:00 a.m. today. The committee will present the Request for Proposal (RFP) for architectural services. At the last jail committee meeting the Inmate Roster is the most popular link on the Stutsman County website. The link is updated every 15 minutes and has the total population of the inmates at the bottom of the pages. The committee will review the RFP and if the committee moves forward with this, it will be set up as a county contract. The committee will need to set up a budget. The cost for an analysis will be approximately \$50,000 -60,000. The committee will also look at cost sharing.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, is requesting approval of the draft Multi-Hazard Mitigation Plan. This has to be done in order to submit the draft to the State Department of Emergency Services for approval. Daniel Schwartz, Wenck, completed and presented the draft of the Multi-Hazard Mitigation Plan for Stutsman County to the commissioners. A public hearing for the plan was held last night. The plan is in a structured format and parts of the plan can be taken apart for each jurisdiction. After the State Department of Emergency Services approves the plan it will go to FEMA for final approval. Marks made a motion, seconded by Schwartz to approve the draft Multi-Hazard Mitigation Plan as presented. Motion Carried.

Auditor Bradley introduced David Bratton. He is our new Veteran Service Officer.

Marks made a motion, seconded by Neys to approve the taxable meals and mid-month bills. Roll Call vote: Schwartz, Neys, Klose, and Marks voted aye.
