At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call. Absent was Dennis Ova.

A motion to approve the minutes from the July meetings was made by Neys and seconded by Schwartz. Motion carried.

Toni Hible, County Tax Director, requested approval of out-of-state travel to attend an appraisal school the week of September 19, 2011 in Pierre, SD. Marks made a motion seconded by Schwartz to approve the travel request. Motion carried.

A motion to approve the site authorizations for the ND Buffalo Foundation at the Jamestown Country Club and at the Stutsman County Fair Grounds Beer Garden was made by Schwartz and seconded by Neys. Motion carried.

Quotes for the ER grade raise projects 47-1, 47-2, 47-3, 47-4, 47-8 and 47-9 were opened. Bidders bonds were reviewed and approved by State's Attorney Fritz Fremgen. Quotes were as follows: Guthmiller Earthmoving, Inc. -47-2 \$149,199.93; 47-8 \$487,425.98; 47-9 \$569,319.81; Lindberg Brothers Inc. -47-1 \$630,304.00; 47-4 \$679,363.00; 47-8 \$1,033,458.00. No bids were received for ER project 47-3. Steve Thompson, Interstate Engineering, stated that a couple of the bids were substantially over the estimates. Thompson said that he would visit with ND DOT regarding the bid quotes. September 18, 2011 was the ending date for 100% reimbursement for ER projects. After that date the projects become 80/20-20% County. Thompson would review the bids and come back into the meeting after the Park Board Meeting.

Clarence Daniel and Dale Van Erem, Representatives from Spiritwood Township and Doug Jacobson, Superintendent of Barnes County North School District were present for the new – expanding business property tax exemption hearing for a 60 million gallon corn based biorefinery in Spiritwood Township. A motion to waive the requirement of the competitive business notification was made by Marks and seconded by Schwartz. Motion carried. Noel Johnson, COO, reviewed the request from Dakota Spirit AgEnergy for a 10 year property tax exemption – years 1-6 (100%), year 7 (80%), year 8 (60%), year 9 (40%) and year 10 (20%). Klose asked how this request compared to the previous request from Newman Group. Johnson stated that it was very similar. Al Christianson, Director, Government Affairs for Dakota Spirit AgEnergy, stated that to make this business viable, his company needed to look at options that existed, and based on the County's favorable history for value added agriculture they felt this was an appropriate action to do. Mr. Jacobson questioned if Dakota Spirit AgEnergy had any experience with other counties, townships and/or school districts within the state and if it was consistent with other requests. Christianson stated that McLain County for Blue Flint Ethanol granted a 5 year exemption at 100% and said to come back for the second five years. The company also did a drying and storage facility in McLain County in 2010 which they allowed a 100%, 80%, 60%, 40% and 20% for approximately a \$3 million project. The estimate tax for the biorefinery was \$445,000 with approximate 55% to the school district, 30% to the County and 15% to the township. Marks noted the input the Great River Energy (Dakota Spirit AgEnergy) was putting into the County but questioned if it was time to pare back on granting incentives to large companies and that there was a lot of dollars that could be generated to help in road repair. Marks made a motion to allow the first three years at 100% with 4th year 90%, 5<sup>th</sup> year 80%, 6<sup>th</sup> year 70%, 7<sup>th</sup> year 60%, 8<sup>th</sup> year 50%, 9<sup>th</sup> year 40% and 10<sup>th</sup> year 30%. Schwartz seconded the motion. Christianson said that he understands where the commission was coming from and if it works out from a business standpoint they would proceed with it. Johnson said that the request worked out to be equivalent to an 8 year 100% exemption whereas the motion worked out to be about a 7.2 year 100% exemption – not a sizable difference. Roll call vote: Marks, Schwartz, Neys and Klose voted aye.

Christianson also reported that in a meeting with the Dept of Commerce that if the three miles of access roads to the Great River Energy's project were added to the federal aid system it would allow GRE access to safety funds for turning lanes and railroad crossing issues. ND DOT stated that the County would need to request the roads to be added to the system. Daniel, Spiritwood Township Chairman, stated that they had no problem with plowing snow and mowing weeds but would not be able to maintain the pavement in years to come. Mickey Nenow, County Highway Superintendent, would research the issue before further action was taken.

Nenow presented bills from RTS Shearing for emergency grade raises. Schwartz made a motion seconded by Marks to pay the bills of \$106,334.56 for the project 1/2 mile West of Streeter and \$89,778.36 for the project 3 miles West of Streeter both amount were less 10% of the total projects until the pit release agreements were received and to pay 30% (\$47,821.80) of the project total for work

completed on the project 3.5 miles South of Cleveland. Roll call vote: Schwartz, Neys, Klose and Marks voted aye.

Steve Thompson reviewed the quotes that were opened earlier in the meeting. Projects 47-1 quote \$630,304.00 (estimate was \$292,170.00); 47-2 corrected quote \$167,199.93 (estimate was \$138,435.00); 47-3 no bid; 47-4 corrected quote \$693,363.00 (estimate was \$317,652.00); 47-8 quote \$487,425.98 (estimate was \$456,172.00); and 47-9 quote \$569,319.81 (estimate was \$536,260.00). Thompson stated that reasonable bids were received for 47-2, 47-8 and 47-9 but 47-1 and 47-4 were high. He recommended awarding 47-2, 47-8 and 47-9 and hold off on 47-1 and 47-4 until they could discuss the bids with the DOT. Klose and Schwartz stated that they needed to know where the County was at for reimbursement before they would know what the County could afford to do. Schwartz thought that 47-2 could be awarded but 47-8 and 47-9 should hold off awarding until tomorrow. Johnson stated that these projects were 100% reimbursement but it was a matter of when reimbursement would be received. Johnson said that some of the 2009 money has started coming in and he would need to look at the cash situation but financially it was hard to turn away 100% money. Schwartz made a motion seconded by Marks to award 47-2, 47-8 and 47-9 to Guthmiller Earthmoving, Inc. Projects 47-1 and 47-4 would be reviewed at a special meeting on Wednesday, August 3 at 4:00 p.m. Roll call vote: Neys, Klose, Marks and Schwartz voted aye.

Fritz Fremgen, State's Attorney, reviewed his monthly report.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, presented changes to the Local Emergency Planning Committee. LEPC was recommending adding Lt. Teresa Brecto (The Salvation Army), Chad Kaiser (County Sheriff), Matthew Leitner and Randy Dullum (Jamestown Regional Airport), Amy Mayer (Regional Environmental Health Practitioner) and Rick Woehl (Jamestown Rural Fire Dept.) and to remove as members Deanna Van Bruggen, Lt. Mitcheal Brecto, David Orr, Andrew Schneider, Jim Dodd, Wayne Fylling and Brenton Nesemeier. Neys made a motion seconded by Schwartz to nominate the six individuals to the committee and to delete the old members. Motion carried.

Bergquist also presented a request for an on-site vulnerability assessment for the Law Enforcement Center and Courthouse by the Department of Emergency Services and the ND Fusion Center. The governing authority had given permission for the assessment to be completed at the LEC but since the two building are attached and connections to the two buildings it was suggested that the study be completed for the Courthouse too. The assessment is free with no obligations and would be a neutral perspective as to what our security issues were. Tracey Trapp stated that the after-hours entry was a concern at the LEC. The time required to complete the questionnaire was the only cost investment. Marks made a motion seconded by Neys to approve the on-site vulnerability assessment. Motion carried.

Mr. Bergquist presented mutual aid agreements that were required by FEMA if other resources were required from another county because of a catastrophic event. Nine counties included in the agreements were Cass, Burleigh, LaMoure, Foster, Barnes, Logan, Kidder, Wells and Griggs. Schwartz made a motion seconded by Neys to approve the mutual aid agreements with the nine counties. Roll call vote: Klose, Marks, Schwartz and Neys voted aye.

Bergquist showed the commission the water elevation charts of the two dams for the high elevation years. Both dams need to be down to base of the flood control pool by November 1. The corp does not want to increase the cfs over 1800.

Chad Kaiser, County Sheriff, requested permission to solicit bids for a new 2012 pickup as purchase, trade in or for sale and to receive quotes for a program car. Both vehicle purchases were included in the budget. Schwartz made a motion seconded by Neys to give permission to solicit bids for a pickup and quotes for a car. Motion carried.

Tracey Trapp, Law Enforcement Center Administrator, requested permission for out-of-state travel to attend the Bureau of Prisons Contractors Training Conference in Minneapolis from August 23 - 25, 2011. There was no cost for the conference other than mileage and lodging. A motion to allow the out-of-state travel was made by Schwartz and seconded by Neys. Motion carried.

At 5:26 p.m., the Commission meeting was recessed for the Park Board meeting.

Lorenz reported that water was coming into the reservoir faster than it was going out. They were down to two boat docks again because of the high water.

At 5:50 p.m., the regular Commission meeting was called back to order with all Commissioners except Ova present.
