At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Craig Neys, Doug Kaiser and Mark T. Klose answered roll call.

A motion was made by Ova seconded by Neys to approve the minutes of the July 2009 meetings. Motion carried.

Robin Iszler, Central Valley Health District Administrator, presented the 2010 budget for the Central Valley Health District. Also present was Marsha Bollingberg, Central Valley Health Director of Nursing. The revenue budget requested the same 5 mill levy as last year. Revenue and expense budgets increased from \$571,000 to \$685,000. The major revenue increases were revenue from program activities and additional state aid. The main expense increases were for one additional staff and increased employee medical insurance costs. Ova made a motion seconded by Kaiser to approve the budget. Roll call vote – Ova, Marks, Kaiser, Neys and Klose vote aye.

The hearing was held on the request by Jason Anderson to close approximately 425 feet of the section line between Section 34 and Section 35-T142N-R64W lying south of County Road 42. Certified mail had been sent to all adjacent land owners and township officers. No one appeared to protest. Mr. Anderson indicated that he planned on building within the section line and he had fenced off the line with no complaints from the neighbors. Access would still be available to all surrounding land. A motion was made by Marks seconded by Neys to approve the closing. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

Kaiser made a motion seconded by Ova to appoint Dr. Larry Johnson to a 5-year term as County Coroner. Motion carried.

Tracy Trapp, Law Enforcement Center Administrator, requested permission to attend the Bureau of Prisons conference in St. Louis. Kaiser made a motion that was seconded by Neys to approve the out-of-state travel request. Motion carried.

Jeff Klein, State NFIP Coordinator, presented information on the National Flood Insurance Program. The program required passing a flood plain management ordinance. The ordinance required monitoring and issuing permits within mapped flood plains. There was no flood plain mapping outside of Jamestown. There were no plans in the immediate future to map the County. Klose questioned whether or not bridges would have to be built to a higher standard within the flood plain. Klein commented that as of now, the county was not mapped so there were no additional requirements. Klose indicated that individual townships could enroll on their own to enable residents within their township to purchase flood insurance. Nellie Degen commented that townships did not have the staff or expertise to handle the program and that the townships were reluctant to take on the responsibility. Kaiser voiced his concerns that there were too many unknowns about the program and what would happen if the county was mapped. Terry Shaffer, Homer Township resident, commented that he had substantial damage to his home and he was unable to purchase flood insurance. A committee of Marks, Bergquist and Johnson would review the program and make a recommendation to the Commission on whether or not to participate.

Fritz Fremgen, State's Attorney, presented his monthly report and the overweight ordinance for county roads that was prepared in 2006. Adoption of the ordinance would require a public hearing similar to what was done in 2006. Kaiser commented that the ordinance was not to generate revenue – it would help to protect the roads that the county could not afford to maintain. Johnson recommended working with Sheriff Orr and budgeting for the potential costs. A committee of Marks, Kaiser, Johnson, Zimmerman, Fremgen and Orr would meet and bring back a recommendation.

Mike Zimmerman, County Highway Superintendent, reviewed the status of the flood damaged roads. Seventeen sites had been reviewed with an estimated cost of \$2.1 million. Steve Thompson, Interstate Engineering, estimated \$200,000 for engineering the Emergency Relief (ER) projects. The ER projects and engineering for the projects were eligible for 80/20 cost reimbursement – 20% County match. Marks made a motion seconded by Ova to submit the scope of work and engineer's summary for the ER projects as they were prepared to the Valley City ND DOT for their approval. Motion carried.

Zimmerman requested approval to repair the road south of Half-way Lake to allow one-lane traffic to get by for now at an estimated cost of \$3,000. Marks made a motion that was seconded by Kaiser to approve the repairs. Roll call vote – Kaiser, Neys, Klose, Ova and Marks voted aye.

At 5:41 p.m. the County Commission meeting was recessed for the County Park Board meeting.

At 5:46 p.m. Chairman Klose called the Stutsman County Park Board meeting to order. Park Board members present were Mark Schlecht, Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose. Bob Woodward was absent.

Schlecht made a motion that was seconded by Kaiser to approve the minutes from the July meeting. Motion carried.

A motion was made by Ova and seconded by Marks to approve the payment of the monthly bills. Roll call vote - Schlecht, Ova, Marks, Kaiser, Neys and Klose voted aye.

Lorenz had met with a FEMA representative at the Ypsilanti Park. Repair of the road and parking lot had been approved. He stated that he would apply to Game and Fish for assistance with a restroom building. He had visited with the Dakota Anglers and the Park Board could apply to them for the 25% cost share. Marks stated that he had gone to the Water Board and they seemed very receptive to paying for the fill to repair the washouts in the dam. He had received estimates to fill the washouts from Tony Roorda of approximately \$7,200 and from Scherbenske for about \$2,200. Marks would contact Ken Dalsted with the Water Board with the estimates.

Dennis Lorenz, County Park Superintendent, reviewed the 2010 budget. Over \$300,000 was budgeted for capitol improvement projects – almost all projects were to repair flood damage. The projects include a restroom at Ypsilanti Park, restroom replacement at the Marina, shelter repairs, paving the Marina parking lot, maintenance on cabin access roads, and a new concession building at Pelican Point Landing. Approximately \$190,000 would be spent yet this year on capitol projects. The revenue for the projects would come from grants through the Bureau of Reclamation, ND Game & Fish and Garrison Diversion. Dakota Anglers will be providing partial funding for several of the projects. The Board voiced their appreciation of the Dakota Anglers for their support of Park Board projects.

Lorenz reviewed the status of fixing the flood damage at the Marina and Pelican Point Landing. Estimates to move the road at the Reservoir so the Marina could be located on the road above its current location were \$150,000. The Bureau recommended using the existing parking lot. Pelican Point Landing was about ready to go for camping. The concessionaire was trying to find a temporary building to use for the remainder of the season. Plans and ideas for a new building would have to be developed. The campground committee would work on the plans for both campgrounds.

Mark Monek, representative of the Addiction Counselors Association, requested a special use permit for the Island at the Jamestown Reservoir for a sobriety walk sponsored by the local addiction counselors on September 16th or 17th. Ova made a motion seconded by Schlecht to approve the special use permit. Motion carried.

Rick McKay, cabin owner, requested gravel on the access road to the cabins south of the Agri-Cover road. Midway Township would review the request.

A motion to adjourn was made by Ova and seconded by Marks. At 6:31 p.m. the August 2009 County Park Board meeting was adjourned.

At 6:32 p.m. the regular Commission meeting was called back to order with all Commissioners present.

Neys made a motion seconded by Kaiser to approve the raffle permit of the Anne Carlsen Center. Motion carried.

A motion was made by Ova and seconded by Kaiser to approve a letter of support for the grant application of the Napoleon Municipal Airport Authority for runway reconstruction. Motion carried.

Nellie Degen requested the County participate in the National Flood Insurance Program. The townships couldn't or wouldn't participate. The county was the only recourse to enable residents to purchase flood insurance protection.

Marks made a motion that was seconded by Ova to approve payment of the monthly bills. Roll call vote - Neys, Klose, Ova, Marks and Kaiser voted aye.
