At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Mark T. Klose, Craig Neys, Dale Marks, Dennis Ova, and David Schwartz answered the roll call.

Robin Iszler presented the 2016 projected budget for Central Valley Health for Stutsman and Logan County. Maternal child health program usually generates around \$17,000 which helps fund school nursing and that program may be cut. There could be a possible \$56,000 funding from the city of Jamestown which is a 3% increase. State Aid from the State General Funds for services provided for public health. Budgeted \$795,000 for salaries and fringe benefits and have been eliminating part-time staff positions as they become vacant positions to cut down costs. They will be applying for grants to make up the deficit, doing better in Logan County with an increase in clients seen. IT staff member resigned in July, Central Valley Health is looking to either contract the work out or hire a replacement. Central Valley Health received National Health Accreditation status. Casey Bradley and the auditor from Logan County will have a meeting via phone to certify the budget as presented.

Connie Ova, JSDC, center for ED additional roofing request, the awnings were not part of the new roof that was just put on. The county share would be \$526 to add awnings to stop the windows from leaking and will also fix any rain damage that was incurred. Neys made a motion, seconded by Marks to approve to add awnings as part of the roofing project. All vote aye, motion carried.

Searle Swedlund, \$75,000 matched funds from the city annual request which funds numerous businesses and local events. Tourism Board is looking at prioritizing the list of projects that they currently have to yet complete. Ova made a motion, seconded by Schwartz to approve the annual funds request \$15,000 of the County's share. Roll call vote: Ova, Marks, Schwartz, Neys, and Klose vote aye. Motion carried.

Gwen DuBord, Accounts/Benefits Coordinator, presented the 2 year renewal with the Southeast Human Service Center which has remained the same with the Safebed program which takes care of kids when they have nowhere to go. Schwartz made a motion, seconded by Ova to approve the renewal of contract. All aye, motion carried.

Tyler Michel, Assistant Highway Superintendent, requested money that was budgeted to buy the Sheriff's department truck before totaled out for \$20,000 and place one of the older trucks onto a sale. Neys made a motion, Schwartz seconded to approve the request to purchase a newer truck. All aye, motion carried.

Jerry Bergquist, Emergency/9-1-1 Coordinator, requested acceptance of grant funds. Receive on an annual to buy down wages of Bergquist, Rita Morris and Sarah Van De Velde in the amount of \$63,437 which is less than last year. Ova made a motion, seconded by Marks to accept the grant as presented. All aye, motion carried.

Casey Bradley, initial budget for 2016, supplemental packet has a summary page with COLA and health insurance as one of the major changes. Mental Health and Juvenile Court will have to be increased. Non-departmental change is due to the fund changes and mill levy consolidations that have taken place. Communications staff moved to full-time and will now include over-time. IT budget request of an additional \$24,000 to buy down new epollbook surface tablets which will be tested at the JPS Special Election in September. Increase to \$110,826 for capital projects for the Park Department. Analysis of the 2016 will increase to 85% for Family and 95% for Single plan coverage for the county share of Health Premiums. Proposed mill levy with the 3% cap that was

placed which does include the state mill levy which by law is at 2 mills. Road and Bridge will be capped at the 10 mills but will be covered by transfers done from the General fund. Agency requests, the asterisk indicates which ones have not turned in their requests and supporting information. Jamestown Regional Airport would like to request an additional \$65,000 for capital improvements in addition to the capped 3 mills already. Set up an additional meeting an hour before the next scheduled commission meeting to discuss the request made by the Jamestown Regional Airport and State's Attorney Fritz Fremgen. Capital budget with the goal to get the property tax numbers in the years going forward to keep them relatively consistent by eliminating unnecessary budget requests made by departments. \$200,000 in revenues into the Corrections department, county share of the LEC will no longer be transferred but collected through property tax levy. 15% decrease in transport revenue based on the housing numbers. 24/7 program projected an \$80,000 revenue with a significant increase of use of the program. Meeting will begin at 3pm on September 1st to meet with Fritz Fremgen and the Jamestown Regional Airport members to address the additional budget requests. Budget hearing will be October 6th.

Schwartz made a motion, seconded by Ova to approve the taxable meals and mid-month bills. Roll Call vote: Marks, Schwartz, Neys, Klose and Ova vote aye. Motion carried.
