Official Proceedings of the Stutsman County Commission – August 18, 2020

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke, David Schwartz, Steven Cichos and Mark Klose answered the roll call.

Mickey Nenow, Road Superintendent, presented his monthly report. The Stutsman County Road Department has only worked on county projects this past Spring and Summer. The Road Department has not started any projects for townships. Chip-sealing has started on the Ypsilanti and Millarton roads.

Anne Carlsen Center requested a letter of support for a USDA loan. Stutsman County is not involved monetarily. Cichos made a motion, seconded by Gumke, to approve the presented request. Roll call vote: Ova, Gumke, Schwartz, Cichos and Klose voted aye. Motion carried.

A preliminary 2021 budget was presented by Robin Iszler, Unit Administrator for Central Valley Health.

Iszler stated there is hope of a vaccine this Fall for Covid-19. Vaccines will not be tested on North Dakota residents at this time. A distribution plan is in the works.

Approval of special event permits for the Hitchin' Post and Corner bar were requested. Schwartz made a motion to approve the requested permits for the Hitchin' Post and Corner Bar, seconded by Ova. Motion carried.

A Stutsman County Zoning Board appointment for Brian Amundson was presented. Another position is still open. Cichos made a motion, seconded by Gumke, to re-appoint Brian Amundson to the Stutsman County Zoning Board. Roll call vote: Gumke, Schwartz, Cichos, Klose and Ova voted aye. Motion carried.

Jessica Moser, Treasurer, requested to cancel uncashed warrants and treasurer checks. A list was provided to the commission. Schwartz made a motion, seconded by Gumke, to cancel the checks. Roll call vote: Schwartz, Cichos, Klose, Ova and Gumke voted aye. Motion carried.

Nicole Meland, Auditor/COO discussed excess FEMA funding for projects under cost estimates. Stutsman County is starting to receive the 2019 FEMA funding. Estimates were obtained based on material-cost sheets for the projects. The townships have to apply for reimbursement through Meland. Proper documentation is needed for Stutsman County to pay the townships. If projects come in under the cost estimates, Stutsman County is allowed to keep that funding and use it towards other road projects. The funding and submitted receipts are being tracked. Meland made a request to allow townships that came in under-budget to utilize the funding that was originally obligated to them. Stutsman County is the applicant agent. Gumke made a motion to approve Meland's request to allow townships that came in under-budget to utilize the funding that was originally obligated to them, seconded by Ova. Roll call vote: Cichos, Klose, Ova, Gumke and Schwartz voted aye. Motion carried.

Stutsman County Narcotics Task Force requested using the Asset Forfeiture Fund to purchase a DSLR camera, lenses, and accessories to replace the current camera. The requested dollar amount is \$650. A motion to approve the request of \$650 to be used toward the purchase of a new camera was made by Gumke, seconded by Schwartz. Roll call vote: Gumke, Schwartz. Klose, Ova, Gumke, Schwartz and Cichos voted aye. Motion carried.

Meland gave an update on NDPHIT Health Insurance and voluntary insurance options. Schwartz made a motion to switch to NDPHIT, seconded by Ova. Stutsman County will give NDPERS a 60-day notice to end services. Roll call vote: Ova, Gumke, Schwartz, Cichos and Klose voted aye. Motion carried.

A discussion was held with Erik Legrey regarding Stink Lake Road. At this time, there is nothing Stutsman County can do to help with the situation. The State currently has all of the information regarding this topic. The township does not have the cost-share to cover the project.

At 5:13 p.m., the County commission meeting recessed for the County Park Board meeting.

Official Proceedings of the Stutsman County Park Board – August 18, 2020

At 5:13 p.m., Chairman Klose called the Stutsman County Park Board meeting to order. Dennis Ova, Ramone Gumke, David Schwartz, Steven Cichos, Mark Klose, Jason Houge and Joan Morris answered the roll call.

At 5:17 p.m., Commissioner Gumke left the meeting and joined via phone.

Karl Bergh, Park Superintendent, presented his monthly report. Bergh stated new sirens will be put in place. He also discussed some issues with the bathhouses that were caused from lightening from the last storm.

Erik Nordstrom, Spiritwood Lake Campground, requested some extra picnic tables that the Stutsman County Park Board has. The picnic tables are old and need repairs. Houge made a motion to give Nordstrom 12 picnic tables, seconded by Ova. Roll call vote: Gumke, Schwartz, Cichos, Klose, Houge, Morris and Ova voted aye. Motion carried.

Meland discussed Pelican Point Campground expansion change orders. The campground is short on black dirt. The bid was also short on moving the dirt. The original plans called for 6 inches of black topsoil. Meland believes they can cut it down to 3 inches of black topsoil on the back-slope. It's estimated the campground is 1,000 cubic yards short. It's an estimated \$35,000 to complete the project. Meland thinks the county can do it for \$25,000. Meland requested allowing Stutsman County to potentially utilize another \$25,000 to complete the topsoil work on the campground expansion. Stutsman County is still under-budget. Houge made a motion, seconded by Ova, to approve the request to potentially utilize another \$25,000 to complete the project. Morris questioned the budget for the project and how much has been expended to date. Roll call vote: Schwartz, Cichos, Klose, Houge, Morris, Ova and Gumke voted aye. Motion carried.

Houge made a motion to approve the mid-month bills, seconded by Schwartz. Roll call vote: Cichos, Klose, Houge, Morris, Ova, Gumke and Schwartz voted aye. Motion carried.

Meland discussed the CARES Act funding. To date, \$421,000 was submitted. Stutsman County will receive roughly another \$166,000 for two more months of payroll. The Stutsman County Commission will have to decide what to do with that funding. Some options were discussed. Klose mentioned putting it towards the new insurance policy. Cichos mentioned lowering the mill levy on the 2021 budget. Cichos asked Meland to bring options forward for the board to consider. Meland would like the Commission to decide by the last meeting in September how they want to utilize the funding.

The 2019 Audit Report was presented by Meland. Cichos asked questions relating to the bond reporting; he was unaware of the bond that the county held.

Cichos made a motion, seconded by Schwartz, to approve the taxable meals and mid-month bills. Roll call vote: Klose, Ova, Gumke, Schwartz and Cichos voted aye. Motion carried.
