Official Proceedings of the Stutsman County Commission – August 21, 2018

At 4:30 p.m., Chairman Mark Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark Klose answered the roll call.

Corey Genter, Staff Appraiser, presented an application for abatement for parcel #31-0140000 for Marvin and Penny Gottfried. In April, Mr. Gottfried contested his valuation and valued his property at \$191,213.00. The Lowery Township Board met to discuss this matter and approved Mr. Gottfried's requested valuation of \$191,213.00. Stutsman County conducted an appraisal after-the-fact and valued the property at \$178,126.00. At this time, Genter requested the commission to approve Stutsman County's valuation of \$178,126.00. Schwartz made a motion, seconded by Ova to approve a valuation of \$178,126.00. Roll call vote: Marks, Schwartz, Neys, Klose and Ova voted aye. Motion carried.

A request to approve special event liquor permits for the Corner Bar at three locations was made. A motion to approve the presented special event liquor permits was made by Ova, seconded by Schwartz. Motion carried.

Nicole Meland, Auditor / COO, asked the commission if they would like to speak with any individual departments regarding their budgets in September prior to the final budget hearing. No hearings were requested.

A request for the final budget hearing to be held on October 2, 2018 at 6:00 p.m. was made by Meland. Neys made a motion to approve the presented request, seconded by Ova. Motion carried.

Meland spoke with regards to the County excess levies on townships for the preliminary tax notices. Schwartz made a motion to leave an excess levy on Sharlow Township and call Fried and Weld Township to pay down their balances, seconded by Marks. Motion carried.

The Primary Election recount was scheduled for Friday, August 24, 2018 at 4:30 p.m. Meland would like to replace Jessica Alonge, Deputy Auditor / Recorder, with Emily McLean, Deputy Auditor, for the recount board. A motion to approve the replacement was made by Schwartz, seconded by Neys. Motion carried.

Meland informed the board the Jamestown Tourism grant for the Lakeside Campground expansion master plan was approved on this date.

Connie Ova, JSDC, requested approval of a \$75,000.00 matching grant for Jamestown Tourism, \$15,000 from County funds. Neys approved the requested matching grant amount, seconded by Marks. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted age. Motion carried.

Ova presented an informational update on the JSDC Integrated Marketing & Communications Plan.

An update on the August 14, 2018 CenturyLink cable cut and alternate routing process was presented by Jerry Bergquist, Stutsman County Emergency Manager / 9-1-1 Coordinator.

A request to appoint Brian Paulson as an alternate member to the SE Coordinated Regional Interoperability Board (CRIB) was made. Marks made a motion, seconded by Ova to approve the requested appointment. Motion carried.

Bergquist spoke regarding consideration to place increasing local 9-1-1 fees from \$1.00 to \$1.50 on the November ballot. Other counties have increased their 9-1-1 fees in the State. If passed, the fee would become effective February 1, 2019. Marks made a motion to place the increase of 9-1-1 fees, not to exceed \$1.50, on the November ballot and approval of the ballot language, seconded by Schwartz. Roll call vote: Schwartz, Neys, Klose, Ova and Marks voted aye. Motion carried.

Schwartz made a motion, seconded by Neys to approve the taxable meals and mid-month bills. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye. Motion carried.
