At 4:10 p.m. the Joint Logan County meeting was called to order will all Stutsman County Commissioners present and Dean Entzminger from Logan County. Commissioner John Wald from Logan County was on speaker phone. Mark Klose asked for nominations for chairman of the joint meeting. A motion to nominate Klose was made by Ova, seconded by Entzminger, Klose asked for any other nominations, any other nominations. Marks made a motion that nominations cease and cast a unanimous ballot for Klose, seconded by Neys. Motion carried. A motion to approve the 2012 Central Valley Health District budget was made by John Wald, seconded by Ova. Roll call vote, Ova, Marks, Schwartz, Neys, Klose, Entzminger and Wald voted aye. Motion to adjourn was made by Neys, seconded by Entzminger, motion carried. Meeting adjourned.

Connie Ova, JSDC CEO, presented a Flex PACE buy down request from Super 8 Motel owned by Mr. Kal Patel. The JSDC board unanimously approved up to \$85,000 to Mr. Patel who is requesting an \$85,000 interest buy down loan which would be split 80% city sales tax of \$68,000 and 20% county property tax of \$17,000. Mr. Patel is building 20 additional rooms at the Super 8 which are very much needed in the city. A motion to approve up to \$17,000 was made by Schwartz, seconded by Neys. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye.

Chad Kaiser, Stutsman County Sheriff, opened bids for a new pickup. The department would be trading in a 2008 Ford F150. Bid from Wilhelm's was \$10,194 with trade, and \$29,194 without trade. Bid from Stoudt's was \$12,939 with trade and \$29,560 without trade. The Road Department may be interested in the trade in pickup. Kaiser will review the bids and make a recommendation at the next meeting. Kaiser presented a grant that his office had received from the Department of Transportation in the amount of \$15,000 to pay for overtime to enforce seatbelt and DUI laws. Motion to accept the grant was made by Neys, seconded by Schwartz. Motion carried.

Kerry Peuser with Michael J Burns Architects had reviewed the LEC roof repair bid cuts with the low bidder - A & R Roofing. A motion to approve the Option #3 at a cost of \$138,540 was made by Schwartz, seconded by Marks. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye.

Tracey Trapp informed the Commission that the house across the street to the south of the courthouse is for sale. It would be a good property for the county to purchase for parking space, office space or at some point a minimum security building. A motion to have Klose and Schwartz look into the property and negotiate a price was made by Ova seconded by Marks. Motion carried.

Tracey Trapp requested out-of-state travel for LaRae Frieze to attend a food show in Alexandria Minnesota. A motion to allow out-of-state travel was made by Schwartz seconded by Ova. Motion carried.

Toni Hible, County Tax Director, requested approval of out-of-state travel for Dustin Bakken to attend an appraisal school the week of September 19, 2011 in Pierre, SD. Ova made a motion seconded by Schwartz to approve the travel request. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye.

Warren Tobin, Veterans Service Officer, presented the county employees wage and benefit committee requests for 2012.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager gave a flood information update.

At 5:07 p.m. commission meeting was recessed.

At 5:14 p.m., the County Park Board meeting was called to order with members, Klose, Neys, Schwartz, Marks, Ova and Woodward present. Schlecht was absent.
