

Official Proceedings of the Stutsman County Commission – September 6th, 2016

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Denny Ova, and Mark T. Klose answered the roll call. Craig Neys was absent.

Schwartz made a motion, seconded by Marks to approve the minutes of the August 2016 meetings. Motion carried.

Jessica Alonge, Stutsman County Treasurer, introduced BreAnna Garza who has been hired as the new deputy treasurer and would like to add as her name to the county bank accounts. Motion made by Schwartz to add BreAnna Garza as a signatory, seconded by Ova. Motion carried.

Alonge informed the commission of the Wells Fargo account that is used for corrections, roughly \$2,073 needs to be canceled, any check over \$50 that was issued to the person would get another notification that the check could be cancelled and the money would be sent to the state. Inmates are now issued cards instead of checks. Marks made a motion to cancel the checks, seconded by Ova. Motion carried.

Commissioner Dale Marks, Fort Seward is in need of new flags; the current flags have been fixed multiple times. Request to use \$3,000 of the \$6,000 tax money collected on the historical levy to purchase 1 new polyester flag and 1 new nylon flag. Money was originally budgeted for the Frontier Fort but was not awarded since a budget was not turned in by the deadline.

Nellie Degen submitted 4 police reports of intrusions at the Frontier Village; they would like to request the other \$3,000 to take necessary measures to help secure the village more than what it is now. Law enforcement recommended the purchase of surveillance cameras to watch the grounds of the Frontier Village.

Ova made a motion to grant \$3,000 to The Frontier Village and \$3,000 to Fort Seward, seconded by Schwartz, contingent upon invoices submitted by both agencies to show proof of purchase. Roll call: Ova, Marks, Schwartz, and Klose vote aye. Motion carried.

September 20-29th both Rita Morris and David Bratton will be absent, would like to temporarily close the office. Jerry Bergquist would answer phone calls, Bratton would like to notify veterans in the area and work with Barnes County in the event of paperwork needing to be completed Barnes County's Veteran Service Officer would cover. Schwartz made a motion to close the office of the dates specified, Marks seconded. Motion carried.

Dell Horn, Jamestown Community Corrections Coordinator, rate to stay at \$1.25/hour with no other changes made. Increase in community hours being issued by judges, program did not have to borrow money from savings account this year to keep the budget in the black. Marks made a motion to approve contract as presented, seconded by Ova. Motion carried.

Robin Iszler, Central Valley Health Unit Administrator presented the CVH budget, board of health met in August met and approved the budget. Over \$1,000,000 in revenue sources and again budgeted for a 3% shortfall. Budgeted \$42,000 for rent and \$23,000 would be Stutsman County's share. Salaries are budgeted for \$920,000 with a large increase due to various programs loss including Maternal Child. Expenses did decrease slightly due to a change in the bond payment on the building. Hired a coordinator to run a coalition so begin this year and work with compliance to receive grant monies. \$89,617 increase in salaries due to grant loss such as Maternal Child Health funding that recently ended. Health insurance was budgeted for a 12% increase due to staff salary increase, have not budgeted for the potential 17.4% increase and they did budget for a cost of living increase. Iszler will be meeting with Logan County next week and if all goes well she will submit the budget to both Logan & Stutsman County auditors. Ova made a motion, seconded by Schwartz, to approve the budget and allow the County Auditor to certify the budget to Logan County. Roll call: Marks, Schwartz, Klose and Ova vote aye. Motion carried.

Jamison Veil, abatement on parcel #62-2421011 for Farm Residence for the 2016 year based on the stipulations on the state provided form. Winfield Officers held a special meeting and approved the abatement. Based on the information they filed on the application Veil recommends the approval. Marks

made the motion seconded by Ova to approve the abatement as presented. Roll call: Schwartz, Klose, Ova and Marks vote aye. Motion carried.

Schwartz made a motion to approve the Special Even Permits contingent upon township paperwork for Cork & Barrel and The Corner Bar, seconded by Ova. Motion carried.

Mickey Nenow, 3 shops are completed other than the electrical & plumbing. 2 miles east of Spiritwood at the Barnes county line, September 26th is the start date and should be completed by the 15th of October, 2016. The 1st mile off of I-94 on the GRE road, there are 1.6 miles left going north to highway 10. By mid-October they are hoping to be putting the deck of the bridge down depending on the weather. Grade raise west of Cleveland will need to be raised and made wider but should be done shortly.

Casey Bradley, County Auditor/COO, presented the EAP semi-annual report- total of 15 contacts and 2 county wide training sessions. Four employees and two family members called to utilize the services. All 6 were self-referred; none of them were referred by a supervisor.

Bradley, gave the commission the 2017 initial budget & mill levy review, net change mainly came from COLA, received an increase in grant revenue for States Attorney's office. Child custody investigators have been court ordered to be paid back to the County on the District Court budget. Building maintenance decreases due to capital asset transfers and main purchases will be going away this coming budget season. A change in the Sheriff's department \$78,000 increase, majority is the Health Insurance, had 12 total last year and 14 this year. Emergency Management and Communications Center stay around the same. Removed the part-time staff and will occasionally run into over-time. Bradley noted a deficit in the Road and Bridge department and also the Social Service Department. Emergency fund was reduced to keep Road and Social Service department at the max levy. Health insurance \$1,518,521 assuming a 7.5% increase for 2017 budget. 130 positions budgeted that are taking benefits currently. Klose questioned the retirement on the Park Department, Mr. Lorenz, Park Superintendent, has indicated he is retiring at the end of the year, some of the current employees are on an old retirement plan and when there are new hires they will become part of the NDPERS plan. Mill levy breakdown set a max of 3% on all levy increases; state mill levy does not fall under this because they are at the 2 true mills which are the Garrison Diversion and State Hospital. The Road & Bridge and Social Services are set at 0 with the Library increased .11 mills. Emergency fund decreased .8 mills to help correct the Library Fund. The 2016 proposal is at 96.03 mills which is a reduction of 2.08 mills. There could be a 2.1% increase in property taxes against existing properties.

Bradley informed the commission if they would like to schedule any additional meetings or meet with any particular department to let him know so he can schedule a meeting or put it on the next commission agenda. The Final budget hearing will be held October 4, 2016 at 6:00p.m. in the commission room and the Auditor's office will notify all parties of the increase.

At 5:02 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

At 5:16 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. David Schwartz, Dale Marks, Mark T. Klose, Denny Ova, Robert Woodward, and Jason Houge answered the roll call. Craig Neys was absent.

Woodward made a motion, seconded by Houge to approve August 2016 minutes. Motion carried.

Dennis Lorenz, Park Superintendent, presented his monthly report stating Lakeside Marina to black top was authorized in spring; Border States was contacted and cost would be \$37,000 roughly. Rain damage, Pelican Point was leveled and after heavy rain it will need to be graveled again. Problems at the Lakeside Marina campground with the sewer system, possible plug in the drain field. Lorenz does not believe it is a tank problem. Lorenz announced that he would be leaving at the end of this season and believes Donald Lorenz will also be leaving. John expressed he would also be leaving; Lyndon and Lucas have not yet decided.

Motion made by Houge, seconded by Schwartz to approve the monthly bills. Roll call: Klose, Houge, Woodward, Ova, Marks and Schwartz vote aye. Motion carried.

Fritz Fremgen, State's Attorney, gave his opinion planting Alfalfa would go against the dedication of the land since it could be considered a cash crop. Park Board would like to set up a committee to address the issues brought up by the current lease holder, Eric Nordstrom. Committee to address Spiritwood Campground will be made up of Fritz, Casey, Jason, Dave and Dale.

Nicole Meland, Administrative Staff Officer, currently senior passes get 50% discounts; concessionaires receive all proceeds of the senior passes. During a meeting February 2008 it was decided but it was never added to the contracts, The DAK has reported around \$350 being generated by Senior Pass revenue. Board decides if we want to honor the passes or not. Houge made a motion to remove the Senior Pass discount option as of January 1, 2017, seconded by Schwartz. Motion carried.

Bradley presented the 2017 Park vacancies, Dennis Lorenz retiring; Bradley suggests setting up committee to come up with a plan to fill the vacancy. Craig, Jason, Bob, Dave, Casey and Nicole will be on the committee to come up with a recommendation for the Park board.

Dean Alber is having issues with ruts on the middle area and damaging equipment. Alber would like 5-6 loads of black dirt to smooth the area out and seed some grass this fall yet.

Adjourn at 6:10 by Schwartz, seconded by Houge. Motion carried.

Motion made by Marks, seconded by Schwartz to approve the bills. Roll call: Ova, Marks, Schwartz, and Klose vote aye. Motion carried.
