Official Proceedings of the Stutsman County Commission

November 1, 2011

At 4:00 p. m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

A motion to approve the minutes from the October meetings was made by Ova and seconded by Schwartz. Motion carried.

Jacki Lindell, County Treasurer, presented a list of outstanding checks that have been outstanding for a period of over one year.

Motion by Neys and seconded by Schwartz to authorize Lindell to cancel the two outstanding checks. Motion carried.

Lindell requested that the commission authorize adding Renee Valenta, Audit Support Assistant, as a signatory on the Stutsman County Bank accounts located at Unison Bank. Motion by Schwartz and seconded by Neys. Motion carried.

Mickey Nenow, County Highway Superintendent, presented proposals from Lightowler Johnson Associates and Interstate Engineering in response to the County's request for RFP's for multiple 2012 Emergency Relief Projects. It was the consensus of the board to wait until the midmonth commission meeting to select one of these firms for the projects.

Nenow presented a proposal from Braun Intertec Corporation for geotechnical services (Proposal FA-11-06783) in response to the County's requests for these services in conjunction with the Great River Energy (GRE) road reconstruction project in Spiritwood Township. It was discussed that the proposed cost of \$5,190 would be reimbursed by the Special Assessment District that was established previously; Steve Thompson of Interstate Engineering confirmed that these costs would be reimbursed. Schwartz made a motion seconded by Marks to accept the Braun Intertec proposal for geotechnical service. Roll call vote - Ova, Marks, Schwartz, Neys, and Klose voted aye.

At 4:10 p.m. the commission held the hearing to review the appraisals for tax foreclosures 2008 through 2010. Each member of the commission had reviewed and established an appraisal price for the properties presented. Klose opened the meeting for comments or questions from City Auditors, Township Board members, or the general public; no comments were made. Ova made a motion seconded by Marks to set the sale date and time for these properties at 10:00 a.m. November 15, 2011 at the Stutsman County Auditor's Office. Motion carried.

Casey Bradley, County Auditor/COO, presented a Gaming Site Authorization request from Arrowwood Ducks Unlimited. The request is to conduct games of chance at the 281 Stop, Pingree. The activities would take place November 10, 2011. Klose indicated that this was an annual event that they apply for each year. Schwartz made a motion seconded by Ova to approve the Gaming Site Authorization request for November 10, 2011. Motion carried.

Bradley informed the Commission that Benefits/Accounts Coordinator, Norma Kaiser, has given her notice of retirement effective December 1, 2011. Ms. Kaiser has been employed by Stutsman County for the past 22 years. Bradley explained that this position is responsible for the all payroll and accounts payable functions of the county. It is the recommendation of the Stutsman County Personnel Committee as well as Auditor/COO Bradley that this position be filled as soon as possible. A motion was made by Ova and seconded by Schwartz to authorize Bradley to fill the vacancy in the Benefits/Accounts Coordinator position. Motion carried.

Commissioner Schwartz and Chairman Klose updated the board on the Personnel Committee meeting that took place earlier in the day. It is the recommendation of the Personnel Committee that Auditor/COO Bradley be added, as an official member, to the Personnel Committee as well as the Grievance Committee. A motion was made by Schwartz and seconded by Marks to add Auditor/COO Bradley as a member of the County Personnel and Grievance Committees. Motion carried.

Bradley presented two potential names for nomination consideration for the upcoming vacancy on the Jamestown Regional Airport Authority Board. Jim Boyd, Chairman Airport Authority, forwarded a list of potential nominations. Of that list Keith A. Veil, local business owner and avid flyer, and Arnold Siefken, local business owner and avid flyer, responded to the County Auditor's Office to express their interest in serving on the board. Clarice Liechty also provided a letter of endorsement for Mr. Veil to serve on the board. Klose commented that he was aware of others that might also be interested and suggested that official nominations be made at the November 15th board meeting to allow other parties time to submit their interest to the board. It was the consensus of the commissioners to make official nominations at the November 15th board meeting.

A motion was made by Ova and seconded by Marks to pay the bills as presented. Roll call vote - Marks, Schwartz, Neys, Klose and Ova voted aye.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, presented a draft copy of the "Agreement to Jointly Operate the Stutsman County Communications Center". Bergquist explained that this agreement was drafted at the request of the Law Enforcement Center Board's request. It attempts to capture the current operations of the Stutsman County Communications Center, which has never operated with an agreement despite having operated since its inception as a joint effort between Stutsman County and the City of Jamestown. This document was created by County Sheriff Chad Kaiser, Emergency Manager Bergquist, and City of Jamestown Council Member Ramone Gumke. Mr. Bergquist stated that this was a preliminary draft and was not the final product; neither the City nor the County's legal staff has had the opportunity to review this document. He also stated this document was intended to only establish current operations and not bind either entity into future changes that might take place. A motion was made by Schwartz and seconded by Ova to send a copy of the draft agreement to State's Attorney Fritz Fremgen for review. Motion carried.

Bergquist informed the board that the 2011 Emergency Management Performance Grant (EMPG) Award has been adjusted as follows: Original grant award accepted by the Commission on July 19, 2011 – \$29,819.00; additional funds awarded by letter on October 18, 2011 – \$40,327.00; total grant award \$70,146.00. Grant comparison from past grants: 2011 EMPG grant = \$70,146.00 (\$12,472.00 more than 2010 and \$21,138.00 more than 2009); 2010 EMPG grant = \$57,674.00 (\$8,666.00 more than 2009); and 2009 EMPG grant = \$49,008.00. After a brief discussion as to why the funding has been increased each year Bergquist indicated that he was not positive as to why but his department certainly welcomed the additional funding.

Bergquist requested permission from the board to begin the process of advertising and hiring two temporary dispatcher positions. He informed the commission that both positions were currently budgeted for in the 2012 budget and would not begin employment until January of 2012. He also informed the board that he intends to stagger the hiring of these positions to ensure the current staff is able to adequately train them on an individual basis. But the overall intent is to only advertise for the position once and use that applicant pool to fill both positions. He also presented

information that illustrated call center demand has increased 23.01% since 2008 with specific increases of 28.90% in the morning shift and 23.76% in the afternoon shift, which are the shifts intended to be covered by these new hires. A motion was made by Marks and seconded by Schwartz to allow Bergquist to begin the process of advertising and hiring the first of two part-time dispatchers in January 2012. Roll call vote - Schwartz, Neys, Klose, Ova and Marks voted aye.

Fritz Fremgen, State's Attorney, presented his monthly report. Fremgen updated the board on the current status of Stutsman County establishing and meeting Title VI compliance standards. Currently, Assistant State's Attorney Heitkamp is working on reviewing county owned facilities and drafting various compliance plans. It is their goal to have all work completed by the middle of December 2011. Fremgen stated that he needed to contact Bryon Fuchs, NDDOT Local Government Unit, to discuss the process of Stutsman County becoming certified as a Title VI compliant county. It is the understanding of all involved that there are new requirements placed on this compliance for future Federal Highway funding. It was the consensus of the board that Auditor/COO Bradley and State's Attorney Fremgen contact Mr. Fuchs as soon as possible to find out the exact requirements and update the board at the next meeting.

Fremgen informed the board that he has been in consultation with staff at the North Dakota Insurance Reserve Fund (NDRIF) regarding payment of a bill related to an Administrative Hearing that was conducted in response to a termination of a Social Service Employee. At this time NDRIF will be looking into the billing to see if it qualifies for reimbursement by their organization.

At 5:10 p.m., the Commission meeting was recessed for the Park Board Meeting.

A motion to approve the minutes from the October meeting was made by Schwartz and seconded by Woodward. Motion carried.

A motion to approve the following bills was made by Neys and seconded by Schlecht. Roll call vote - Klose, Woodward, Schlecht, Ova, Marks, Schwartz and Neys voted aye.

Fran Romsdal, President of the Cabin Association, voiced the association's concerns over increasing the permit fees at this time. Mr. Romsdal noted that the incessant flooding has decreased the usability of the properties because of access issues to many of the properties as well as many cabin owners incurring additional costs to correct or mitigate various issues created by the flooding.

Larry Kuntz, Land and Water Manager with the Bureau of Reclamation, indicated that the Bureau did not know for certain why there was a disparity in the current permit fees. It was their intent to have all fees based on the index, with seasonal paying 50% of the fee that is charged to year round permits. He also indicated that the index was used in lieu of the five year appraisal cycle because the appraisals were cost prohibitive at this point in time. He also stated that the board may set a permit fee higher than the index indicated by not lower, as rates currently are.

Commissioner Schwartz pointed out that Stutsman County had received a letter on October 27, 2011 from Joseph Hall, Chief of Resource Management, of the Bureau of Reclamation that directs the county to set year-round rates at \$2,360 and seasonal rates at \$1,180.

Romsdal requested that any additional revenues generated from the permit fees be designated for riprapping costs along the reservoir on the properties currently occupied by the seasonal and year round permit holders. Klose indicated that this funding could not be used for the benefit of one or two individuals but rather must benefit everyone equally. Kuntz also concurred with this statement. Neys suggested that the association put together some possible uses of the funding and present them at a future Park Board meeting.

Romsdal requested that the Bureau consider looking at more lands being opened for personal and cabin use. Mr. Romsdal suggested that this may be a good option to help generate additional revenues. Kuntz stated that it was his understanding that the Bureau was not interested in opening more land for this type of use.

A motion was made by Schwartz and seconded by Schlecht to approve the 2012 cabin permit rates in accordance with the letter from the Bureau at \$2,360 for year-round and \$1,180 for seasonal. Roll call vote - Klose-aye; Schlecht-aye; Woodward-nay; Ova-aye; Marks-aye; Neys-aye; and Schwartz-aye. Motion passed 6-1.

Sandy Eckelberg, Accounts/Property Coordinator, presented the Pelican Point Concession Contract for consideration of noncompetitive extension based upon the three previous years of flooding. Ms. Eckelberg informed the board that there was a previous meeting between the Bureau, county officials, and the concessionaire to discuss this possibility. Given the circumstances of the flooding events the concessionaire only had two good operating years out of the five year contract and the Bureau had no objections to extending the contract on a single year basis for up to three years. A motion was made by Ova and seconded by Marks to extend the current contract through 2012 and to reconsider in 2012 to extend for the 2013 season and do so again in 2013 for the 2014 camping season. Roll call vote - Schlecht, Woodward, Ova, Marks, Neys, Schwartz, and Klose all voted aye.

Nellie Degen informed the board that it was her understanding that the board may not use the additional revenues generated by the permit fees to improve the properties occupied by the permit holders. The funding may only be used for the betterment or benefit of all properties.

At 6:50 p.m., a motion was made by Neys and seconded by Woodward to adjourn the Park Board meeting. Motion carried.

At 6:50 p.m., the regular Commission meeting was called back to order with all Commissioners present.

At 6:51p.m., a motion was made by Schwartz and seconded by Ova to adjourn the commission meeting. Motion carried.
