Official Proceedings of the Stutsman County Commission

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

Ova made a motion seconded by Schwartz to approve the minutes of the October meetings. Motion carried.

Brian Osowski, Osowski Business Consulting, requested that the Commission waive the \$10,000 fees for the Recovery Zone Facility Bonds that were approved for IRET Properties and for Allied Agronomy. Low tax rates, low interest rates and the relatively low amount of the bond requests reduced the attractiveness of acquiring the bonds. The companies were willing to pay the \$1,000 application fee. Noel Johnson, County COO, indicated that there was virtually no cost or risk to the county for issuing the bonds. By policy, the City of Jamestown would have charged about \$3,000 for issuing similar MIDA bonds. Neither project had received a property tax exemption so both would be fully taxable upon completion. Klose noted the request by the ND Industrial Commission for the County to waive their remaining allocation of the Recovery Zone Bonds. Osowski indicated that there were several large projects, mainly in western North Dakota that could use the bonds. He requested that if the bonds were released, the County would indicate a preference for their use for projects in Ward County. Ova questioned if there were any projects close to Stutsman County. The only project was a new hotel in Cass County. A motion was made by Marks seconded by Schwartz to waive all fees except the \$1,000 application fees. Roll call vote - Ova, Marks, Schwartz, Neys and Klose voted aye. Ova made a motion seconded by Neys to release the County's allocation of \$6,755,000 in Recovery Zone Economic Development Bonds and \$5,416,000 in Recovery Zone Facility Bonds to the ND Industrial Commission with a preference for their use for Ward County projects. Roll call vote - Marks, Schwartz, Neys, Klose and Ova voted aye.

The hearing on the appraised value to set the minimum sales price for foreclosure properties was held. No City or Township was present to express concerns over the appraised prices. Neys made a motion seconded by Ova to conduct the foreclosure sale on November 16, 2010 at 10:00 a.m. in the lobby on the main floor of the courthouse. Motion carried.

A motion was made by Ova seconded by Schwartz to cancel \$41.51 in prior years' taxes on parcel 70-1000880 so that the City of Courtenay could sell the property. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye.

Marks made a motion seconded by Schwartz to approve the agreement between Stutsman County and the School Districts within the County for the dissolution and assignment of duties of the Stutsman County Superintendent of Schools. Roll call vote – Neys, Klose, Ova, Marks and Schwartz voted aye.

Mike Zimmerman gave his report. Rocking the road south of Cleveland and graveling were nearly completed. Zimmerman reviewed the Federal Aid project list. The County would have \$1,321,467 of Federal Aid Funds in escrow in 2011. The potential future projects on the list were widen and overlay SC-4707(053) - Medina to Woodworth – at a project cost of \$7.02 million in 2014; widen and overlay SC-4717(062) – Cleveland south – at a projected cost of \$4.485 million in 2015; CER-4717(071) – grade raise Cleveland south – at a project cost of \$486,377 in 2011; \$600,000 for bridge replacement one mile south of Ypsilanti in 2011 and \$500,000 for a bridge replacement on the stock yard road west of Jamestown in 2012. The bridge in Sydney Township was still pending decision in Denver. Marks

made a motion seconded by Schwartz to place County Highway 62 South on the project list. Klose commented that the commission should utilize the matrix system to prioritize future projects. Roll call vote: Klose – nay, Ova – aye, Marks – aye, Schwartz – aye, and Neys – aye. Motion carried.

A motion to approve the Federal Aid project list with the inclusion of County Highway 62 South was made by Marks seconded by Schwartz. Roll call vote: Ova – aye, Marks – aye, Schwartz – aye, Neys – aye, and Klose – nay. Motion carried.

Fritz Fremgen, State's Attorney, gave his monthly report. With the election of Jay Schmitz as a District Judge, he would move Troy LeFevre into Schmitz's position and hire a replacement for LeFevre's position. He requested authorization to offer a sign on bonus if necessary to fill the position. Marks made a motion seconded by Neys to authorize a sign on bonus over 3 years of up to \$3,000. Motion carried.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, requested acceptance of two Homeland Security Grants – a \$6,500 grant for training and a \$16,000 grant for conducting an exercise. Both were 100% grants with no matching fund requirement. Ova made a motion seconded by Schwartz to accept the grants. Roll call vote – Marks, Schwartz, Neys, Klose and Ova voted aye.

Marks reviewed the agreement between adjacent counties for a truck regulatory authority. A common law enforcement officer would be hired and deputized by each of the four participating counties. \$20,000 per year over the next two years would be budgeted by each county to purchase equipment and pay the salary of the officer. Barnes County would be home base and they would provide storage for the vehicle and equipment. Schwartz made a motion seconded by Neys to approve the resolution and joint powers agreement for the creation of the South Central Regional County Truck Regulatory Board. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye.

Ova made a motion seconded by Neys to appoint Commissioners Marks and Schwartz to the Board of Directors for the South Central Regional County Truck Regulatory Board. Roll call vote – Neys, Klose, Ova, Marks and Schwartz voted aye.

Steve Thompson, Interstate Engineering, presented the Wetland Banking Instrument that would secure 17.42 acres of wetland mitigation acres on a 22.93 acre drained wetland in the SW1/4 of 16-T142N-R67W owned by Ryan Odenbach. The mitigation acres would be used for the County's ER and other road projects. The document had been approved by the Federal Highway Administration and other various Federal agencies. 8.21 acres would be used for ER projects currently under construction. The remaining 9.21 acres would be banked for future projects. The County would be responsible to plug the drain, make quarterly inspections to the site, document the condition and report to the NDIRT team. Odenbach would be compensated \$5,000 per acre. Schwartz made a motion seconded by Ova to approve signing the Wetland Banking Instrument and the \$5,000 per acre compensation. Roll call vote – Klose, Ova, Marks, Schwartz and Neys voted aye.

Zimmerman requested permission to notify property owners along the county highways to discontinue farming the right of way and the requirement that the right of way be restored to Federal standards. The letter would be sent after the deeds from the ND DOT had been filed that delineated the right of way. The letter would include cost estimates from private contractors to complete the restoration. Schwartz made a motion seconded by Marks to authorize sending the letter. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye.

At 5:10 p.m. the commission meeting was recessed for the County Park Board meeting.

At 5:16 p.m. Chairman Klose called the Stutsman County Park Board meeting to order. Park Board members present were Bob Woodward, Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose. Mark Schlecht was absent.

A motion to approve the minutes from the October meeting was made by Neys seconded by Woodward. Motion carried.

A motion to approve the monthly bills was made by Ova seconded by Marks. Roll call vote – Woodward, Ova, Marks, Schwartz, Neys and Klose voted aye.

Neys made a motion seconded by Woodward to accept a \$1,390.99 grant from the Buffalo City Tourism Foundation to purchase a brush mower and to approve a hold harmless agreement between the Park Board and William Steinmetz to operate the mower to maintain a bike path on the east side of the Reservoir. Roll call vote – Ova, Marks, Schwartz, Neys, Klose and Woodward voted aye.

Ova made a motion seconded by Schwartz to approve the transfers of Lot 53, West Side from Unruh to Tweed; Lot 54 West Side from Wentz to Neumiller and to approve the transfer of Lot 64, West Side from Schilling to Schilling contingent on completion of paperwork. Roll call vote – Marks, Schwartz, Neys, Klose, Woodward and Ova voted aye.

The removal of redundant and obsolete language from the cabin permit would be on hold pending possible changes to the permit.

Dennis Lorenz, County Park Superintendent gave his monthly report. At Lakeside Marina the handicap rails were in place, rip rap was being placed and the parking lot was being cleaned up. The fish

cleaning station would be put in place next spring. The Marina should be ready to operate next spring. Tree cutting, cleanup and planting was taking place.

Lorenz reported that there was a problem at Spiritwood Lake on the area north of Sandy Beach. Property lines were in question. He requested permission to send a letter to the cabin owners along with a map showing land ownership and where the surveyed section line was located. Schwartz made a motion seconded by Ova to send a letter to the cabin owners. Motion carried.

The 2010 campgrounds revenue was reviewed. Concessionaire contracts would expire in 2011.

The Degens had requested that the trees on Stoudt's lot be trimmed for visibility purposes. Lorenz reported that he had talked to Mike Zimmerman about the issue and Zimmerman thought that placing either a stop sign or yield sign on the road would take care of the issue. Woodward made a motion seconded by Ova to have Zimmerman place a stop sign on the road. Motion carried.

A motion to renew the dock permit for Chris Mikkelson was made by Neys and seconded by Marks. Motion carried.

A motion to adjourn the Park Board meeting was made by Neys seconded by Marks. At 5:43 p.m. the meeting was adjourned.

The Stutsman County Commission meeting was called back to order at 5:44 p.m. with all Commissioners present.

A motion to approve the monthly bills was made by Ova seconded by Schwartz. Roll call vote – Marks, Schwartz, Neys, Klose and Ova voted aye.
