Official Proceedings of the Stutsman County Commission – December 1st, 2015

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys, Dennis Ova, and Mark T. Klose answered the roll call.

Neys made a motion, seconded by Marks to approve the minutes of the November 2015 meetings. Motion carried.

Casey Bradley, Auditor/COO, presented a summary on Sharlow Township's balance with the road department since they were present. With a balance of over \$50,000.00, the township cannot receive services from the Stutsman County Road/Highway Department. A resolution was passed three years ago, by the Stutsman County Board of Commissioners, to place a \$50,000 cap on township balances. Sharlow County stated their comments and concerns. Casey Bradley suggested setting up a meeting to discuss a possible payment plan.

Schwartz made a motion, seconded by Ova to approve the 2016 beer and Sunday beer applications for Buchanan Bar, Anchor Bar, Windsor Bar, Sportsman, and the County Fair that were received by the Auditor's Office. Motion carried.

Commissioner Craig Neys spoke about the request for a letter of support to extend the Highway 52/36 turning lane reconstruction. There is not enough room on the west side of 281. The project will be put on hold. Lighting out in that area was addressed.

Mickey Nenow, County Highway Superintendent, presented his monthly report. The Road Department is continuing to do rocking and snow plowing. They have finished graveling the roads.

Mickey is requesting to advertise to bid for purchase of assets for a 2016 Motor Grader and Loader. It is the consensus of the commissioners to approve the request.

Nenow is requesting to purchase a used truck (semi) for up to \$32,000.00. Schwartz made a motion, seconded by Marks to approve the request as presented. Motion carried.

Mickey is requesting approval to sell a County owned gravel pit in Montpelier by sealed bids. The pit is approximately 65.71 acres. Ova made a motion, seconded by Schwartz to approve selling the Montpelier gravel pit as presented. Motion carried.

Nenow received a yearly maintenance certification letter from the North Dakota Department of Transportation. Stutsman County will have to maintain their roads at the Federal Aid standard. Neys made a motion, seconded by Ova to approve entering into the agreement as presented. Motion carried.

Fritz Fremgen, State's Attorney, presented his monthly report.

Jerry Bergquist, Emergency Manager/9-1-1 Coordinator, received FEMA approval of the Stutsman County Multi-Hazard Mitigation Plan. The County and incorporated cities require the plan in order to receive certain types of non-emergency disaster assistance from FEMA. No grant funds are available at this time. All incorporated cities have their own chapters and will receive copies of the information. This was a \$37,000.00 project; with\$31,500.00 being paid by Federal/State funds and \$5,500.00 was paid with an in kind-match.

Bergquist gave an update on the "Are You Prepared?" booklet distribution. There were not enough booklets, so re-printing caused the mailing to be held back. The mailing company out of Bismarck failed to send the booklets out to businesses, like negotiated. Initially they wanted an extra \$900.00, but finalized on \$200.00. The total project was \$12,309.00 and paid by the Homeland Security grant, except the \$200.00, which was paid for by LEPC (Local Emergency Planning Committee) funds.

Casey Bradley, Auditor/COO, informed the Commission the new Veteran Service Officer, David Bratton, reached

the end of his probationary period. Bradley conducted a six month evaluation with Bratton. Bradley would like to see him in a full-time position. Schwartz made a motion, seconded by Marks to approve appointing Bratton in the full-time Veteran Service Officer position as presented.. Motion carried.

The Village Business Institute will be presenting an onsite orientation of the EAP (Employee Assistance Program) on December 16, 2015. The onsite orientation will be for all staff members and Board members are encouraged to attend. The times will be as follows: 10:00 a.m., 11:00 a.m. (Supervisors), 2:00 p.m. and 6:00 p.m.

Harassment training will be on January 13, 2016. The times will be as follows: 10:00 a.m., 1:00 p.m. (Supervisors) and 3:00 p.m.

Auditor Bradley is requesting to contract for ATM services. There is no interest from any of the local banks. Bradley contacted the last bidder to see if they were still interested in providing ATM services. Carr Enterprises Inc. would like \$2.00 per transaction because of the low volume that goes through the ATM. Stutsman County would like an open-ended agreement with a 30-day notice to end the contract if needed. Neys made a motion, seconded by Ova to approve entering in an agreement with Carr Enterprises Inc. as presented. Motion carried.

The current board appointments are as follows: Human Services Board: Sandy Bendewald and is the only applicant; Park Board: Jason Houge and Robert Woodward have submitted their applications as well as Robert Martin; Water Resource Board: Joel Lees and Arlyn Schmidt and they both submitted applications; Weed Control Board: Dale Reimers and he is the only applicant; and Social Services Governing Board: Lynne Tally who has not submitted an application as of yet. Appointments will be made at the December 15th meeting.

Effective April 1, 2016, Stutsman County will no longer be required to sell hunting and fishing licenses. Stutsman County will not be continuing their sales and distribution of said licenses. Schwartz made a motion, seconded by Neys to approve discontinuing the sales and distribution of hunting and fishing licenses. Motion carried.

At 4:55 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

Dennis Lorenz traded in the Parks' 2008 Grasshopper 729 Mower/Front Deck for a 2016 Grasshopper 729T Mower/Front Deck. The sub-total was \$14,500.00. The total with the trade in was \$7,500.00. The mower was in the 2015 budget. Schwartz made a motion, seconded by Houge to approve purchasing the mower as presented. Roll call vote: Dale Marks, Dave Schwartz, Craig Neys, Mark Klose, Jason Houge, Robert Woodward, and Denny Ova voted aye. Motion carried.

At 5:13 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Schwartz, seconded by Woodward. Motion Carried.

At 5:14 p.m., the Stutsman County Commission Meeting reconvened.
