Official Proceedings of the Stutsman County Commission – December 1, 2020

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Ramone Gumke, David Schwartz, Steven Cichos (via phone) and Mark Klose answered the roll call. Dennis Ova was absent.

Gumke made a motion, seconded by Schwartz to approve the November 2020 meeting minutes. Motion carried.

Shannon Larson, Human Resource Director, presented board appointments.

Schwartz made a motion to appoint Gayle Nelson to the Buffalo Bridges for a 3-year term, seconded by Cichos. Roll call vote: Gumke, Schwartz, Cichos and Klose voted aye. Motion carried.

Denny Ova joined the meeting at 8:03 a.m. via phone.

Two positions are available for the Water Resource Board. One application was received from current board member Joel Lees. A motion to re-appoint Joel Lees to the Water Resource Board for a 5-year term was made by Gumke, seconded by Schwartz. Roll call vote: Schwartz, Cichos, Klose, Ova and Gumke voted aye. Motion carried.

The Park Board received two applicants for the 1 unexpired term from Robert Martin and Henry Steinberger. A vote was held and Martin received 3 votes. Steinberger received 2 votes.

Ackerman-Estvold and Interstate Engineering were interviewed on November 24, 2020. Mickey Nenow, Highway Superintendent, recommended awarding Interstate Engineering for the preliminary design on two grade raises South of Cleveland. Ova made a motion to retain services from Interstate Engineering for RFP, seconded by Gumke. Roll call vote: Cichos, Klose, Ova, Gumke and Schwartz voted aye. Motion carried.

Schwartz discussed construction engineering for the Medina project and for the two projects South of Cleveland. It would be up to the commission whether or not they want to do RFP's again, interviews, scoring and push the projects back. Schwartz recommended using the sufficient money Stutsman County has in the two accounts for Federal Highway Aid dollars. This is 100% cost to Stutsman County. This topic has been tabled for a future meeting.

Jessica Alonge, Interim Auditor/COO, presented a Drug Task Force Asset Forfeiture request. During Case # TF20-00767, \$6,131 was seized. Forfeiture agreement paperwork was prepared and negotiated by Stutsman County Special Prosecutor Kara Brinster, where \$4,931 was forfeited to the Stutsman County Narcotics Task Force. The Task Force is requesting \$986.20 (20% of the \$4,931) of the forfeited currency for payment of the Special Prosecutor's fee for work performed in the forfeiture case. Cichos made a motion to approve the presented request, seconded by Gumke. Roll call vote: Klose, Ova, Gumke, Schwartz and Cichos voted aye.

A motion to approve a year-end check run on December 31, 2020 was made by Gumke, seconded by Schwartz. Motion carried.

Schwartz made a motion, seconded by Gumke, to approve the beer and liquor licenses for the Anchor Bar and Buchanan Bar. Motion carried.

At 8:27 a.m., the Stutsman County Commission recessed for the Stutsman County Park Board.

Official Proceedings of the Stutsman County Park Board – December 1, 2020

At 8:28 a.m., the regular meeting of the Stutsman County Park Board was called to order. Dennis Ova (via phone), Ramone Gumke, David Schwartz, Steven Cichos (via phone), Mark Klose, Jason Houge, and Joan Morris (via phone) answered the roll call.

Houge made a motion to approve the November 2020 meeting minutes, seconded by Schwartz. Motion carried.

Jessica Alonge, Interim Auditor/COO discussed contracting with an attorney for cabin land sales. This is in reference to documentation that must be drafted after the land conveyance has been completed and when cabin owners are ready to make their purchases. Fritz Fremgen, State's Attorney, was doing some research. This topic has been tabled until Fremgen has the information prepared.

The Bureau of Reclamation has not signed the land conveyance agreement. Senator Hoeven's Office is interested in having a signing ceremony. A Zoom call is to be scheduled for Tuesday, December 8, 2020 at 10:00 a.m. The Senator's office is requesting a cabin owner and Park Board member speak, along with Senator Hoeven and the Regional Director.

Alonge discussed 2021 cabin permit fees and permit renewals. Schwartz made a motion to send out notices to cabin owners to include the Bureau of Reclamation permit fees, pro-rate the two tabled leases (Miller – 25W and Backer – 32W) and pro-rate future cabin purchases if made by June 30[,] 2021, seconded by Ova. Roll call vote: Houge, Morris, Ova, Gumke, Schwartz, Cichos and Klose voted aye. Motion carried.

Karl Bergh, Park Superintendent, presented some future project ideas. Bergh has a list of grants the Stutsman County Park Board can apply for. A request for input and narrowing the list of projects down was made by Bergh. This topic is tabled for the next meeting.

Schwartz made a motion, seconded by Ova, to approve the monthly bills. Roll call vote: Morris, Ova, Gumke, Schwartz, Cichos, Klose and Houge voted aye. Motion carried.
