

Official Proceedings of the Stutsman County Commission

December 2, 2008

At 4:00 p.m., Chairman Klose called the regular monthly meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call.

Mike Zimmerman, County Highway Superintendent, presented the Application for Federal Highway Aid. A motion to fill out the Federal Aid Application, sign and submit was made by Kaiser, seconded by Neys. Motion carried. Zimmerman stated that the application asks “if the county does any projects in 2009, would the county be willing to pay the contractors up front and get reimbursed as the money becomes available.” Zimmerman stated it is not a binding contract. By agreeing to this, the county has an opportunity to access funds if they become available. A motion to enter into the agreement to pay contractors up front and get reimbursed as the funds become available was made by Ova, seconded by Marks. Motion carried.

A motion to reappoint Dale Marks to the JSDC Board was made by Ova, seconded by Kaiser. Roll call vote – Neys, Klose, Ova, Marks and Kaiser voted aye. Motion carried.

A motion to close all county offices December 26 was made by Ova, seconded by Kaiser. Motion carried.

Nellie Degen, cabin owner voiced concerns over the land user fees for the cabins at the reservoir.

A motion was made by Kaiser, seconded by Neys to approve the following beer license applications for 2009: Lucas Gudmestad d/b/a/ Hitching Post Bar, Stutsman County Fair Association, Krewzer’s Dream, Inc. d/b/a Buchanan Bar (Bob & Kris Wenzel), Sandra Norquist d/b/a Ypsilanti Bar & Grill, Carmel Demaray d/b/a Windsor Bar; annual Sunday beer permits to Krewzer’s Dream and Hitching Post Bar. Motion carried.

A motion to approve the November meeting minutes was made by Kaiser, seconded by Ova. Motion carried.

A motion to appoint Deb Lee to the Social Service Board was made by Kaiser, seconded by Marks. Motion carried.

Jay Schmitz, Chief Assistant State’s Attorney gave their monthly report.

At 4:28 p.m. the Commission meeting was recessed for the County Park Board meeting.

Stutsman County Park Board Meeting

At 4:30 p.m. the Stutsman County Park Board meeting was called to order by Chairman Klose. Roll call was answered by Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys, Mark Klose, and Mark Schlecht. Bob Woodward was absent.

A motion was made by Schlecht and seconded by Neys to approve the minutes of the November 6, 2008 meeting. Motion carried.

A motion was made by Ova, seconded by Kaiser to pay the monthly bills. Roll call vote – Schlecht, Ova, Marks, Kaiser, Neys and Klose voted aye. Motion carried.

Rick McKay and Nellie Degen expressed concerns about how the cabin lease amounts for seasonal and year around leases were arrived at.

Recommended cabin lease rates are as follows: Seasonal/Year-Round – 2009 \$600/\$1,445; 2010 \$700/\$1,685; 2011 \$800/\$1,930. A motion to approve the cabin lease rates as presented was made by Schlecht, seconded by Kaiser. Roll call vote: Ova-aye, Marks-nay, Kaiser-aye, Neys-aye, Klose-aye and Schlecht-aye. Motion carried.

Dennis Lorenz, County Park Superintendent gave his year end report. The Game and Fish Department is looking at putting a boat ramp in north of the Buchanan Bridge on the Jamestown Reservoir. It would mainly be used by the commercial fishermen but it would be open to the public. The Game and Fish

Department is asking the county to sponsor the project at no cost to the county. The project would be completed with grant money at a cost of approximately \$50,000. A motion to sponsor the project was made by Neys, seconded by Kaiser. Motion carried. A vault toilet is being considered at Spiritwood Lake. It would be paid for with grant money, the only thing the Game and Fish Department is asking is that the county would take care of it.

At 5:20 p.m. a motion was made by Neys, seconded by Schlecht to adjourn the Park Board meeting.

At 5:21 p.m. the Stutsman County Commission meeting was called back to order.

A motion to pay the bills was made by Marks, seconded by Ova. Roll call vote: Kaiser-aye, Neys-aye, Klose-aye, Ova-aye and Marks-aye. Motion carried.
