Official Proceedings of the Stutsman County Commission – December 3rd, 2013

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Marks made a motion, seconded by Ova to approve the minutes of the November 2013 meetings. Motion carried.

Mickey Nenow, County Highway Superintendent, presented his monthly report. County road 68 North of Cleveland will not be completed this year but will be in the spring. Streeter grade raise has not been finalized yet and South of Cleveland the grade raises has not been completed yet and there will be a meeting on Wednesday December 4<sup>th</sup> to discuss the project. Currently the Road crew is working on rock north of Kensal, cleaning up trees in the townships and County roads but is also dependent on the weather.

Nenow updated the Commission that the Guthmiller projects have been completed but they have not cleaned up the sites due to pending projects.

Nenow is requesting to enforce a weight restriction of 8 Tons per axle up to 80,000 lbs. gross weight rather than adopting a "No haul" zone for Highway 40 East. Concerns were raised to "No Haul Road" regulations which may become difficult to enforce, the solution requested is to set the gross weight restriction so that farmers and contractors can continue to use Highway 40 and keep commercial traffic to interstate for heavier loads. During spring time Highway 40 would apply to the original spring load restrictions. Motion made by Schwartz to adopt 80,000 gross weight restrictions for Highway 40, seconded by Marks. Motion carried.

Schwartz gave an update on the County right-of-ways in which he has been traveling around the county checking for compliance. Schwartz stated out of about 190 checks he had done he only found about a dozen to be in violation. Schwartz is requesting to give an additional warning to landowners giving them a deadline of June 15, 2014 to take corrective action. Nenow and Schwartz are planning to work together to compile a list of landowners that will be notified of the violations. Commission will look at the compliance again once there is a list of the landowners for review before they send any letters out.

Kathryn Naumann Moe, Assistant State's Attorney, presented the monthly report for the State's Attorney's Office and stated no changes have occurred.

Motion was made by Neys to approve the 2014 beer and Sunday beer applications that were received by the Auditor's office, seconded by Marks. Motion carried.

Motion made by Ova to appoint one applicant to the Human Service Board and one applicant to the Weed Control Board, seconded by Neys. Motion carried.

South Central Dakota Regional Council requested a Joint Powers Agreement with Stutsman County for the year 2014. Funding has been allocated in the 2014 budget to cover the cost of the agreement. Motion made by Schwartz to accept the Joint Powers Agreement with South Central Dakota Regional Council, seconded by Marks. Motion carried.

Casey Bradley, Auditor/COO, informed the commission that the state bid out the 9.245 miles north of Medina which runs one mile off of Interstate 94 up to the city limits of Medina and with the remaining mileage north of Medina. The project breaks through the city limits since the road had just been redone and does not need an overlay. For budgeting purposes the county used the same estimates for bids that were received for the Old Highway 10 project. The county is looking at roughly \$2.5 million with Border States as the low bidder at \$1,472,155.64 which puts the county \$1.1 million under budget with the project being an 80/20 split. Motion made by Schwartz to award bid to Border States Paving Inc. for county project SC-4707(055), seconded by Ova. Roll call vote: Ova, Marks, Schwartz, Neys and Klose all vote aye. Motion carried.

Klose questions where the excess money the county accrued from property tax foreclosure sales is allocated. Bradley informs the commission the money left after the taxes are settled goes into the general fund and can be used as they see fit. Klose suggests putting the money towards the computer software bill which could amount to a year off of the repayment plan. Motion made by Marks to transfer the excess money towards the computer software repayment, seconded by

Schwartz. Roll call vote: Marks, Schwartz, Neys, Klose, and Ova vote aye. Motion carried.

Bradley informed the commission of a request put in by Tracey Trapp, Jail Administrator, to purchase a replacement copy machine. The current one in use was purchased in 2004 and cannot keep up with the work due to constant jamming. The Law Enforcement Center board reviewed a quote from Central Business Systems in Jamestown at a cost of \$5,050.00 and recommends proceeding forward with the local vendor. Motion made by Marks to purchase a copier from Central Business Systems for \$5,050.00, seconded by Ova. Motion carried.

Bradley stated the Senior Center Board rejected the easement for the old building due to concerns of who future tenants may be and the possibility of them obstructing access to the garage. Bradley requested Fritz Fremgen, State's Attorney, to draw up a lease instead of an easement so there's more flexibility with any future tenants.

Jim Fettig, Maintenance Supervisor, is requesting approval to enter a contract with an Architect to continue to work towards ADA compliance with the main level bathrooms. Fettig states they filed paperwork to reapply for grant money to use on the main level restrooms which will require moving walls, tiling the floors, and change the lighting which will put the project over \$50,000.00 in which state law requires any projects over the \$50,000.00 requires the services of an architect. Fettig had Carey Peuser stop in to look at the bathrooms and Peuser has agreed to provide services for \$1,800.00-2,700.00 to do the blue prints of the entire project. The grant money maxes out at \$52,000.00 and is an 80/20 grant so the county is looking at least \$10,400.00 or more. The architect will take approximately three days to complete the work, twenty-one days to run advertisements for bidding. Fettig talked with Hillerud construction and they would have time to complete the entire job with a plumber being lined up. The money has been budgeted into the 2014 fiscal year for the maintenance department to pay for the project. Motion made by Schwartz to approve the hiring of an architect for the main level restrooms for \$1,800 with a maximum of \$2,700.00, seconded by Marks. Motion carried.

Motion made by Ova to approve bills for payment, seconded by Marks. Roll call vote: Schwartz, Nevs. Klose. Ova and Marks vote ave. Motion carried.

Dennis Lorenz, Park Superintendent, presented his monthly report to the Park Board. The playground equipment has been put in place but the borders surrounding have not be completed. The Park department has been spending time cutting trees and having the stumps ground out but there will be more to complete in the spring time. The reservoir froze over November 22<sup>nd</sup> but still has open water west of the island. One truck went through the water by the Buchanan Bridge because the ice is not thick enough to hold heavier weight such as vehicles. Klose inquired about concessions applications and if it has been generating any interest. So far there have been two interested parties and applications are due Thursday December 5<sup>th</sup>, 2013 where they will be opened at 3pm that day.
