At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

Ova made a motion seconded by Neys to approve the minutes of the November meetings. Motion carried.

Jay Schmitz, Assistant State's Attorney, submitted a letter of resignation. He had been elected as a District Judge and would take office January 1, 2011. He thanked the Commission for his years of employment and the Commission wished him well.

Richard Huebner, Chairman Severn Township, requested a \$10,000 loan for Severn Township to help repair flood damaged roads south of 49<sup>th</sup> St SE on 81<sup>st</sup> Avenue and east of 81<sup>st</sup> Ave on 49<sup>th</sup> St SE. Neys made a motion seconded by Marks to approve a 5 year loan at 5% annual interest from the General Fund Sub-account. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye.

Joe Brummund requested that the Commission consider allowing 105,500 pound loads for tractor trailers with pups. 105,500 pound loads on semis with pup trailers were less pounds per square inch of tire surface than on conventional semis with 80,000 pound loads. The larger loads would mean less traffic on the roads. Commissioner Schwartz commented that the county bridges had all been constructed for maximum loads of 80,000 pounds. The greater weight would accelerate bridge deterioration. Zimmerman indicated that repetitive dynamics and pavement flexes would have to be considered. Townships would have to be involved. The heavier loads would be crossing township roads before they got to the county collectors. The Commission would discuss the matter at the township officer's meeting and get additional information.

Sheriff's vehicle bids were opened. Bids were as follows: Don Wilhelm, Inc. -2011 GMC Sierra SLE Crew Cab - Selling Price \$38,925 Trade Allowance \$15,120 Rebates \$7,300 Net Price \$16,505; R.M. Stoudt Inc. -2011 Ford F-150 Crew Cab 4X4 - Selling Price \$34,830.05 Trade Allowance and Fleet Discount \$16,001.00 Net Price \$18,829.05 (price without trade is \$29,330.05). The bids were tabled for review and recommendation by the Sheriff's Department until the next meeting.

Rich Welding & Mark Dooley, Gavilon Grain, presented a proposal for upgrading the paved County Road 40 PA to a 105,500 pound road and paving County Road 64 GA from Gavilon grain north to 40 PA. The \$1.35 million cost estimate would be paid with funds from Gavilon, ND Department of Transportation, BNSF Railroad and JSDC. The funds from BNSF were contingent upon closing the railroad crossing adjacent to Gavilon. The Commission would not consider closing the crossing until a public hearing was held. Steve Thompson, Interstate Engineering, presented issues that had to be resolved. The cost estimate did not include utility relocation, right of way, cultural resources, and wetland mitigation. Ova made a motion seconded by Schwartz to authorize Thompson to prepare more accurate cost estimates that included all aspects of the project's potential costs. Motion carried.

Lance Brower, County Agent, presented the potential economic impacts of Gavilon expanding their facility to include wholesale liquid fertilizer. 15 created jobs and 13 additional jobs with an economic impact of \$7.3 million could be attributed to the operations of the expansion plus 45 created jobs and 18 additional jobs with an economic impact of \$8.3 million could be attributed to the construction of the expansion to the facility.

Fritz Fremgen, State's Attorney, gave his monthly report. The right of way plats and deeds for Old Highway #10 had been recorded. Counties imposing overweight fines and retaining the fees collected was not legal under current law.

Noel Johnson, County COO, reviewed the township balances owed to the County Road Department for contract work. The total was over \$1.3 million. 29 townships had imposed their own excess levy. Johnson recommended placing a 9 mill excess levy on 11 of the townships that did not have an excess levy and had an account over one year delinquent and a balance owing of at least \$15,000. Courtenay Township concurred with the excess levy, but they were concerned about the cost overruns on FEMA projects. These costs were the sole responsibility of the Township. Zimmerman responded that FEMA rules and policies were always changing. Ova made a motion seconded by Schwartz to place a 9 mill excess levy on the following townships – Alexander, Chase Lake, Courtenay, Flint, Gerber, Manns, Marstonmoor, Roosevelt, Sharlow, Wadsworth and Walters. Roll call vote – Marks, Schwartz, Neys, Klose and Ova voted aye.

Schwartz made a motion seconded by Neys to abate the 1983-1987 taxes of \$699.31 on Kensal City parcel #76-1000270 so the City could sell the property. Motion carried.

A motion was made by Ova seconded by Marks to make the following Board nominations: Weed Board – Robert Martin; LEC Governing Board – James Nygaard; Water Resource Board – Joel Lees and Arlyn Schmidt; and Buffalo City Tourism – David Smette. Motion carried.

Neys made a motion seconded by Ova to approve the following Beer License applications: Shawndell Gudmestad-Moore d/b/a Hitching Post Bar; Jamestown Country Club; Ron Davis d/b/a Cuz=n Ron=s Saloon; Wayne & Hilda Kuntz d/b/a Sportsman Bar; Carmel Demaray d/b/a Windsor Bar; Krewzer=s Dream Inc. (Bob & Kris Wenzel) d/b/a/ Buchanan Bar; Judith Ganser d/b/a Anchor Bar; Sandra Norquist d/b/a Ypsilanti Bar & Grill; Stutsman County Fair Association; and Joey Uehran d/b/a 281 Stop. Motion carried.

A motion was made by Schwartz seconded by Ova to make the following Stutsman County Committee appointments: Grievance Committee - Norma Kaiser, Elise Miller, Warren Tobin, and Mickey Nenow; Personnel Committee - Linda Chadduck, Sandy Bendewald, Jerry Bergquist, and Mickey Nenow; Newsletter Committee - Renee Valenta, Diane Nygaard, Todd Volk and Nancy Pfaff; Wage and Benefits Committee - Jacki Lindell, Troy LeFevre, Melissa Rudnick, Teresa Steele, Warren Tobin, Jason Falk, Robin Harrington and Steve Comer. Motion carried.

Mike Zimmerman, County Highway Superintendent, gave his monthly report. The 2009 grade raises had been completed. He presented 15 potential ER grade raise projects for next year. Marks made a motion seconded by Neys to solicit proposals for engineering services for the 2011 ER projects. Motion carried.

Zimmerman requested the Commission begin planning for selecting road recycling projects for next year.

A motion was made by Schwartz seconded by Marks to pay \$20,000 for Stutsman County's share of the South Central Regional Truck Regulatory for the multi-county effort for weight compliance on county roads. Roll call vote – Schwartz, Neys, Klose, Ova and Marks voted aye.

Jon Arntson, Bond Council for IRET Properties, requested passage of the resolution that set the general covenants for the Recovery Zone Facility Bonds to expand Bison Twin Theaters at the Buffalo Mall. Neys made a motion seconded by Schwartz to approve the bond resolution. Motion carried.

At 5:26 p.m. the commission meeting was recessed for the County Park Board meeting.

At 5:31 p.m. Chairman Klose called the Stutsman County Park Board meeting to order. Park Board members present were Bob Woodward, Mark Schlecht, Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose.

A motion to approve the minutes from the November meeting was made by Schlecht seconded by Woodward. Motion carried.

A motion to approve the monthly bills was made by Neys seconded by Schwartz. Roll call vote – Woodward, Schlecht, Ova, Marks, Schwartz, Neys and Klose voted aye.

Johnson reviewed the proposed changes to the cabin permit as approved by the Bureau of Reclamation. Permit fees were updated; redundant and outdated language was removed. There were no substantive changes. Nellie Degen expressed concerns over the proposed fee schedule. 2011 – seasonal \$800 – year-around \$1,930; and 2012 – seasonal \$1,000 – year-around \$2,500. Prior to 2003, seasonal permit fees were half of the fees for year-around permits. Now, the proposed fee schedule had seasonal permits at 40% of the year-around fee. The seasonal use was for 7 months or more than half the year. The Park Board could increase the seasonal fee. The consensus was that the Park Board could consider changes for 2012 at a later date – fees for 2011 had already been billed. Ova made a motion seconded by Schlecht to approve changes to the language within the permit. Roll call vote – Schlecht, Ova, Marks, Schwartz, Neys, Klose and Woodward voted aye.

Dennis Lorenz, County Park Superintendent gave his monthly report. Three new vault toilets had been installed: below the Lakeside Marina, East side of 5-Mile Corner and near the public boat ramp area on 31<sup>st</sup> St SE. All the improvements at Lakeside Marina were completed so everything should be ready to go for next year.

A motion to adjourn the Park Board meeting was made by Schlecht seconded by Woodward. At 6:08 p.m. the meeting was adjourned.

The Stutsman County Commission meeting was called back to order at 6:09 p.m. with all Commissioners present. Johnson presented documents for the Commission to review pending an appeal by a former employee whose employment had recently been terminated. Johnson reviewed the scope of the Commission's role per the Stutsman County Policy Manual.

A motion to approve the monthly bills was made by Ova seconded by Schwartz. Roll call vote – Ova, Marks, Schwartz, Neys, and Klose voted aye.
