

Official Proceedings of the Stutsman County Commission

March 3, 2009

At 4:00 p.m., Chairman Klose called the regular monthly meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call.

A motion to approve the minutes of the February, 2009 meetings was made by Kaiser and seconded by Ova. Motion carried.

The Commission opened and reviewed the gravel crushing bids. Bids were as follows: Gravel Products Inc., Minot, ¾" material - \$3.23 cy, 1" material - \$3.11 cy; Sundre Sand and Gravel Inc., Minot, ¾" material - \$3.13 cy, 1" material - \$2.88 cy. Kaiser made a motion that was seconded by Neys to accept both bids with a preference to the low bidder. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

A motion was made by Ova and seconded by Marks to approve the Memorandum of Agreement for joint library services with the City of Jamestown. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

Fritz Fremgen, State's Attorney, gave his monthly report. His primary focus has been working on the wind zoning ordinance.

Ova made a motion that was seconded by Kaiser to appoint Dale Marks to a two year term on the Stutsman County/City of Jamestown Joint Library Board. Motion carried.

A motion was made by Neys and seconded by Kaiser to appoint Lynn Krueger to a three year term and Char Freeberg to a one year term on the Stutsman County/City of Jamestown Joint Library Board. Motion carried.

Mike Zimmerman, County Highway Superintendent, gave his monthly report. The County would receive \$343,426 in Federal Stimulus Funds for roads. Steve Thompson, Interstate Engineering, estimated the cost to chip-seal County Highway 42 from County Highway 62 to Buchanan as \$393,783 for construction plus \$32,000 for engineering. The County would have to pay for the costs exceeding the stimulus funding. The plans were ready to be submitted with a proposed bid letting of May 15. Kaiser made a motion that was seconded by Marks to proceed with the project and to advertise for requests for proposals for construction engineering services. Motion carried.

Zimmerman reviewed the snow removal costs for January - \$32,000 for Guthmiller's assistance, \$78,611 for County roads, \$96,500 for Townships and \$33,549 for employee overtime. The township expense did not include township work that was completed by private contractors. All Townships should contact the Road Department to be informed of the Snow Emergency assistance available from the State, and the Road Department would assist them with the application process.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, indicated that the Governor had requested a Presidential Disaster for snow removal assistance for February. If there is no declaration, the State's program may continue for February snow removal costs.

Zimmerman requested approval of the emergency snow routes that were designated by the Townships. These were the township roads that would be kept open. Having the designated routes was a

requirement if and when a Presidential Disaster was declared so that townships could be eligible for federal funds. Kaiser made a motion that was seconded by Marks to approve the emergency snow routes. Motion carried.

ND Department of Transportation was completing a study for possible new traffic safety devices on the two railroad crossings in Kensal. If the devices are necessary, the DOT would be requesting that the County participate in 10% of the cost.

A motion was made by Kaiser and seconded by Marks to request assistance from the ND Highway Patrol for road weight limit compliance. Motion carried.

Zimmerman indicated that the County's road weight restrictions would be implemented when the State restrictions begin.

Tracey Trapp, LEC Administrator, requested permission to purchase a used 12 passenger prisoner transport van. He had quotes from two local dealers for less than the \$20,000 that was budgeted for the purchase. Kaiser made a motion that was seconded by Neys to purchase a van for \$16,900 or less. Roll call vote – Kaiser, Neys, Klose, Ova and Marks voted aye.

A motion was made by Ova and seconded by Kaiser to transfer \$220,770.75 from the General Fund's Estate Tax account 10-114-6999 to the General Fund sub-account 52-000-5999. Motion carried. Bergquist requested permission to order a replacement radio repeater for the Jamestown Amateur Radio Club. The current repeater is owned by the County and was purchased in the mid-80's. The repeater is used by the Amateur Radio Club to help the County with emergency communications such as assisting with weather spotting activities in the summer. The Amateur Radio Club can either complement existing public safety radio communications activities or can step in if normal radio communications methods fail. 80% of the \$22,315 cost would be paid with grant dollars – the 20% County cost was budgeted for in the Emergency Management Budget. A motion was made by Ova and seconded by Neys to authorize the purchase. Motion carried.

At 5:25 p.m. the meeting was recessed for the Park Board meeting.

Stutsman County Park Board Meeting

March 3, 2009

At 5:30 p.m. Chairman Klose called the Stutsman County Park Board meeting to order. Bob Woodward, Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call. Mark Schlecht was absent.

Woodward made a motion that was seconded by Ova to approve the minutes of the December, 2008 Park Board meeting. Motion carried.

A motion was made by Ova and seconded by Woodward to pay the bills. Roll call vote – Woodward, Ova, Marks, Kaiser, Neys and Klose voted aye.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, informed the Board of the anticipated pool elevation forecasts for both Pipestem Dam and Jamestown Dam and the anticipated level of water releases from both dams. In 1997, 1,800 cfs was the maximum release and it's anticipated that releases of this magnitude would be required again this year. To gear up, the City of Jamestown has declared a flood emergency and is requesting assistance from the Omaha Corps of Engineers through its Advanced Measures program. In order to be considered for this assistance, the City must first ask for assistance from the County and from the State of North Dakota. If assistance is denied, the ND Department of Emergency Services would then ask the Governor to request assistance from the Corp of Engineers.

At 5:37 p.m. the Stutsman County Park Board was recessed and the regular County Commission meeting was called back to order with all members present. A motion was made by Neys and seconded by Ova to deny the City of Jamestown's request for funding, manpower and expertise for flood preparation assistance. Motion carried.

At 5:38 p.m. the County Commission meeting was recessed and the Stutsman County Park Board meeting was called back to order with all members except Schlecht present.

With the amount of snow in the water shed, there was potential for the Marina at the Reservoir to flood. Any water at the Reservoir above an elevation of 1,444 feet would begin to inundate the Marina. The Commission would consider an emergency declaration at their next meeting so the County could be eligible for federal funds to reimburse flood related costs.

Bergquist indicated that the road immediately south of the Pipestem Dam had a culvert with a flow capacity below the maximum potential releases. In the event of maximum releases at Pipestem, the road may have to be breached so that the water can flow freely at higher release rates.

Bergquist reviewed a press release from the Corp of Engineers. The Corp has initiated a new Dam Safety Program that rated their earthen Dams in the US on a scale from I to V – I was unsafe – V was the safest. All Dams in ND were rated at IV except the Pipestem Dam – the Pipestem was rated at III. The rating was based on data that the Corps obtained in 1997 when Pipestem Dam was at record pools. There is no immediate cause for concern however the Dam Safety rating of III will allow the Corps to fund a program that will address any potential safety issues at the Dam. A program such as this was utilized at Jamestown Dam several years ago which allowed the Bureau of Reclamation to address potential safety issues with much success.

Ova made a motion that was seconded by Woodward to approve the cabin transfer of Lot 5 West Side from Meidinger to Headland. Motion carried.

Dennis Lorenz, County Park Superintendent, gave his monthly report. The notice to remove fish houses from the Pipestem and the Reservoir had been published. Plans were to prepare to dike the Marina within the next 7 to 10 days. Pelican Point should not be severely affected by flooding. They would be moving the docks out of harms way.

A motion was made by Woodward and seconded by Neys to adjourn. At 5:59 p.m. the March Park Board meeting was adjourned.

At 6:00 p.m. the regular Commission meeting was called back to order with all Commissioners present.

Marks made a motion that was seconded by Ova to appoint Jane Trautman to the Buffalo City Tourism Foundation Board. Motion carried.

A motion was made by Marks and seconded by Neys to approve the raffle permit application of the Ypsilanti Community Club. Motion carried.

Kaiser made a motion that was seconded by Marks to pay the monthly bills. Roll call vote –Neys, Klose Ova, Marks and Kaiser voted aye.
