

Official Proceedings of the Stutsman County Commission

May 3, 2011

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered roll call.

Schwartz made a motion seconded by Neys to approve the minutes of the April 2011 meetings. Motion carried.

Robin Iszler, Central Valley Health District Administrator, presented the annual report and update of the Health District's activities and new programs.

Steve Thompson, Interstate Engineering, presented the engineering breakdown for work completed west of Cleveland in 2010 by Guthmiller Earthmoving. A motion to allow the environmental study of the 2010 ER project (Site 13) to begin was made by Schwartz, seconded by Marks. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye. A motion to advertise for the Cleveland South construction engineering only was made by Neys, seconded by Schwartz. Motion carried.

Mickey Nenow, County Highway Superintendent, reported that 3 of the 4 emergency grade raises were completed. He also presented an agreement form that private contractors could sign to allow them to haul gravel out of the county pits. A motion to approve the form and allow private contractors that were licensed and bonded to haul out of the county pits was made by Marks, seconded by Ova. Roll call vote – Ova, Marks, Schwartz, Neys and Klose voted aye. Nenow requested permission to advertise and hire 2 permanent part-time positions. Schwartz made a motion to allow advertisement and hiring of 2 permanent part-time positions, seconded by Marks. Motion carried.

Arlen Goter, Chairman of Lowery Township, requested a loan from the county for road repair. A motion to loan Lowery Township \$10,000 at 5% for 5 years with the stipulation that the township go to the maximum mill rate allowed of 36 mills was made by Marks, seconded by Ova. Roll call vote – Marks, Ova, Schwartz, Neys and Klose voted aye.

A motion to advertise for and fill the vacant Special Deputy Treasurer's position was made by Ova, seconded by Schwartz. Roll call vote – Marks, Ova, Schwartz, Neys and Klose voted aye. A motion was made by Marks seconded by Ova to allow Cheryl McPherson, Special Deputy in the County Recorder's Office to perform weddings. Motion carried.

4:48 p.m., Commissioner Marks left the meeting.

A motion to allow offices to implement and use a flex schedule for the summer months was made by Neys, seconded by Schwartz. Motion carried.

Nellie Degen presented information on the Parent Awareness/Prevention Center, which is a new program available for families of the Jamestown Public School District, and to extend an invitation to the County Commission to attend the ribbon cutting ceremony on May 23, 2011 at 6:00 p.m. at the Jamestown Middle School.

At 4:57 p.m., the Commission meeting was recessed for the Park Board meeting.
