

Official Proceedings of the Stutsman County Commission – July 21, 2020

At 3:00 p.m., Chairman Klose call the special meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke, David Schwartz, Steven Cichos, and Mark Klose answered the roll call.

The 2021 preliminary budget was discussed. The proposed 4.50 mill increase can be attributed to the need to replenish the emergency fund, health insurance increases and large decreases in anticipated revenue. There was over \$200,000 in lost revenue from corrections, as well as reductions in state aid and highway aid. Inmate capacity is down to allow for potential quarantine of COVID positive prisoners which also decreases transport revenue. Klose inquired about spending down any fund balances, Meland said there are no spend downs in the current budget besides those that were already planned.

The emergency fund mill levy was discussed. There are currently 4 mills budgeted, which is the maximum. Klose suggested keeping it at 4 mills until the final budget, and it could be lowered at that point once more details are known about road projects.

Health insurance costs were discussed. Currently discussions have indicated a 10-21% increase. Meland and Shannon Larson, HR Specialist, have been looking into a new insurance plan through NDIRF but have not heard back about rates. It might not be feasible to start a new plan for 2021 but could be a potential in 2022.

Klose suggested moving forward with the preliminary budget as it stands. The final budget can be lower than the preliminary but not higher.

The pumper truck for the Park department was discussed. It will need to be replaced in the next few years. There is money budgeted for new pickups, but they might not be needed since the current ones are in good shape. Meland will work it out so that there is money put away for the pumper truck.

The weed department budget was discussed. Meland raised the levy to 3 mills in order to qualify for state aid grants. It is high right now until taxable values are finalized, then it could be lowered.

Schwartz made a motion, seconded by Gumke, to approve the preliminary budget. Ova, Gumke, Schwartz, Cichos, and Klose voted aye. Motion carried.

At 3:25 p.m., Ova made a motion to adjourn the meeting, seconded by Gumke. Motion carried.

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission. Dennis Ova, Ramone Gumke, David Schwartz, Steven Cichos, and Mark Klose answered the roll call.

Tyler Perleberg, Tax Director, presented a list of omitted property assessments. These are properties that did not qualify or complete the paperwork for the Farm Residence Exemption. The properties were assessed to assign a value. Two individuals on the list did call and request an application but have not

submitted it yet. They will have to go through the abatement process if they do qualify for the exemption. Cichos made a motion, seconded by Gumke, to approve the values. Gumke, Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.

Corry Shevlin, JSDC, discussed a feasibility study for the Buffalo City Park. The county share will be \$5,000. This is a project being proposed by Brian Lunde. Gumke made a motion to approve, seconded by Ova. Schwartz, Cichos, Klose, Ova, and Gumke voted aye. Motion carried.

Shevlin discussed the annual request for South Central Dakota Regional Council dues. It is recommended to be paid by the JSDC Board of Directors, and the county share will be \$13,489. Schwartz made a motion, seconded by Cichos, to approve. Cichos, Klose, Ova, Gumke, and Schwartz voted aye. Motion carried.

Shevlin discussed the Give Get Grow campaign that is being run by the Jamestown Chamber of Commerce. The campaign will include an on-air radiothon and follow-up promotion to sell gift cards of gift certificates from participating merchants to local citizens and businesses. The goal is to inject much needed cash flow into our local Jamestown and Stutsman County businesses. Residents can buy giftcards to local businesses and it will be matched by the pool. The county share will be \$1,000. Cichos made a motion, seconded by Gumke, to approve. Klose, Ova, Gumke, Schwartz, and Cichos voted aye. Motion carried.

Schwartz discussed awarding the motor grader bid. The bid from Butler was \$205,228 and \$217,500 from RDO. The RDO bid has a better buyback guarantee. Schwartz and Nenow recommended accepting the bid from RDO because of the cost savings from the guaranteed buyback. Schwartz made a motion to award the bid to RDO and to keep the old V-plow, seconded by Ova. Ova, Gumke, Schwartz, Cichos, and Klose voted aye. Motion carried.

Klose discussed the intersection by the stockyards that is in bad condition. They had received a bid from Border States to repair it. Schwartz said the bid was approximately \$61,000. Schwartz recommended awarding the bid to Border States and contacting the businesses nearby to see if they will contribute. Schwartz made a motion to proceed with Border States to repair the roads, seconded by Gumke. Gumke, Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.

Jerry Bergquist, Emergency Manager/9-1-1 Coordinator, discussed the 2020 Emergency Management Performance Grant and a Supplemental Grant. This is a subsidized grant to offset wages. The main grant is \$40,603. They also received a supplemental grant this year for \$6,266 that can be used to offset COVID related expenses, including wages. Ova made a motion to accept the grants, seconded by Cichos. Motion carried.

The new siren at the Marina was discussed. It was ordered from Jamestown Communications but has not arrived yet. It will be installed at 40 feet in the air rather than the ten feet it was previously. 9-1-1- fees will cover half the cost. The park department has not been able to get any grants to cover the remaining costs.

Jessica Alonge, Chief Deputy Auditor/Recorder, presented the Primary Election Expense Report. There was a total of 4,879 ballots submitted which was up from the 2018 Primary. We were under budget by about \$15,000. The cost ended up being \$4.85 per vote compared to \$7.24 per vote in 2018.

Nicole Meland, Auditor/COO, discussed setting a date for the Final Budget Hearing. It is usually held on the first meeting in October. Ova made a motion, seconded by Schwartz to set the hearing for October 6th at 6:00 p.m. Motion carried.

Meland discussed a presidential disaster for Spring 2020 that was declared on July 9th. The state submitted damages for spring snowmelt which included frost heaves and boils. They were removed from the declaration by FEMA and the state is arguing that issue. We had 1046 sites identified in the spring assessment and 27 of those sites were inundated roads that would require a grade raise. The inundated road costs are over \$2.85 million and the spring snowmelt damages are over \$2.8 million. Funding from the 2019 disaster is starting to come in.

An application for a special event permit for the Corner Bar was presented. Schwartz made a motion to approve, seconded by Gumke. Motion carried.

Gumke made a motion, seconded by Schwartz, to approve the taxable meals and mid-month bills. Schwartz, Cichos, Klose, Ova, and Gumke voted aye. Motion carried.
